Some assignments include: Chief, Office of Training and Career Management, where I supervised the Defense Attaché School, the Defense Strategic Debriefing School, and the Special Training Division at the Defense Intelligence Agency, Washington, D.C.; Deputy Director for Training and Doctrine, Intelligence Directorate, U.S. Joint Forces Command, Norfolk, Virginia; Associate Dean and Professor, National Intelligence University, Defense, Intelligence Agency; Staff Group Leader, Combined Arms and Services Staff School, Command and General Staff College, Ft. Leavenworth, Kansas; Commander, Dallas Recruiting Battalion, Dallas Texas; Action Officer, The Joint Staff, Pentagon, Washington, D.C.; and Commander, Headquarters and Operations Company, Intelligence Command, National Security Agency, Ft.
