8	plan as may be inconsistent with such amendment.

10	WHEREAS, the City Council of the City of Alexandria finds and determines that:

12	1. In Master Plan Amendment No. 2018-0001, the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on June 5, 2018 of an amendment to the
15	Potomac Yard/Potomac Greens chapter of the Master Plan of the City of Alexandria to amend
16	Map #24A/Potomac Yard CDD#10 Predominant Height Limits to allow a maximum height of
17	117 feet on Block A2, which recommendation was approved by the City Council at public
18	hearing on June 23, 2018;

20	2. The said amendment has heretofore been approved by the planning commission
21	and city council after full opportunity for comment and public hearing.

23	3. All requirements of law precedent to the adoption of this ordinance have been
