Dear Mayor and City Council:

As Alexandria residents living right across the street from the Envoy Nursing Home at 900 Virginia Avenue, I am very concerned about Options 1 and 5.

The nursing home benefits the entire community, yet those of us whose houses surround this commercial facility bear the brunt of noise from:

- -emergency vehicles and lights flashing, at all hours
- -trucks making deliveries in the wee hours
- -very large Sysco trucks delivering food
- -extra large trash trucks
- -massive mowers and leaf blowers
- -humongous air conditioning roof unit that can be often heard for several blocks
- -slamming car doors and voices of staff during shift changes at 7am and 11pm.

All this is occurring while the nursing home is held by the current ordinance to residential noise limits.

Now up for discussion is Option 1, which would eliminate consideration of the surrounding residential neighborhood and allow the Envoy facility to use the commercial standard, and Option 5, which would raise the Commercial noise limit. We vehemently oppose these changes, which could only add to the noise emanating from across the street. It is only fair that properties completely surrounded by residential uses abide by residential standards.

In contrast, we very much support Option 7, which would ban deliveries between 11pm and 7am. It would be better still if they were banned between <u>7pm</u> and 7am. Mornings and evenings would be much more pleasant and early-to-bed residents such as small children wouldn't be awakened.

Dear Ms. Sitton.

I am writing to express my opposition to Option 1 of Docket Item 30 of the November 9 City Council work session on noise ordinance. As a resident living directly across the street from an assisted living facility (the Envoy of Alexandria) any increase to noise levels allowed would be to the detriment of my family and fellow property owners in the Braddock Heights neighborhood, especially those within a 1-2 block radius of the facility.

For example, two summers ago, the Envoy had an aging HVAC system on the roof of their property. All summer and the summer before it was replaced, the decibel levels (measured with a decibel reader) averaged at 65-70 of continuous din. It was so uncomfortable, that my family and I could only be outside for short periods of time before the noise drove us inside. Having two small children who love playing in the backyard, this was unacceptable. Neighbors and I complained at the quarterly SUP meetings, and to the City until the unit was replaced. Having lived with that level of noise by a commercial building in a residential area, I can tell you how severely it reduces your quality of life. We could hear that 65-70 decibel aging HVAC not only outside, but indoors as well. It was a constant drone from April to late October.

The stated goal of increasing the vibrancy in commercial areas is not universal throughout the city; an assisted living facility in a residential neighborhood is not doing anything to increase the vibrancy of the neighborhood. This standard should be modified only in areas with businesses such as restaurants, shops, music venues, etc., not for all commercial properties. There are many commercial uses that provide necessary services but do not contribute to the vibrancy of an area and therefore do not need license to increase their noise levels when located in residential areas.

We struggle enough with deliveries and trash pickup throughout the day that give our block an industrial feel that is already out of sync with the neighborhood. We kindly request that you do not apply this type of blanket policy change without considering these unintended consequences to neighbors of one-off commercial properties like that of the Envoy.

Re: Phase II Revision of Noise Ordinance

Dear Mr. Lambert:

North Ridge Citizens' Association appreciates the opportunity to comment on the Transportation and Environmental Services (T&ES) Department's proposed options for revising the noise ordinance. For ease of discussion, we have summarized the options as follows:

- 1. Replace the "predominant use" criterion with "property use of noise source."
- 2. Regulate DIY construction to the same hours as other construction.
- 3. Give responsibility for enforcing neighbor-to-neighbor noise inside buildings to the City, rather than leaving it to building management/condo boards.
- 4. Establish "plainly audible" as the standard for neighbor-to-neighbor noise from 11 pm to 7 am.
- 5. Increase the commercial property limit from 60 to 65 dB (day).
- 6. Allow less restrictive noise standards via a SUP.
- 7. Prohibit loading, unloading, and delivery between 11 pm and 7 am if within 500 ft of a residential area.
- 8. Expand "noise in public places" rules from the central business district to the entire City.
- 9. Remove the 75 dB limit on lawn and garden power equipment, or only control by hours/days of the week.
- 10. Increase civil penalties for violations.

First and foremost, the quality of life in Alexandria is not enhanced by noise. The City should take steps to <u>reduce</u> noise as much as reasonably possible. And, at a minimum, any proposal to weaken noise protections should be strictly scrutinized and considered only where absolutely necessary to enhance our citizens' quality of life. For these reasons, we <u>oppose</u> Options 1, 5, 6, and 9 and <u>support</u> Options 2, 4, 7, 8, and 10. We take no position on Option 3.

OPPOSE:

Option 1—We strenuously oppose Option 1 because it would remove consideration of the predominant use of the immediate surrounding neighborhood in setting noise limits. While we recognize that there may be a rare instance where the predominant use might be difficult to determine, in the vast majority of cases (such as single-family-zoned residential areas) there is no ambiguity and no reason to weaken the requirement.

When a commercial, institutional, or industrial facility is entirely surrounded by residential properties, the residential noise limits should absolutely prevail, as they currently do. An even stronger case can be made when a commercial or institutional property is inserted into a residential neighborhood through the SUP process.

Further, "predominant use" is a common-sense term employed in other contexts in the City zoning ordinance, as well as in other contexts such as tax law. All these reasons counsel against deleting it as a criterion.

Options 5 and 6—We strongly oppose Option 5, which would increase the noise limit for commercial properties, and Option 6, which would make it possible to increase noise limits beyond the levels provided in the ordinance through the SUP process. The attractiveness of Alexandria as a place to live is not improved by more noise. Also, allowing increased noise would exacerbate and increase the frequency of disputes between neighbors, which are already on the rise due to increased density and reduced setbacks allowed by the City.

Option 9—Option 9 would delete the 75 dB limit on lawn and garden power equipment—apparently because the noise made by this kind of equipment routinely exceeds 75 dB—and instead only limit its use to certain hours of the day. We oppose this weakening of the current requirements. Moreover, the City should begin a process that ultimately could lead to banning the commercial use of such equipment. Not only are the two-stroke gasoline engines that power them extremely loud, they pollute the air—hardly consistent with the idea of a "green" city.

SUPPORT:

Options 2, 4, 7, 8, and 10—NRCA supports these options, which would further restrict noise in the City. We agree that noise-producing do-it-yourself (DIY) projects should be limited to the same hours as projects done by contractors (Option 2), and that "plainly audible" is an appropriate standard for neighbor-to-neighbor noise in residential neighborhoods between 11 pm and 7 pm. The 11 pm "cutoff" time actually is quite late for residents such as those with young children who have early bedtimes and those who would like to enjoy a quiet evening outdoors.

In the middle of the night, the noise of truck engines and slamming doors, and their backup beep, beep, is enough to make anyone sit straight-up in bed. Thus, we strongly support Option 7, which would prohibit loading, unloading, and deliveries between the hours of 11 pm and 7 am. Further, we encourage the City to consider starting the no-delivery period earlier, e.g. 7 pm. This would still allow a 12-hour window for loading, unloading, and deliveries, while affording residents an opportunity to enjoy quiet evenings before bedtime.

We support Option 8 that would apply existing limits on noise from City-owned facilities in the central business district to the rest of the City.

We concur with Option 10 which would increase the civil monetary penalties for violations of the sound ordinance. We also ask that the City explicitly address the issue of enforcement as it considers these changes. Will the City commit the necessary staff and other enforcement resources? If residents cannot count on the City to enforce its rules, there is no purpose in enacting them.

In addition, we ask that the City consider converting (or requiring the conversion of) trash and recycling collection trucks to electric-only. Like leaf blowers, the noise from these trucks is horrendous. These trucks also are big polluters.

NRCA looks forward to engaging with you and your staff and with the City Council as these discussions move toward final action.

When you receive and discuss the Noise ordinance on Dec 14, please recommend reducing the hours when gas powered lawn equipment can be used. During the council's noise discussion on Nov 9th, one council member seemed to reject the notion of limiting gas-powered hours because she thought it was a good thing that landscaping companies can start early and make more money. In fact, we aren't saying they can't start early. We are saying that if they start before 9 a.m. they can only use electric powered lawn equipment (or manual tools). Starting early in the summer to protect the workers' health also lacks credibility when you read about the gas powered leaf blower's detrimental health impacts.

Our recommendation is: Instead of Monday-Friday 7am -9pm Change this to Monday-Friday 9 am - 7pm.

Instead of from Saturday and Sunday 9 am to 9pm Change this to Saturday & Sunday 12-6pm

Staff were instructed on Nov 9th to research limits other communities are imposing. The <u>District of Columbia</u> and <u>California</u> have banned gas powered leaf blowers, along with 100 others who have regulated or banned same.

Thank you for always listening and considering this solution.

-SUPs with a much higher than average volume, frequency, severity, or some other reasonable threshold of documented noise complaints should be immediately subject to review and revised/enhanced regulations to protect those harmed by incessant noise violations. Those SUPs cannot be left "as is" because they have failed to protect people who live under them. I live under such an SUP (The Royalton Condominium/ Whole Foods Market), and it is a complete failure because the assumptions underlying the sources of noise were overly simplistic. One judgmentally selected residential unit on Duke Street was the proxy for the determination about noise levels for the entire building; meanwhile, commercial equipment and store operations were completely ignored. The City did not put in adequate conditions for the developer to meet (quality of construction including windows, siting of commercial equipment including 24/7/365 fans right next to residences without any enclosures or noise attenuation features, inadequate bays for volume of products, etc.) as well as protective conditions for store operations (no enforcement of noise and idling in fire lanes on Georges Lane and the loading dock, or the use of "jake" brakes and a host of other noise, like after-hours trash compacting, repetitive honking, employee noise). -The biggest problems with the noise code are lack of enforcement, lack of effective deterrents (no fines or inadequate fines that just become a small cost of "doing business" for a profitable commercial store like Whole Foods), and difficult to understand or follow altogether. No one can understand, for example, how noise in our (non-enclosed) loading dock is supposed to be handled because it crosses the property line after-hours and there are a variety of sources contributing to the noise that are not easily identified in the noise ordinance (including misuse of parking spaces for storage and loading and unloading of goods; in other words, factors that have to do with the faulty SUP). -The Alexandria Police has not been responsive in after-hours enforcement, which is exactly the time when the more severe nuisance violations take place (e.g. when people are trying to sleep). It is unacceptable to have a noise ordinance that no resident can count on in time of greatest need, or to give the impression that the Police can be counted on when calling the non-emergency number. -HOAs and Building Managers are not interested, equipped, or have the expertise or the legal authority to enforce the noise ordinance. It is naive to assume that they would be better at it than the City, since the governing documents do not give them much authority. In a mixed-use building, they would be very reticent to "fine" or discipline a commercial tenant, and this has been borne out by 15 years of experience since my building was erected. -When a commercial entity has been shown for years not to comply with a single maximum 60 decibel standard, how can they be trusted to comply with two sets of standards (one for day time and another for night-time)? This makes no sense and doubles the enforcement burden, which is inadequate to begin with. The source of the noise at my residence is equipment that runs continuously, not a restaurant or pub operation that simply "stop" at a certain time and "restart" at another. Therefore, the 2 noise standards would not work at all for my mixed-use building. -The objective of a noise ordinance is to protect the public and their health, not to protect commercial entities. The idea of raising decibel standards around residential units is indicative of the City being co-opted by commercial interests. More people than ever work from home now, and will continue to do so. They pay their property taxes and expect to be protected from nuisances that make it hard for them to work, concentrate, enjoy their leisure time after work, and most of all, be able to sleep at night.

The City of Alexandria has allowed the building of several new mixed use buildings, where residents live above commercial establishments, however, the options and discussions related to the proposed revisions mention nothing about mixed use buildings. Along with a new mixed use ordinance, local building codes should be updated to ensure that any new mixed use construction would keep noise levels with healthy and legal limits. Unless one has lived with non-stop illegal noise, 24/7 hours day after day, for months on end, one will not be able to understand how critical it is to have environmental noise within legal and healthy limits. Noise limit standards based on decibels cannot be enforced at all, unless residents and police officers have immediate access to the type of sound measurement devices specified in the ordinance for measuring whether a violation of the ordinance has occurred. The Police Department must be provided with qualifying decibel measurement equipment for every shift, and citizens must have access to such equipment also, or be allowed to take measurements with the NIOSH cell phone app available free of charge. This app can be calibrated to roughly match the measurements of Class 1 and Class 2 meters using the microphone built into cell phones. The proposed language in Section 11-5-4 (2) addressing Sound Reproduction Devices only covers sound coming from a building, a structure, or a vehicle. It therefore excludes situations I've brought to the attention of Lisa Goldberg and Mayor Wilson in which the music playing through huge speakers on the pool deck at the neighboring apartment complex was so loud that the fixtures in my apartment were shaking, and I could not use my phone or hear my television turned up to maximum volume, with my windows shut, I am certain that the sound level coming into my apartment for approximately six hours on those occasions was at least twice the allowed maximum specified in the proposed Ordinance. I could not remain in my apartment - I was forced to leave to prevent damage to my hearing. I have also had loud music aimed directly into my apartment from the grassy strip of lawn between my apartment building and the property of the complex next door, during picnics that went on for hours - and this was after the management of that complex had been contacted twice by Ms. Goldberg regarding the noise from loud music, at my request (after the police refused to act). There are also increasing numbers of people at the same apartment complex (South Port Apartments) blasting music from their vehicle stereos with all of the doors and windows open, for long periods of time as they are parked in the parking lots. When those headache-inducing noise levels from recorded music are again encountered for hours at a time, I will have no recourse for help from the Ordinance, if the proposed language in 11-5-4 (2) is not broadened to include sound coming from all property areas including pool decks, grassy areas, and parking lots. That will be a disaster for me, and for all of the other residents in my apartment complex. I urge you, and I beg you, to please broaden the language of this provision to include noise problems that are very likely to occur on a regular basis.
