- Request Description: After learning about the discussion surrounding DC Poultry's request to operate in Alexandria, I dug deeper into the humanity of halal meat preparation. This is a great general article about why halal is controversial (<https://www.theweek.co.uk/58447/halal-meat-what-does-it-involve-and-is-it-cruel-to-animals>) and this article is a succinct pro/con view of this approach to meat preparation (<https://www.bbc.com/news/magazine-14895534>).

My takeaway is that the most humane way to slaughter animals is to perform a "pre-slaughter stun," to minimize or eliminate their ability to feel the pain of the actual slaughter. I'd love to know if DC Poultry does this and I cannot find any publicly available information. My request is to make this question a part of the conversation when this topic is next raised in a Council meeting.

Secondly, are there any data that show the economic benefits or drawbacks of having a slaughterhouse in an urban/suburban area like the location being proposed?

I am writing to advocate for this discussion to focus on the humanity of the process and the economics of the choice to locate here. By doing this, we can steer clear of racism or red herring reasons for making a decision in the best interest of our community.

Absent any other information, my voice goes in support of allowing DC Poultry to operate here. Until I choose to eat vegetarian, I need to own the fact that my menu choices require slaughter. And I value the diversity of businesses, perspectives and options my family has in my community, which I want to reflect our global community as much as possible.

We use the Frolick Dogs Gym and Daycare at 3225 Colvin Street in Alexandria and we have concerns about the Special Use Permit being sought by DC Poultry for a poultry slaughterhouse (abattoir) on Colvin Street near Frolick Dogs. Our concerns are sanitary and parking. We are familiar with slaughterhouses (abattoirs) and used them frequently when we lived in Brussels, Belgium. In Brussels slaughterhouses (abattoirs) were grouped together and were subject to regular and rigorous sanitary inspections by Brussels authorities due to concerns about fecal and other waste products related to the slaughter of animals. We are concerned that with so few parking spaces (4) the delivery of live chickens would leave fecal matter on parking and other surfaces that could endanger pets using Frolick Dogs, Dogtopia and Pinnacle Pet Spa. Has Alexandria checked with other municipalities to see how they regulate and locate slaughterhouses (abattoirs)? Are there other slaughterhouses (abattoirs) in the DC area, where are they located, and how are they regulated and inspected? Despite the Saba Live Poultry business staff's assertion that all the trash and garbage will be stored indoors at all times, this business will truck live birds to the facility. There will be birds crowded in cages in what is most likely to be a putrid smelling interior, as is typical of all the live poultry markets I personally have visited in New York City and that have been visited and recorded by others. These places are filled with birds who typically come from suppliers who round them up from various locations and often these birds are sick and dying with undiagnosed (and of course untreated) illnesses. But even if they are healthy, they must sit in their cages and listen all day long to the cries and screams of the other birds who are having their throats cut.

Please understand that throat-cutting of a living creature including a chicken is NOT humane and that the language of "humane" to describe this process cheapens the word "humane" and falsifies the experience the birds are enduring. This includes the painful, terrifying experience of a knife blade close to the face and cutting into the sensitive skin and trachea and other parts of the innervated face, throat and neck area. It includes the cruelty of making birds awaiting their own deaths listen to the killing being conducted over and over. So forget "humane."

Live poultry markets are not clean places regardless of how much rhetoric is expended to say that they are. The smell of blood and suffering is strong, and most frequently, the birds do not have fresh clean food or water in their cages, adding to the inhumanness of these places which always includes rough handling.

And what happens to the birds who are not slaughtered and sold to customers? How are they disposed of along with the daily mess of entrails, blood and other body parts of birds who are slaughtered? The location, which is in the city limits of Alexandria, proposes that a slaughter house be approved to operate where, we understand, animals will be subjected to lethal cuts and allowed to bleed out to their death. This raises grave concerns on many levels including the disposal of animal remains, blood, and other pollutants, etc. Also released into the community ecosystem will be feathers from chickens, bacteria such as salmonella, fungus and mold spores, and parasites. We travel to Colvin Street more than five days a week to have our dog boarded and visit the recycling center at least once a week. In addition to the effect such a facility may have on my family and I, our dog will be subjected to potential illness from this propose slaughter house which, like other residents to visit Colvin Street, will then be returned to families' residences.

There are extreme health concerns for the dogs of Frolick (as well as the numerous other businesses located within a 2 block radius including Frolick Dogs, Dogtopia, Wild Bird Center, Pinnacle Pet Spa, & Wholistic Hound Academy) associated with a slaughterhouse being so close by:

**Bacteria:** Dogs eating chicken feces can ingest bacteria such as salmonella which cause serious diarrhea.

WEBA very much appreciates the need to promote development in the city generally and in an area that once was a run-down industrial pocket. Yet, this area has evolved and is now the site of several progressive, pet-oriented facilities.


WEBA is particularly concerned with the impact of the smells from the establishment on the dogs that are expected to be within range of it. Our city has gone to the dogs, and there is no turning back!

Many, if not all, of the existing businesses that would be nearby to this new business are all positive reinforcement establishments, and to locate something so shockingly antithetical to the sensibilities of their clients would significantly discourage those clients from frequenting the area.

Indeed, it is unusual for a slaughterhouse to be located anywhere within Alexandria city limits given how built up the city is generally, but it is especially unwise to locate one where it would cause substantial harm to existing businesses.

Importantly, we are very sensitive to the issue of the religious nature of this new business. Further, we respect those who would benefit from the creation of this new establishment. Our concern is entirely on the practical impact of the business on the neighborhood. It is in that light that we hope you will reject the SUP being sought in this matter.

Ms. Sitton,

I was dismayed to hear about Alexandria City government's approval to allow a chicken slaughterhouse to establish business on Colvin Road. As a long-time Alexandria resident I was also dismayed to hear about the lack of notice given to the neighboring businesses and residents of the City before granting approval.

I understand the final vote is imminent and wish to register my complaint with the City against permitting this business to open and operate within the City limits.

Having lived in Harrisonburg, VA, where poultry breeding and slaughtering is a main line of business, I can attest that the smell from these facilities is horrendous and spreads rapidly and for significant distances if there's a wind. The smell will permeate the nearby homes and stores and may have a long term impact on current residents' willingness to remain in the vicinity as well as deter new businesses and residents who would take their place. Please consider the value of homes in the immediate area as well as the tax funds directed to the City as in jeopardy in the long run should this type of business be allowed so close to these areas.

While I completely understand the value of a Halal butcher to be located in our area with so many interested families and businesses, that isn't what this business is. A butcher's doesn't house animals nor kill them on premises irrespective of how the animals are cared for during the process. This type of business is inappropriate in any densely populated city, including Alexandria. The addition of large trucks carrying live poultry on Duke Street (!?!) is alarming to say the least. Does the City reasonably believe adding large trucks, no matter how frequent, to the traffic in that location has anything but a completely negative impact?

The idea that any proposal of this nature received traction with our City government is appalling, much less the approval it's received. It seems beyond upsetting that the government pushed the approval through without announcing a forum of any kind inviting the residents in the immediate vicinity to comment and discuss. I understand you can't please everyone. But discussion on matters of this nature, that will have a significant impact on all of your constituents, is imperative.

I sincerely hope you receive sufficient comments, negative and positive, to stop the approval process immediately in order to open a dialogue in which all residents can reasonably participate without urgency. As it is, the news of this approval was not released in a timely fashion, very clearly limiting the possibility of any discourse.
