My roots in Alexandria run deep—my mother was raised here and attended school at Lyles-Crouch, Parker-Gray, Minnie Howard, and the former T.C. Williams. I spent my early childhood living with my family in Del Ray, where I gained a personal connection to the rich cultural and historical legacy of this city. I was proud to return to Alexandria last year, this time as a homeowner in the Seminary West neighborhood, and I am deeply invested in giving back to the community that helped shape me. Currently, with the Federal City Alumnae Chapter of Delta Sigma Theta Sorority, Inc., I serve as chairperson of the Dr. Betty Shabazz Delta Academy, a youth enrichment program providing educational and cultural programming for African American middle school girls in the Washington Metropolitan area. I also work as the Communications Analyst for the Office of Civil Rights at the U.S. National Science Foundation, headquartered in Alexandria. In this role, I support equity-driven outreach and messaging that advances inclusive practices across the federal science community. Previously, I volunteered at the Smithsonian National Museum of African American History and Culture from 2016 through 2020, supporting educational outreach and visitor engagement until the COVID-19 pandemic. I recently completed the City of Alexandria's City Academy, which deepened my understanding of local government and enhanced my commitment to civic involvement. I also serve as a member of the Alexandria chapter of the NAACP, where I continue to advocate for justice and equity in our city. Academically, I hold a master's degree in Strategic Communications and a bachelor's degree in Communications, both of which have equipped me with the tools to craft impactful messaging, foster dialogue, and elevate community voices.
