As a resident of Alexandria for the past 8 years, the parent of a current and future ACPS student, a former public school teacher, and an education policy professional, I'm interested in continuing my role on the Alexandria Children, Youth, and Families Collaborative Commission to support our community in creating equity of opportunity for all Alexandria children and families. The city of Alexandria benefits from vibrant and diverse communities and schools and a rich historical culture, but faces a critical achievement and opportunity gap, particularly for students of color and low-income students. I believe education is a critical lever for change, but combining education with wraparound health and human services is essential for improving equity of opportunity. This is particularly important in the wake of the pandemic, which has exacerbated gaps in equity of opportunity for our most vulnerable and historically marginalized students. I have spent the last decade leading and managing complex technical assistance projects for districts. state education agencies, and national education organizations. This work includes planning and facilitating stakeholder engagements with diverse groups of parents, teachers, principals, community members, and district and state leaders on a wide range of complex education issues ranging from policy design and implementation, instruction and professional development, educator workforce policy, and improving equity of opportunity for under-served student groups. I am well-versed in supporting small- and large-scale project implementation including managing logistics, operations, and short and long term planning. I spent the early part of my career as a public school teacher and dean of students in Title I schools, and have firsthand experience working in underserved communities. I supported ACPS as a thought partner during the pandemic, serving on the Reopening Planning Committee and Learning Advisory Team to engage in planning and continuous improvement for virtual and hybrid learning. I also served as the co-chair of the ACPS Douglas MacArthur/Patrick Henry Collaborative Committee, charged with supporting a successful dual occupancy of the Patrick Henry Campus during the upcoming Douglas MacArthur modernization project. For two years, I served as the Board Treasurer of the Clover-College Park Civic Association. I recognize the increasing challenges that ACPS and the city of Alexandria face as a result of the pandemic, leading to concerns with incomplete learning, increased student mental health needs, and challenges with chronic absenteeism and engagement.
