At the Natural Resources Defense Council, I lobby for enhanced federal funding for wastewater and stormwater utilities, develop policies to ensure that water and sewer service is affordable for all people regardless of income, and advocate for the adoption of robust, workable legal solutions to bring wastewater and stormwater systems into compliance with the Clean Water Act. I testified before Congress earlier this year about legislative proposals to promote sustainable wastewater and stormwater infrastructure, and I regularly work with national media outlets to bring attention to water infrastructure issues. ## Statement of Interest/Why You Should Be Appointed

---

My family and I have lived on Manning Street in Alexandria for five years. We love it. The people, the neighborhood - it is all invaluable and we have felt blessed to call this corner of Alexandria home. Like many others, our street was devastated by the flooding of the past three years. There are roughly 38 homes on our small street and in each of the four events (7/8/19, 7/23/20, 9/10/20, 8/15/21) you could count on one hand the number of them that did not experience flooding issues. Some are affected by a main storm drain that runs through an adjacent alleyway, almost all experience some level of sewage backups, and a few homes get hit with both. Neighbors have lost cars, business equipment, and personal mementos that can never be replaced. Others have seen back doors blown in and internal walls collapse due to the volume and strength of the water, some have come perilously close to losing pets. One family lost a car, their home insurance (due to repeat claims), and they contracted COVID, all in 2020. The mother was isolating at home with a newborn, they feel certain that the exposure came from either having to wade through knee-deep sewage or from the mitigation crews that were dispatched in the aftermath. The three-month-old was the first to show symptoms. We have lost so many neighbors to this problem – one that has a detailed connection with our sewers. While I recognize that the foundation of our issue lies largely in the fact that our stormwater infrastructure is woefully undersized, it is impossible to talk about this without also acknowledging the impact that has on our sanitary sewers and how together, the two are responsible for an astonishing amount of devastation in our lives as well as that of our friends and neighbors. As such, I have dedicated a substantial amount of time since the July 2020 storm learning as much as I can about both our stormwater and sanitary sewer infrastructure. In that time I have also grown to understand more about what AlexRenew does and the important role they play not just in treating our wastewater, but also in protecting our waterways from combined overflow. I see the position on the AlexRenew Board as complimentary to the Ad Hoc Stormwater Group and feel there is much to be gained by having overlap between the two entities. Similar to how water quality and quantity projects are both housed under the stormwater utility fee, there is also overlap in the information surrounding both systems and the needs in the years to come and I can think of no better area to keep expanding my knowledge, and extending my service, than to participate on this board. I believe my stormwater perspective would be a value-add to this board and have no doubt that the knowledge I would gain would provide similar value to the stormwater group.
