4	adopting and incorporating therein the amendment heretofore approved by city council to
5	the Seminary Hill/Strawberry Hill Small Area Plan chapter of such master plan as Master
6	Plan Amendment No. 2021-00007 and no other amendments, and to repeal all provisions of
7	the said master plan as may be inconsistent with such amendment.

9	WHEREAS, the City Council of the City of Alexandria finds and determines that:

11	1. In Master Plan Amendment No. 2021-00007, the Planning Commission, having
12	found that the public necessity, convenience, general welfare and good zoning practice so
13	require, recommended approval to the City Council on December 7, 2021 of an amendment to
14	the Seminary Hill/Strawberry Hill Small Area Plan Chapter of the Master Plan of the City of
15	Alexandria to amend the land use designation from RL/residential low to RM/residential medium
16	for 4575, 4555, and 4557 Seminary Road, which recommendation was approved by the City
17	Council at public hearing on December 18, 2021;

19	2. The said amendment has heretofore been approved by the planning commission
20	and city council after full opportunity for comment and public hearing.

24	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

26 27	Section 1. That the Seminary Hill/Strawberry Hill Small Area Plan Chapter of the
28	Master Plan of the City of Alexandria, be, and the same hereby is, amended by amending Map
29	13 Seminary Hill/Strawberry Hill Land Use to change the land use designation from
30	RL/residential low to RM/residential medium for 4575, 4555, and 4557 Seminary Road, attached
31	hereto and incorporated fully herein by reference, as a new chapter of the Master Plan of the City
32	of Alexandria, Virginia.

34	Section 2. That the director of planning and zoning be, and hereby is, directed to
35	record the foregoing master plan amendment as part of the Master Plan of the City of
36	Alexandria, Virginia.

38	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
39	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

41	Section 4. That the Master Plan of the City of Alexandria, as amended by this
42	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,
