1 ORDINANCE NO. _____ 2 3 AN ORDINANCE approving and authorizing the sale of property owned by the City of 4 Alexandria, located at 3700 Mount Vernon Avenue in the City of Alexandria, Virginia 5 22305, to the Alexandria Housing Development Corporation. 6 7 WHEREAS, the City of Alexandria owns the real property at 3700 Mount Vernon 8 Avenue, in Alexandria, Virginia 22305 (the "Property"); and 9 10 WHEREAS, on September 8, 2020, and on May 11, 2021, the City Council approved predevelopment loans to the Alexandria Housing Development Corporation (AHDC) 11 12 in order to support the potential development of an affordable housing project at 221 West Glebe 13 Road, 3606, 3610, 3612, and 3700 Mount Vernon Avenue, that included the potential sale of the 14 Property; and 15 16 WHEREAS, the City Manager has determined that the Property is no longer 17 required for municipal or public purposes and recommends that the Property be disposed of by 18 sale to a non-profit City related entity, specifically Alexandria Housing Development 19 Corporation as set out in his memorandum to City Council dated February 1, 2022, for 20 Introduction and First Reading, Consideration, Passage on First Reading and Request for Public 21 Hearing at its legislative meeting on February 8, 2022, and for a Second Reading and Final 22 Passage at its public hearing on February 12, 2022; and 23 24 WHEREAS, the City may forgo the competitive sale process for the disposition of 25 City property and negotiate the sale of City property with public entities or non-profit City-26 related entities, including the Alexandria Housing Development Corporation, at the direction of 27 the City Council; and 28 29 WHEREAS, the City Manager has recommended the sale of this Property to the 30 Alexandria Housing Development Corporation for the sum of \$10.00, and contingent upon 31 approval of land use approvals by the Planning Commission and City Council; and 32 33 **WHEREAS**, the City Council is of the opinion that the sale of this property is in the 34 public interest and will otherwise advance the City's land use goals; now, therefore, 35 36 THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS: 37 38 Section 1. The Property is no longer required for a municipal or public purpose and 39 the City Manager recommends that the Property be sold to the Alexandria Housing Development 40 Corporation. City Council directs that the City forgo a competitive sale process for the 41 disposition of the Property and negotiate the sale with the aforementioned entity; and 42 43 Section 2. That the sale of real property described below to the Alexandria Housing 44 Development Corporation for the sum of \$10.00, and contingent upon approval of land use 45 approvals by the Planning Commission and City Council, be, and the same hereby is, approved
