4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
5	adopting and incorporating therein the amendment heretofore approved by city council to
6	the Seminary Hill/Strawberry Hill Small Area Plan chapter of such master plan as Master
7	Plan Amendment No. 2021-00009 and no other amendments, and to repeal all provisions of
8	the said master plan as may be inconsistent with such amendment.
9	
10	WHEREAS, the City Council of the City of Alexandria finds and determines that:
11	
12	1. In Master Plan Amendment No. 2021-00009, the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on January 4, 2022 of an amendment to the
15	Seminary Hill/Strawberry Hill Small Area Plan Chapter of the Master Plan of the City of
16	Alexandria to amend Map 13: Seminary Hill/Strawberry Hill Land Use, as amended, to reflect an
17	exchange of Institutional area with Parks & Open Space area and amend Map 18: Seminary
18	Hill/Strawberry Hill Height Limits, as amended, to reflect a change in height from 35 feet to 77
19	feet, which recommendation was approved by the City Council at public hearing on January 22,
20	2022;
21	
22	2. The said amendment has heretofore been approved by the planning commission
23	and city council after full opportunity for comment and public hearing.
24	
25	3. All requirements of law precedent to the adoption of this ordinance have been
26	complied with; now, therefore,
27	
28	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
29	
30	Section 1. That the Seminary Hill/Strawberry Hill Small Area Plan Chapter of the
31	Master Plan of the City of Alexandria, be, and the same hereby is, amended by amending Map
32	13: Seminary Hill/Strawberry Hill Land Use, as amended, to reflect an exchange of Institutional
33	area with Parks & Open Space area and amend Map 18: Seminary Hill/Strawberry Hill Height
34	Limits, as amended, to reflect a change in height from 35 feet to 77 feet, attached hereto and
35	incorporated fully herein by reference, as a new chapter of the Master Plan of the City of
36	Alexandria, Virginia.
37	
38	Section 2. That the director of planning and zoning be, and hereby is, directed to
39	record the foregoing master plan amendment as part of the Master Plan of the City of
40	Alexandria, Virginia.
41	
42	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
43	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

Section 4. That the Master Plan of the City of Alexandria, as amended by this ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria, Virginia. Section 5. That the city clerk shall transmit a duly certified copy of this ordinance to the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the Circuit Court shall file same among the court records. Section 6. That this ordinance shall become effective upon the date and at the time of its final passage.
