24	chapter that are not contested and tendered to the director of finance within 30 days from the date
25	the citation was issued shall be \$40 unless otherwise provided by this section, the city code, state
26	law, or other provisions of law.

28	The penalties for the below violations that are not contested and tendered to the director of
29	finance within 30 days from the date the citation was issued shall be as follows:
30	(1) For violations of section 10-4-46, "Parking heavy vehicles in commercial business areas":
31	(a) \$100 for the first violation,
32	(b) \$250 for the second violation, and
33	(c) \$350 for the third and any subsequent violation, upon the fourth and any
34	subsequent violation the vehicle shall be immobilized, in accordance with the process
35	set forth in section 3-2-355, or be removed for safekeeping, in accordance with the
36	process set forth in Article C, Chapter 8, Title 5; Notwithstanding any other section
37	of the City Code, referenced or otherwise, penalties of this section may escalate
38	and ultimately may include immobilization or removal whether or not the
39	previous penalty fines have been paid.
