Dear Members of the Alexandria City Council:

I had the pleasure of hosting and emceeing a very special event in November where our County and three municipalities announced the completion of a state-of-the-art, 100% fiber network from Lumos Networks, a premier provider of fiber-to-the-premises internet. Lumos now offers direct fiber connections to the internet at speeds the region has never had before, eliminating the digital divide and placing Alleghany Highlands at the forefront of the gig economy.


