1. Calling the Roll.

Mayor Wilson called the meeting to order and the City Clerk called the roll. All members of City Council were present, with Councilman Chapman arriving following roll call.

2. Presentation of the Proposed Annual Operating Budget for FY 2023 (including Schools), the Proposed Capital Improvement Program (CIP) for FY 2023 to FY 2032 (including Schools CIP), and the Proposed Tax Rate Recommendations.

Mr. Parajon, City Manager, presented the Proposed Annual Operating Budget for FY 2023 (including Schools), the Proposed Capital Improvement Program (CIP) for FY 2023 to FY2032 (including Schools CIP), and the proposed Tax Rate Recommendations.

City Manager Parajon presented City Council with a proposed Fiscal Year 2023 General Fund Operating Budget of \$829.9 million, representing an increase of 7.7%, including \$248.7 million and funds 100% of the Alexandria City Public Schools request. City Manager Parajon also presented the City's 10-year Capital Improvement Program for FY 2023-2032 which was 2.73 billion including support for the schools facilities, including a new high school, a retrofitted office building for swing space, and expansion and renovation of two elementary schools.

City Manager Parajon did not require an tax increase to fund ongoing budget operations.
