City Council Members,

I write as an Alexandria City resident and parent with a child currently attending Potomac Crescent Waldorf School (PCWS). The school's plan to occupy a new building (424 North Washington St) next school year has been approved by the Planning Commission and will be voted on by City Council tomorrow. I understand some nearby residents are voicing concerns about safety and traffic disruption related to student arrivals and departures at the new location.

First, as you may be aware, PCWS moved to a temporary location at Old Town Community Church just a few blocks away for this academic year. The current school drop off and pick up situation has worked very efficiently. The school staff is always present to help children exit and enter their cars and there have been no safety incidents all year. PCWS has used a staggered arrival time for different classes to help minimize the impact on traffic and several families carpool with others (ours included). Others live close enough to walk or bike.

Second, as a school that embraces the Waldorf philosophy, the PCWS staff, students, and families value sense of place and community. The children have really flourished being in Old Town this year, from exploring the neighborhood, walking to Jones Point Park every Friday, and even taking the DASH bus to go sledding at the Masonic Memorial. We believe we are stewards of our environment and look forward to more years in the Old Town community.

Hi,

I am writing in support of the permit application of Potomac Crescent Waldorf School for drop of and pickup of students on Washington Street. I am a parent and can attest to the safety and efficiency of drop off and pickup at the current location on Prince St. and the commitment of the school to safety. Kids hop in and out, always on the curb side, and the cars are on their way within seconds . I very rarely arrive to fine the loading zone full (usually because someone else has illegally parked), I simply drive around the block, or park further down the street and walk to pickup the kids. I drive by the new location of the school on a daily basis on the way to the current location. I can attest the parking spaces along Washington St. are usually completely empty on that block, and spaces are plentiful on adjoining Oronoco and Princess St. I can also attest that many parents car pool, including myself. There are also parents that drop off by bike. With the 10 minute staggered drop off and pickup times between different grades, the "traffic" is minimal and can absolutely be done in complete safety. We live in the Beverly Hills neighborhood in Alexandria, and many of the families are Alexandria City residents.

I can also attest that I have spoken to the "neighbors" across the back alley on 429 N. Columbus St. They expressed that they hate the potential noise made by children playing outside, and want to be able to continue to trespass on the empty parking lot in the back of the empty building. They expressed their preference for the building to remain empty, or be underutilized as an office building, without regard to the property rights of the building owner and the community benefit of the building serving as a school. They expressed that they along with other neighbors scuttled a previous attempt to utilize the building as a school at the city council and intend to do so again. Therefore, it's logical to infer the objections with regard to safety of the pickup/drop-off plan are not made in earnest.

Dear Members of the Council,

I am writing to you in my role as a teacher of three years at the Potomac Crescent Waldorf School. I have heard and read the concerns of the neighbors of 424 N Washington and wish that you hear from someone deeply involved in the actual day to day operations of the school. It is also important that you know that Waldorf Schools develop close knit communities as the parents, the faculty, and the administration each have their role in running the school and in the education of the children.

First and foremost, the safety and well-being of each and every child is our primary concern. Waldorf Schools are renowned for our unique approach which always considers the whole child. We are currently running our pick-up and drop-off on Prince Street as our current location is on 212 S Washington Street. During these times, teachers and administration are present to assist students in and out of their cars. We are very firm on our rule that a student is forbidden to exit on the street side. The current plan is to continue this practice as it is essential to us that we not only move efficiently, but that the children are not harmed in any way.

Our location next year will actually be safer for our students as our current drop-off/pick-up site is rather distant from the school building. This situation means that we have students waiting on the sidewalk as we gather or disperse students to and from their cars. We have established clear boundary lines for the older children to adhere to and for the younger children we employ extra "hands" to maintain order and adherence to the rules.

At 424 N Washington, our building will be a short walk to and from their cars; less time spent on the sidewalk. As we currently do, staff will assist students in and out of their cars and guide them to the front door of the school. And, as we currently insist, all of this will be executed on the sidewalk side and never from the street side of the car.

We have a beautiful and loving community. We are very excited about our new location in Old Town and look forward to educating the children of your community.

As a parent of a former Potomac Crescent Waldorf School (PCWS) student and a twenty plus year resident of Alexandria, I strongly support the move of PCWS to 424 N Washington Street.

We discovered PCWS in 2013 when it was located at one of its former locations in a church in Del Ray. The PCWS community is unlike many other forms of education. The curriculum emphasizes outdoor education and the opportunity for the students to understand the environment and their effect on it. The children are taught to be respectful of each other and the areas in which they work and play. I never witnessed any child being disrespectful or discourteous to any other child or the play areas in which they frequented. And from what I understand, if there was ever a minor incident during which a child mistakenly created discord, they were dealt with swiftly but with compassion.

After preschool and first grade in another private school, we returned to PCWS in second grade at the location shared with the Fairlington Presbyterian Church. The school established an organic garden where students learned the importance of cherishing what the earth brings forth if given some care. Plus, the children were encouraged to play quietly with each other on the playground equipment in the yard adjacent to the church. Parents were encouraged to be involved in their child's education either through participation in seasonal fairs, regular meetings explaining the structure and child-oriented goals of Waldorf education, or through the women's crafting club that met every Friday morning in the school parlor. Our family always felt welcomed at the school, and we watched as our son blossomed under the excellent tutelage of his respected teacher. Our son is a conscientious person and diligent student due to his experience at PCWS.

I strongly believe the addition of Potomac Crescent Waldorf School to the neighborhood of north Old Town would be an advantage and a benefit to the residents in the area. Hello,

My name is Alan Carniol. I am a City of Alexandria resident, living on E Linden St. Today, I am writing on behalf of my daughter, Lucelia, and myself a Potomac Crescent Waldorf parent about the pickup and drop of plan the school shared for its new home.

I heard some neighbors are worried about the safety of our children in regards to this plan. So I wanted to speak to this concern directly. PCWS's current location is comparable, and as a parent, their safety practices have been reassuring - here's what I mean:

Currently, the school is located at Old Town Community Church, which is right on Washington St, between Duke and Prince Street. This is quite a busy location, and I was worried about the safety of dropping off and picking up my three-year-old daughter just a few yards from such a highly trafficked part of Washington St.

I pick up my daughter there three days per week. There are a few actions the school takes that have given me confidence in the safety of my daughter at pickup. What jumps out most is that there are always a lot of staff there - 3-4 teachers, for a group of ten or fewer young students. They are all focused on helping our children get home safely and conduct themselves appropriately at that time. And they stay until the last student is picked up.

There are occasions where I have seen a kid start acting out in a way that could be dangerous, and I then have seen a staff member take this young person aside and dedicate individual attention to them. Meanwhile, there is enough remaining staff to attend to the other children. As a result, I have never been worried about my daughter and the vehicle traffic nearby.

I don't know the plan if the permit is not approved, but I would imagine it would mean the loss of our playground space at this location in order to retain the parking lot.

If you vote against the permit, that puts our preschool children likely crossing Washington Street during the day to reach the nearest greenspaces on the waterfront.

I feel much better about having the drop-off and pick-up plan in place, and I hope for the welfare and benefit of my daughter, Lucelia, that you support this permit.

My name is Kelly Johnson and my husband Steve and I live at 600 Princess Street in Alexandria. We have recently learned about Potomac Crescent Waldorf School's SUP application for the space at 424 N. Washington Street and we are very concerned. We are reaching out to local officials to ask that this SUP application be denied. At the very least, please pause before making a final decision on this approval and consider the dangerous location that you will be putting these children in. A thorough traffic study needs to be conducted so that no one is put in harm's way - this corner is identified as a High Crash Network location and this is not a location for an elementary school. 100+ kids loading and unloading on this busy street seems to me to be a recipe for disaster.

Columbus Street. We have lived there almost 13 years. While this may be a great school, we do not support this school to be located here for the following reasons:

- The construction of a fence to enclose the proposed playground will eliminate an easement off the alley that is needed for emergency vehicles and utility trucks to turn around. There are two poles in the alley with electric lights, neighborhood power, telephone wires, and Comcast. Will the fence negate the easement? The need for access for fire in backyard is paramount as experienced in the alley a few years ago.
- 2. Turning the parking lot owned by 424 N. Washington into a playground means the loss of 14 parking spots for staff who commute. I wonder how many of the 30 staff will park on the street, denying residents of the area.
- 3. There are safety issues concerning pickup and drop off of young children on N. Washington Street with traffic whizzing by and commuters jumping into that parking lane when it's open. (From my experience of walking the dog early in the morning and afternoon on N. Washington, the Rush Hour begins at least an hour earlier than advertised.) Dropping off and picking up 50 children, including unbuckling seatbelts of younger children and gathering lunches, backpacks, etc. during the allotted time may be a goal, but doing it in the projected time is unrealistic. Meanwhile drivers are not to get out of the car.
- 4. Because of the safety of children with initially 50 and eventually 155, are at risk, drivers and commuters are also at risk. A traffic study of N. Washington should be initiated and a realistic plan for the discharge and pickup of children be developed before this request is approved.
- 5. There are 3 reserved spots in the parking garage 1 ½ blocks away for parents who may be delayed or need to see school staff. Where is parking for the 30 staff?

My hope is that the City Council will not approve this site because of the lack of safety for these very young children, especially when 155 is the projected future number, as well as, drivers and commuters.

Dear City Council,

Please consider this comment as part of Item 11 - Special Use Permit for Potomac Crescent Waldorf School #2021-00128, during tomorrow's meeting.

My wife and I have been Alexandria City residents since 2017 and live in Seminary Hill, along with our two young daughters. Our older daughter has spent the last two years as a student at the Potomac Crescent Waldorf School (in full disclosure, Jakob is also a member of the school's board). Given the many challenges of the last few years, we have been so grateful for what this school provides; the Waldorf curriculum is unique within Alexandria, and the staff are as dedicated and professional as we've come across. What this school offers its students, and the community as a whole, is a salve for much of the stress experienced during Covid.

However, we are not submitting this comment to advocate for the school's pedagogy, but to share our experience with how the school executes on its daily logistics, including pick-up and drop-off. Concerns have been raised by neighbors about the efficiency and safety of the proposed pick up/drop off plan at the school's new site at 424 North Washington Street. While we appreciate the concern for the well being of our children (we, as much as anyone, agree that their safety is paramount), we do want to share that in our time with PCWS, we have not had a single cause for concern in this regard.

In our daughter's time as a student, we have experienced two different school sites, and the school's leadership has been thoughtful in planning for and executing pick-up and drop-off at either. Our current location, on Prince Street, is no country road: there is a steady flow of traffic throughout the day and yet, as parents, we experience the pick-up process as safe and smooth. This is likely a function of a well prepared staff, good communication with the parent community, and the fact that our enrollment is significantly smaller than other independent schools in this area.

We understand that a school, even a small one, will have some effect on its neighbors' lives, but have read a number of concerns that seem to play loose with the facts and appear to be motivated by more than just a stated concern for student safety. With safety of our children as the goal, we would encourage the City Council to consider the voices of those members of the PCWS community who have had personal experiences with the school over the last few years, to value its unique educational offering, and to allow the school to move forward with its plans to become a tenant at 424 North Washington.

As an educator and one that supports and operates schools, I am not against having a school in the neighborhood. What I am concerned with is the lack of communication by the proposed school and the lack of concern for legitimate issues raised by the community.

Issues such as easements, trash storage and collection, noise and nuisance can likely be worked out. However, the issues of safety, traffic and parking are less likely to be resolved through negotiation.

As to Safety, I'm sure the permitting authorities will review the capacity limits of the building with regard to the projected 235 maximum students (see below) and 35 faculty, 270 people in total. Egress capacity is paramount with a group of this size. In addition, I'm sure the office reviewing and approving school charters will note the ages of the children and the relevant requirements for a large subset of them to be located on the ground floor of the building, again a fire/life safety egress issue.

However, the proposed drop-off and pick up plans project large volumes of cars on the incredibly busy N. Washington Street. As stated in the SUP, the school projects fewer cars than students as some families will have siblings attending. However, the cars with multiple students in the car seats in the back seat will create the riskiest situation. To egress multiple students from the back seat of a vehicle in the 24 seconds of average time that the school projects (600 seconds/25 cars - from the Addendum) both side doors will be utilized, thus putting the adult escort and student of each multi-student vehicle in a traffic lane.

As to Traffic, it appears the applicant assumes that cars dropping off students will be able to drive straight into one of the 5 drop off spaces. While my parallel parking skills have improved substantially while living in the area, I still must drive past the space, and then reverse into it. This not only adds significant time to the drop-off activity, which is expected to take 24 seconds, but ties up the lane in which I am driving backwards, while performing the parking maneuver. In addition, when the vehicles are done dropping off or picking up, they will need to exit the parking space and re-enter the flowing traffic.

At this point of N. Washington there are 3 lanes in each direction. The curb lane will be used for the 5 drop-off spaces, leaving 2 lanes of traffic. As stated above, the middle lane will now be used for parallel parking and re-entering traffic. Thus, the three lanes of traffic coming South along Washington Street, will be channelled into 1 lane, creating a large restriction and traffic congestion. I recommend that a formal traffic study be performed by a competent traffic engineer to analyze this issue. It is imperative to perform reasonable due diligence to insure the safety of the parents, students and staff of the school as well as the drivers and pedestrians traversing the area **BEFORE approving this SUP**.

As to Parking, this issue too should be analyzed as the 35 staff members will need spaces throughout the day, as will parents that want to enter the building and talk with teachers or staff during drop off or pick up, and visitors and parents throughout the day, especially those in the proposed Child-Parent program. While still inadequate, the 14 spaces that originally were part of the premises will be removed to create a playground, thus exacerbating the issue. Nearby alternatives, such as the Wells Fargo parking lot could be investigated. This situation should be analyzed and addressed **BEFORE approving the SUP** and the entire neighborhood bears the negative impact.

Thank you for your time, and consideration of these important issues.

I hope this email finds you well. I am writing on behalf of PCWS and their proposed drop-off/pick-up location. As a parent of a child at PCWS, the safety and efficiency of drop-off/pick-up is of utmost importance to ensure a seamless transition to school for my son and his parents to work.

The current drop-off/pick-up has been on one of the busiest intersections in Old Town (Prince and Washington). Even with the construction going on, people transitioning back to work, there have been **zero** issues. This includes no back ups, no traffic tie-ups, no disruptions to the children or the surrounding areas and flow of traffic.

I understand that surrounding homes and communities may be concerned with the 'extra' traffic coming to their area in an already high traffic area. And, the reality is, drop-off/pick-up is 15-30 minutes in the morning and afternoon, making a total of 30-60 minutes in a day. I am writing in regard to the pending special use permit application by the Potomac Crescent Waldorf School (PCWS) for its new location at 424 North Washington Street. My son has attended PCWS for the past three years, and the administration there has let the parent community know that there have been concerns raised by neighbors about the safety of the school's plans for student drop-off and pick-up.

I have seen the site in question at Oronoco St. and know the plan for drop off and pick up to be similar to the one the school has been using since the beginning of this school year (September 2021) on Prince St., adjacent to the school's current temporary location. Having participated regularly in those drop-offs and pick-ups, I can attest not only to their safety, but also their efficiency. In the 7-8 months of operation in its current location, I have never once encountered a problem that raised concerns for the safety of my son or for any of his fellow students, nor have I encountered any significant congestion that created a hazard or blocked traffic. We are writing as parents of a kindergartener at the Potomac Crescent Waldorf School (PCWS) and offer this comment as part of Item 11 - Special Use Permit for Potomac Crescent Waldorf School #2021-00128, during the April 23, 2022 council meeting.

It has come to our attention that some neighbors have raised concerns about the school's planned new location at 424 N. Washington Street, under the guise of potential safety concerns of the proposed parking plan for school pick-up and drop-offs. We understand this parking plan was proposed by the city, which would seem to have taken into consideration many factors, with safety being foremost!

Potomac Crescent has always put the safety and well-being of our children front and center. We have seen this firsthand since our daughter enrolled in the PCWS early childhood programs in 2018.

The current drop-off and pick-up schedule is a perfect example of PCWS' commitment to children's safety. We have staggered arrival and pick-up times based on programs and grades, so there is not mass confusion. The process is swift and moves efficiently – even with car seats and the buckling that entails! Our daughter is currently in the largest class at the school and our time at the school is minimal.

We also regularly carpool with another family; and often pick up friends in the grades and have found those pick-ups seamless.

We believe any city that wants to see children thrive would welcome a school like PCWS. PCWS believes in the preservation of childhood. In the early childhood programs that means a strong emphasis on rich, imaginative childdirected play and being outdoors (in all kinds of weather: rain or shine, snow or heat, sometimes all in the same week but that's a letter for another time!). The school's approach to literacy in the early years is also developmentally appropriate, such as through songs, verses and stories. This is precisely the type of early childhood program experts advise parents to seek out.

We recognize we have been extraordinarily privileged to be able to send our child to this school during the pandemic. That she was able to attend safely, in-person. We wish every child had that opportunity and could attend a school like this.

We mention this because it is another example of Potomac Crescent's commitment to the safety and well-being of its school community. This is a school that spent countless hours working in tandem with the Alexandria Department of Health to develop a detailed Covid plan that allowed it to open safely in-person, before there were vaccines available to anyone, let alone teachers and young children.

I live at 423 N. Columbus Street, and am opposed to the Special Use Permit #2021-00128 (item #11 on Saturday's agenda). In my opinion, the applicant has failed to work with the neighbors in good faith to come up with some compromise solutions to the many problems outlined by the neighbors.

In particular, I am concerned about the traffic issues that the school will create. The applicant's plan is completely unrealistic. There is simply no way that the parents will be able to drop off and pick up the students with the military precision that will be required to meet the overly aggressive goals. I speak from personal experience. The junior high school I attended had fewer than 100 students and a rather large driveway and parking area for parents to drop off and pick up the children. In spite of this, the traffic and confusion was always a nightmare at both drop off and pick up times.

The present applicant is proposing to have many more students than were at my school. There is simply no way that this can be done safely in the proposed five designated spaces. I believe that a reasonable alternative would be for the school to make some arrangement with the owners of nearby parking lots, such as 300 N. Washington Street, and have a crossing guard help the children across Princess Street.

I strongly believe that this item should be delayed to allow the applicant, staff, and neighbors to come up with a reasonable plan.

I lived here when Sunrise was planning its (much larger) complex on the same block. In contrast to the school applicant, Sunrise did an excellent job of working with the neighbors and revising its plans so that everyone was happy.

Please send this proposal back to the drawing board for further discussions with the neighbors!

I hope this reaches you well.

I am writing as a proud parent of the Potomac Crescent Waldorf School community. I have had children at the school since 2017.

I have seen the school administration and staff pivot so seamlessly when the Covid pandemic hit, and ever since then I have been thoroughly impressed with their ability to create stability for the children on every level you can imagine.

Because of my experience with the school, they have the full confidence of my husband and I to ensure the safety and security of our children

A few ways they have gone above and beyond to be mindful of the load on parents and our Old Town community:

- Pick-up/Drop-off times at PCWS have been staggered, resulting in even distribution of traffic and short wait times to unload or load our children;
- Teachers work together in groups to ensure even a group of children as small as 10 are escorted to their car safely and efficiently.
- Arranging carpool with parents driving multiple children in their cars;
- The PCWS Administration and Faculty have managed drop-off and pick-up of the children very well, inspiring our confidence that they will continue to do the same at the school's new location.

While all of this is important, I truly believe that schools like PCWS will make Old Town even better. The children love their school community and we are raising the next generation of stewards of their neighborhood and community.

My name is George Best. I live at 421 North Columbus St., which is diagonally adjacent to the proposed school.

I'm here today because I think that the proposal to use for 24 North Washington St. as a school is the wrong use for the property. I believe that for many reasons, most of which other people will present to you as part of statements.

Instead of spending my time repeating our concerns regarding the safety of the parents and children during the drop-off process in the pickup process on N. Washington St. and in the faulty assumptions underlying the school's proposed drop-off and pickup process, I'd like to spend some time today addressing other problems with the proposed SUP. In particular, I'd like to address the shortcomings of several of the conditions staff imposed on the SUP.

First, a proposed change to condition 3. As written, this condition allows the Director of Planning & Zoning to revisit the pick up and drop off plan. I request that this review be made mandatory on an annual basis so that the plan is revised to reflect the effect of changes in the school's enrollment.

Second, I request clarification of the enrollment limit specified in condition 4. In the application, the Applicant proposes an early childhood program with an enrollment of 80 students, a 75 student grade school, and Parent-Child programming with an additional 30 child participants. See page 5, item 5A of the application. This is a total of 185 students, 30 parents, and school staff. As written, Condition 4 does not mention the Parent-Child programming or appear to place any limit on the number of participants in that programming. I ask that the condition be rewritten to clarify that the total number of parents and children participating in the Parent-Child programming count against the 155 student limit set forth in the Condition.

Third, I suggest that the grammatical error in condition 12 be fixed by adding the missing commas to the sentence. The first sentence should read: "Trash and

garbage shall be stored inside or in sealed containers that do not allow odors to escape, invasion by animals, or leaking."

Fourth, I request that condition 13 be amended to require Applicant to pick up litter in the private alley where their dumpsters will be located. As written, the condition only requires them to pick up litter in public rights-of-way and public spaces. The private alley is neither.

Fifth, I request a new condition that prohibits Applicant from leaving its dumpsters at the end of the alley or on Oronoco Street on trash pickup days. If, as is common practice, Applicant rolls its dumpsters to the end of the alley after the night before or the morning of trash pickup day and leaves them for the garbage service to pick up, the dumpsters will either block the alley entrance, or the entrance to the off-street parking on either side of the alley and will continue to do so until they are returned after the dumpsters are emptied. Because the alley is too narrow for a garbage truck to enter, when the garbage truck arrives, the workers performing the pickup should be required to get the dumpsters from their storage space on Applicant's property, take them to the truck to be emptied, and return them to the storage space. That way the dumpsters will not block alley access or the neighboring offstreet parking entrances.

Sixth, I request a new condition requiring Applicants to contract with the Alexander Police Department to have an officer available to direct traffic during the drop-off and pickup times. Condition 3 requires the applicant to "ensure that traffic does not back up or cause traffic circulation issues on N. Washington St. or Oronoco Street." St. Mary's School has two police officers to direct traffic during their dropoff and pickup times. While St. Mary's is a larger school, it is located at the end of a dead-end street. They need two police officers to direct traffic. Based on this experience, is reasonable to expect that at least one person to direct traffic on a busy street like North Washington will be necessary.

Seventh, I request a new condition requiring Applicants to store their dumpsters on their property. I realize that the Staff's presentation states that this will be the case, but the conceptual drawing included in the SUP does not show any space for such storage.

Eighth, at the March 19, 2022 meeting with the neighbors, Joshua Hartman, who I understand is the chairman of the school's board of directors represented that the parking lot would be converted to "open space" and that there would be no playground equipment. I request a new condition that reflects this representation and holds Applicant to the promises it made to its neighbors. I note that the drawing included in the SUP shows playground equipment.

Ninth, at the March 19, 2022 meeting with the neighbors, Mr. Hartman represented that the open space would only be used between the hours of 10:30 AM and 1:30 PM. Reflecting this representation, I request a new condition that limits the use of the open space to between 10:00 AM and 2:00 PM. The Planning Commission indicated that they did not want to interfere with the operation of the school in this manner. However, SUPs for other types of businesses routinely place limits on their outdoor operations, especially those which adversely affect their neighbors.

In summary, Staff's proposed conditions appear to reflect a process in which neither Staff nor the Planning Commission gave much thought to the realities of the day-to-day operation of a school at the proposed location. My conclusion is supported by several pieces of evidence:

1) Staff appears not to have visited the site. Staff told the planning commission that the alley behind the school is 16 feet wide. If they had visited the site, they would know that the initial part of the alley is only 9 feet wide and is bordered on both sides by brick walls. Moreover, if the building owners follow the proposed conceptual drawing provided in the SUP and construct a fence or wall of the property line to define the boundary of the "open space," the entirety of the alley

will only be 9 feet wide. Staff's error impacted the Planning Commission's deliberations in several ways.

2) Staff appears not to have been aware of the Emergency Vehicle Easement until it one of my neighbors pointed it out in a letter to the Planning Commission.

3) The Planning Commission was visibly annoyed when they were informed that this sup would have to be removed from the consent docket and become the subject of a public hearing.

4) It was apparent from the outset of the Commission's deliberations that they were determined to recommend approval of this SUP. It was clear that they did not seriously consider any of the concerns raised in the public testimony. Indeed, one commissioner dismiss concerns about the ramp at speeding and red light running on Washington Street by words to the effect of "I plan for the city I want, not the city that it is. I don't want to accept high speeds on Washington Street." The logical inference from this statement is that the parents and children at the proposed school in danger in order to create congestion which she hoped would slow traffic. I don't think that she literally meant to this, I just think that she hadn't fully thought through her statements.

I ask that you consider my proposed changes and additional conditions in the event that Council decides to approve the SUP so that at least some of the ill effects of this unsuitable intensification of use are mitigated.

I write as a resident at 425 North Columbus Street in opposition to the Special Use Permit #2021-00128. The applicant has failed to work with the neighbors in good faith to resolve issues with the conversion of a long-time office building into a school housing 200+ children and faculty. This approval should be delayed until we can come to some compromise solutions on a number of issues.

We have lived through massive construction on our block, the shaking of our houses for the building of the Sunrise facility, cracked plaster and sewer lines, and reduced parking from these new developments. We dutifully bear these costs in addition to the costs associated with being the stewards of our 130+ year-old houses. We understand development, we welcome our neighbors in assisted living and are willing to work with a potential school, but we do have concerns.

I respectfully request a delay in the approval of this application and a plan and resolution to a number of issues:

1) Pickup and dropoff on GW parkway is not a good idea. This is basic sense. We can talk about plans to reduce the risk but drop off on a major highway artery is risky. The intersection of Washington and Oronoco has 20 accidents reported on Zero Vision Viewer and one pedestrian was seriously injured in April 2019. The school needs a better plan for drop off and pick up. There is a parking lot behind Wells Fargo on Princess that could be considered as a safer drop off spot.

2) Fence line, trash and rodent plan. There will be food debris, diapers, and other trash resulting from the school. The current plan leaves no room for dumpsters, or the pickup of trash and in fact has the fence line going all the way to the alley with zero of the necessary space to store, access, and remove trash. The fence line also reduces access to the back of our homes and long-standing parking on multiple properties off of the alley. The plan needs to include sufficient space for dumpsters, push the fence line back, and include a plan to manage the increased rodent activity that will certainly occur.

3) Parking. There is almost zero chance that late arriving students and their parents will park three blocks away and walk. Teachers will drive and park on the street, and the current plan will reduce our ability to use our off-street parking, while reducing our ability to park on the street.

I was able to flip through the letters sent in support and opposition to this application. Not one person in support lives in the Old Town neighborhood. This is actually where we live; this is our neighborhood and our home. We have small children and value education; we send our children to Jefferson-Houston, and invest in making our public schools places where everyone can be included and succeed. We hope that you will consider our feedback and address our concerns before moving forward with this application.

Something doesn't make sense here, and it seems as if someone hasn't done the math (ironic given the planned use).

Parking: Parking is already tight in the area. In the vicinity of my home, we barely have enough spaces for the Permitted residences. Elimination of parking on the adjacent blocks for a loading and unloading zone will only exacerbate the situation. On top of that, it doesn't add up that there are to be something north of 30 employees of the school, and only a dozen existing parking spaces — some of which will be eliminated by the addition of a play area. It would be great if everyone working at the school would take public transportation or car pool, but that's a rosy prospect — and very unlikely. This will further make parking issues worse. The math doesn't add up.

Drop-Off: The drop-off/pick-up plan looks decent on paper, and might even work if every parent and every student and every rush-hour driver was a robot. But let's get real — these are real parents and children. There no way that this will run as perfectly smoothly as represented. And the offerers of this plan haven't addressed the "what if..." Moreover, there are safety issues in play here. Washington street is one of the most heavily trafficked and highest speed streets in Old Town. This has a real potential for being a mess — or worse.

I am not opposed to a school going in there. I am opposed to granting this SUP at this time, with this poorly-conceived parking and traffic plan. I ask the Council to send this back to the drawing board.

The purpose of this memorandum is to recommend the deletion of Condition #16 of SUP #2021-00128 for a private academic school over 20 students at 424 North Washington Street. The condition was added at the Planning Commission hearing on April 7.

Condition #16 reads:

If the rear of the property is encumbered by an Emergency Vehicle Easement, the applicant shall consult with the Fire Department on a playground design and on rear fencing that comply with Fire Department requirements for emergency vehicle access. The applicant will continue to work with the City to determine whether there is an Emergency Vehicle Easement. (PC)

Since the Planning Commission hearing, staff collected additional information which negates the need for this condition. The City Attorney reviewed a 2020 title report that confirmed a recorded Emergency Vehicle Easement does not exist in the rear parking lot. In addition, the Fire Department confirmed that the EVE would not have been a condition it would have required at this location given that one is not usable due to lack of emergency vehicle access from the 16-foot rear alley.

Staff continues to represent the Planning Commission recommendation of support for the private academic school with over 20 students with the deletion of Condition #16.

#### Planning Commission Recommends Playgrounds Over Emergency Service Access For School

The Planning Commission's (PC) discussion of the Potomac Crescent Waldorf School on the value of a "presumed" Emergency Vehicle Easement (EVE) for 424 N Washington Street was comical, except that ensuring access for emergency services personnel to do their job is not a joke. City staff notified the PC that the Fire Department staff that reviews the information involving the recently found EVE materials had not done so because they were not in the office and the Zoning staff just found out about the EVE the day before. With that information, the PC members concluded that since the EVE was not found by a title company, not known to the Fire Department (because they were never shown it in time), not used by them, and because they can just get access from Washington Street and use their ladders, then the PC did not need to look any further. The PC eventually amended their approval to include that "the applicant shall provide documents to the satisfaction of the Director of Planning and Zoning to confirm the existence of an Emergency Vehicle Easement in the parking lot. If an easement exists, the applicant shall consult with the Fire Department on a playground design and on rear fencing that comply with Fire Department requirements for emergency vehicle access (PC)."

There are plats dated December 30, 1983, April 29, 1988, and February 25, 1999, which show the existence of the EVE. Despite this, the PC has left the safety of 155 children up to the City, which has proven to be unaffected by the concerns of past City officials and PC members who took great care to put a higher value on public safety and emergency services when it required the 22 ft wide EVE at the rear of the property, clearly a necessity for the location of the property. In the years since the EVE was created, the conditions have not changed. If anything, the EVE is more important now as the population and use of the property and surrounding area increases.

Anyone can see that EVE would provide greater access to the rear of the property for fire safety and EMS services for the entire block, as well as room to turnaround vehicles. Meaning that disposing of the EVE doesn't affect only 424 N. Washington but also its surrounding neighbors. The point of an EVE is to prevent property owners from building obstructions like playgrounds and fences in the areas that emergency services will likely need to use in an emergency!

Instead of creating a plan that works for the future safety of the children, the PC has elected to ignore this EVE and its importance in favor of quickly approving a profitable use for the building, regardless of its safety concerns and needs for the area and without even bothering to wait for input from the Fire Department, leaving the most important topics to be discussed and decided "if necessary" at a later time, if at all.

I am Elaine Wick and live at 429 N. Columbus Street, directly behind 424 N. Washington St. I fully agree with the previous testimony given by my community, both the value of quality schools and the problems we face with this proposal. Two issues:

The proposed playground and fence back directly up to the 9-foot-wide alley that separates our properties.

Issue one is the absolute necessity of keeping the easement for vehicle turn-around off the dead-end alley, which would be eliminated by the proposed playground. It is necessary for fire safety reasons and for utility vehicles to service transformers in the alleyway.

But the second issue is simply the safety of disabled persons or anyone who can't climb stairs.

Let me explain. The only access to this building for disabled persons is from the back side, where there will be a ground level elevator. To get there, disabled people will need to travel (on foot?) through the 63foot-long alley, then through the playground, as there would be no handicapped parking or vehicle turn-around space in the 9-foot-wide alley due to the playground. This would be after those people find parking on the street or garage, maybe blocks away.

I believe that schools plan to have good safety standards. But I can't imagine having a child of my own with disabilities navigate this back door entry course every day. Or for a parent on crutches or a grandparent to have to do so.

And For 155 students, numerous staff members, parents, grandparents, etc, it is hard to imagine that no one will ever need this access.

Therefore, I hope that a clear study of this problem would be made, and I believe this application should be denied at this time.

My name is Leander Wick of 429 N. Columbus and I do not support this school being located on a very busy street and backing into my patio. I have written two descriptions of what I was going to say this morning, but I trashed them. My neighbors and friends have or will state them better than I. They talked about safety, fences, trash, rodents, narrow 9 foot wide alley, playground for 150 children, easement, and so forth. They gave you the facts, something at times I found unclear or lacking in the Waldorf presentation.

I want to say for me it is a most serious and sacred obligation that the safety of children be of the upmost importance. They are our future. I don't think there is a person in this Hearing that would not agree with this. If my grandchildren were younger, I would not send them to a school located on a very busy street with a very risky drop off and pickup plan and a very small playground on a parking lot. It is not the curriculum, but the location that is objectionable.

As it stands, I think this request should not be approved but at the best be delayed until community concerns are addressed.

A maximum of three minutes will be allowed for your presentation, except that one officer or other designated member speaking on behalf of each *bona fide* neighborhood civic association or unit owners' association desiring to be heard on a docket item shall be allowed five minutes. In order to obtain five minutes, you must identify yourself as a designated speaker, and identify the neighborhood civic association or unit owners' association you represent, at the start of your presentation. If you have a prepared statement, please leave a copy with the Clerk.

Additional time not to exceed 15 minutes may be obtained with the consent of the majority of the council present; provided notice requesting additional time with reasons stated is filed with the City Clerk in writing before 5:00 p.m. of the day preceding the meeting.

The public normally may speak on docket items only at public hearing meetings, and not at regular legislative meetings. Public hearing meetings are usually held on the Saturday following the second Tuesday in each month; regular legislative meetings on the second and fourth Tuesdays in each month. The rule with respect to when a person may speak to a docket item at a legislative meeting can be waived by a majority vote of council members present but such a waiver is not normal practice. When a speaker is recognized, the rules of procedures for speakers at public hearing meetings shall apply. If an item is docketed *for public hearing* at a regular legislative meeting, the public may speak to that item, and the rules of procedures for speakers at public hearing meetings shall apply.

In addition, the public may speak on matters which are not on the docket during the Public Discussion Period at public hearing meetings. The mayor may grant permission to a person, who is unable to participate in public discussion at a public hearing meeting for medical, religious, family emergency or other similarly substantial reasons, to speak at a regular legislative meeting. When such permission is granted, the rules of procedures for public discussion at public hearing meetings shall apply.

#### **Guidelines for the Public Discussion Period**

(a) All speaker request forms for the public discussion period must be submitted by the time the item is called by the city clerk.

(b) No speaker will be allowed more than three minutes; except that one officer or other designated member speaking on behalf of each *bona fide* neighborhood civic association or unit owners' association desiring to be heard during the public discussion period shall be allowed five minutes. In order to obtain five minutes, you must identify yourself as a designated speaker, and identify the neighborhood civic association or unit owners' association.

(c) If more speakers are signed up than would be allotted for in 30 minutes, the mayor will organize speaker requests by subject or position, and allocated appropriate times, trying to ensure that speakers on unrelated subjects will also be allowed to speak during the 30 minute public discussion period.

(d) If speakers seeking to address council on the same subject cannot agree on a particular order or method that they would like the speakers to be called on, the speakers shall be called in the chronological order of their request forms' submission.

(e) Any speakers not called during the public discussion period will have the option to speak at the conclusion of the meeting, after all docketed items have been heard.
