ORAL REPORTS FROM MEMBERS OF CITY COUNCIL ON BOARDS, COMMISSIONS, AND COMMITTEES

*Virginia Railway Express (VRE) (Councilmember Bagley)

Councilmember Bagley reported that the VRE had a guest speaker from the Federal Railroad Administration to highlight the 100 year planning and capacity work being done for railways around the country and funding to address at-grade crossings to improve safety. Councilmember Bagley noted that there was also a conversation about the grocery tax and the loss of that funding and VRE signed on to a letter expressing desire to see sustained, committed funding for transportation as result of the possible loss of the grocery tax.

*Northern Virginia Regional Commission (NVRC)(Councilwoman Gaskins and Councilman Chapman)

Councilwoman Gaskins reported that the Commission received a presentation on the Virginia Coastal Resilience Master Plan and she noted that the information is available online with a web explorer tool that can allow the public to see where projects are occurring, the funding sources being used for the projects, as well as an equity piece that highlights social vulnerability. Councilwoman Gaskins noted that she and Councilman Chapman have contacted staff to see if any of those tools can be implemented in the City.

Councilman Chapman reported that the Commission is working to bring an Historically Black Colleges and Universities (HBCU) presence to the region and there is a trip scheduled to Virginia State University to speak with the leadership about what type of partnership would be beneficial to the school and the students if there was a campus in the Northern Virginia area.

*Library Board (Councilman Aguirre)

Councilman Aguirre reported that the Library Board discussed the usage of the ARPA funds and they have begun circulation of hotspots for public use. Councilman Aguirre reported that the Board reviewed the Emergency Connectivity Fund grant in honor of Love my Library Month and have made 50 of the Chromebooks purchased with the grant available for public use through the end of February. Councilman Aguirre reported that the will be a paid internship available this summer for special collections branch for five weeks. Councilman Aguirre also noted that the Board discussed possibly hiring a development director to help with fundraising for the Library.

*Northern Virginia Transportation Commission (NVTC) (Councilman Aguirre and Councilmember Bagley)

Councilman Aguirre reported that Commission recognized the departing Commissioners and thanked them for their service and welcomed new members. Councilman Aguirre also reported that the Commission welcomed Senator Adam Ebbin back to the executive committee. Councilman Aguirre noted that Commission had a discussion with Washington Metropolitan Area Transit Authority (WMATA) General Manager Paul Wiedefeld about transit services and thanked him for his service to the authority as he prepares for retirement. Councilman Aguirre pointed out that the Commission received updates from the Program Advisory Committee, including the passage of a couple of resolutions related to a submission to DRPT for a regional bus analysis and a submission for zero emission buses and related strategic plan. Councilman Aguirre reported that there will be a Bus Rapid Transit system along Route 7 to the Tysons Corner area.

Councilmember Bagley noted that Mr. Wiedefeld reported that WMATA is still on track for the electrification of the bus fleet for the system and that the bus ridership is returning at greater rate than rail ridership.

- **WHEREAS**, the Alexandria City Council desires to submit an application to the Regional Roadway Safety Program for up to \$80,000 for Fiscal Year 2023 for Route 1 and Duke Street Intersection Improvements.
- **NOW THEREFORE BE IT RESOLVED,** that the City Council of the City of Alexandria hereby supports the application for up to \$80,000 from the Regional Roadway Safety Program from the Metropolitan Washington Council of Governments for Fiscal Year 2023.
- **BE IT FURTHER RESOLVED**, that the Alexandria City Council hereby grants authority to the City Manager to apply for these grant funds and enter into any necessary agreements with the Metropolitan Washington Council of Governments to accept this grant.

WHEREAS, the affordable housing proposed in this Area would not be economically feasible without the provision of federal low-income housing tax credits and significant City investment at advantageous rates and terms; and

WHEREAS, the proposed development will provide a critical source of affordable housing for current and future low-and-moderate income residents at a range of incomes whose tenancy and local employment is essential to the Area's future economic development and sustainability, as well as to the City's strategic plan goal of maintaining neighborhoods that are diverse, inclusive and true mixed-income communities;

NOW, THEREFORE, BE IT HEREBY DETERMINED as follows:

- (1) The industrial, commercial or other economic development of such area will benefit the city or county but such area lacks the housing needed to induce manufacturing, industrial, commercial, governmental, educational, entertainment, community development, healthcare or nonprofit enterprises or undertakings to locate or remain in such area; and
- (2) Private enterprise and investment are not reasonably expected, without assistance, to produce the construction or rehabilitation of decent, safe and sanitary housing and supporting facilities that will meet the needs of low-and-moderate income persons and families in the Area and induce other persons and families to live within such areathereby creating a desirable economic mix of residents in the Area.

NOW, THEREFORE, BE IT HEREBY RESOLVED that pursuant to Section 36-55.30:2.A of the Code of Virginia 1950, as amended, the Area is hereby designated as a revitalization area.

Two of the four at-large community representatives shall be residents located west of Quaker Lane and one representative shall be an apartment renter; and authorized the City Manager to appoint the four at-large representatives, the small independent business representative, and one development community representative. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

RESOLUTION NO. 3058

RESOLUTION TO AUTHORIZE THE CITY MANAGER TO APPOINT AN AD HOC DUKE STREET TRANSITWAY ADVISORY GROUP

WHEREAS, the City Council wishes to establish an Ad Hoc Duke Street Transitway Advisory Group, and

WHEREAS, the Duke Street Transitway Advisory Group will comment on the Duke Street Transitway alternatives, conceptual plans, and preferred plan, and conduct specified tasks outlined in this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINIA:

- 1. That there is hereby established the Duke Street Transitway Advisory Group (the "Advisory Group").
- 2. That the Advisory Group shall consist of eleven (11) members, and the composition of the group shall be as follows:

- Transportation Commission member (1)
- Planning Commission member (1)
- Alexandria Commission on Persons with Disabilities member or designee (1)
- DASH Bus Riders Group member or designee (1)
- Federation of Civic Association member or designee (1)
- At-large community representatives (4)
- Representative of the development community (1)
- Small independent business owner along the Duke Street corridor (1)

Two of the four at-large community representatives shall be residents located west of Quaker Lane. One representative shall be an apartment renter.

- 3. That the Chairs of the above-named groups shall nominate a member of their group to serve on the Advisory Group.
- 4. That the remaining four at-large, one development community, and one small independent business owner representatives will be appointed by the City Manager and represent interests unique to this project such as students, renters, businesses, minority communities, and non-driving households.
- 5. That the City Manager shall designate the Chair of the Advisory Group.
- 6. That the mission of the Advisory Group shall be to provide input on key deliverables and project recommendations related to the Duke Street Transitway planning and preliminary design.
- 7. That the Advisory Group's primary charge shall be to:
 - Represent the perspectives of their representative constituencies and communicate back to their respective groups as appropriate;
 - Consider and adopt the project vision and guiding principles;
 - Provide comments and recommendations for corridor design alternatives;
 - Recommend to Council to either adopt or reject the recommendation from the 2012
 Transit Corridors Feasibility Plan; and
 - Provide an endorsement of a preferred alternative for City Council consideration.
- 8. That the Advisory Group shall work towards development of consensus provisions, brokered compromises and formal votes to the extent possible and, in cases where there are differing opinions, they shall be included in reports to City Council.
- 9. That staff assistance to the Advisory Group shall be managed by the Department of Transportation and Environmental Services (T&ES) with assistance from other City departments and offices as needed.
- 10. That pursuant to City Code Section 2-4-8, the Advisory Group shall meet on an ad hoc basis as needed for a limited duration of one year, unless otherwise extended by City Council.
- 42. Consideration of a Resolution to Establish Permit Fees for Parklets. [ROLL-CALL VOTE]

WHEREUPON, upon motion by Councilwoman Gaskins, seconded by Councilman McPike and carried unanimously by roll-call vote, City Council approved the resolution to establish permit fees for parklets with amendments to section 3 stating, "Permit fees for Annual Parklets shall be 50% of these fees for any permit issued and valid between October 1, 2022 through September 30, 2023"; and section 4 stating, "Permit fees for Annual and Short-term Parklets shall not be collected until October 1, 2022." The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

RESOLUTION NO. 3059

RESOLUTION TO ESTABLISH PERMIT FEES FOR PARKLETS

WHEREAS, under Section 2.07 of the City Charter, the City Council has the authority to establish fees to be charged for services provided by the City; and

WHEREAS, under City Code Section 5-2-29(j), parklets are a permitted encroachment subject to the criteria referenced in this section; and

WHEREAS, under City Code Section 3-2-85, the fee for encroachments for parklets shall be established by resolution of the City Council; and

WHEREAS, the City of Alexandria, Virginia desires to establish a permit fee for parklets allowed as permitted encroachments under section 5-2-29 of the City Code; and

WHEREAS, the City Council finds and determines that the setting of such permit fees for parklets is necessary and proper at this time.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

- 1. Permits fees for Annual Parklets shall be based on the length of parking that is removed to accommodate the permit and assessed as follows:
 - a. Parklets that are open to the public at all times \$15 per linear foot
 - b. Parklets that are used by a commercial business and:
 - i. Within the King Street Retail Strategy area \$150 per linear foot
 - ii. Within an Equity Emphasis Area (as defined by MWCOG) \$50 per linear foot

- iii. All other areas \$100/ per linear foot
- 2. Permit fees for Short-Term Parklets (i.e. parklets in place for less than 7 days) shall be as follows:
 - a. Permit fee (for initial review of plans and location) \$100
 - b. Applicable fees for Temporary Reserved Parking signage, which depend on the number of days the parklet will be in place (less than 7 days) and whether the space is a metered space or non-metered space.
- 3. Permit fees for Annual Parklets shall be 50% of these fees for any permit issued and valid between October 1, 2022 through September 30, 2023.
- 4. Permit fees for Annual and Short-term Parklets shall not be collected until October 1, 2022.
- 5. That such fees established above shall apply, unless and until revised by the City Council.
- 6. That the City Clerk be, and hereby is, authorized and directed to affix the seal of the City to such documents as may be necessary or convenient implement this Resolution; and

That this Resolution shall be effective immediately.

The maximum rates authorized by City Council in the ordinance reflect:

A base real estate tax rate on residential, commercial and industrial property for calendar year 2022 of \$1.115 per one hundred dollars of assessed valuation. The FY 2023 proposed budget reflects a real estate tax rate of \$1.11. No increase will be considered for the tax rates on personal property (vehicles) or business-tangible property.

- 1. Assumed in this proposed amount is the continued dedication of 0.6 cents for affordable housing;
- 2. Assumed in the proposed amount is the continued reservation of 2.2 cents of the real property tax rate for transportation projects;
- 3. A Special Services District tax is proposed to continue to be levied on all real property located in the Tier I Potomac Yard Metrorail Station Special Services District at the current rate of \$0.20 per one hundred dollars of valuation;

For all other taxes, the following rates are proposed:

4. A personal property tax rate on vehicles for calendar year 2022 of \$5.33 per one hundred dollars of assessed value. The FY 2023 proposed budget recommends a vehicle personal property tax rate of \$5.33 to fund the base budget; and

5. A tangible business personal property tax rate for calendar year 2022 of \$4.75 per one hundred dollars of assessed value and a machinery and tools tax rate of \$4.50 per hundred dollars of assessed value. The FY 2023 proposed budget recommends a tangible personal property tax rate of \$4.75 and a machinery and tools tax rate of \$4.50 to fund the base budget.

City Council set the ordinance for public hearing and second reading on Saturday, April 23 and final passage on Wednesday, May 4, 2022.

The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

- 2. On line 36, page, 3, add the following words, "Notwithstanding any other section of the City Code, referenced or otherwise, penalties of this section may escalate and ultimately may include immobilization or removal whether or not the previous penalty fines have been paid.";
 - 3. On line 32, page 3, the fee should be changed to \$250 for the second violation; and
- 4. On line 33, page 3, the fee should be changed to \$350 for the third and any subsequent violation.

The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, Councilman Aguirre.

ORAL REPORTS AND ORAL PRESENTATIONS BY MEMBERS OF CITY COUNCIL

- 1. Vice Mayor Jackson stated that she agreed with a women's right to choose and that she was disappointed that the proclamation that was removed from the docket became a call for advocacy and lead to antagonism in the community. Vice Mayor Jackson offered an apology to the community who had differing views than hers.
- 2. Councilman Aguirre welcomed Fresh Baguette, a new business that opened in the City recently in Old Town.
- 3. Councilman Aguirre congratulated the 2022 graduating class of Healthy Families her in the City of Alexandria.

- 4. Councilman Aguirre reported that he had the opportunity to tour the rail operations command center, the bus operations command center and the safety operations command center for Washington Metropolitan Area Transit Authority (WMATA) being built here in the City.
- 5. Councilman Aguirre noted that vaccine clinics are continuing with community partners and the Health Department and he visited the clinic at Casa Chirilagua.
- 6. Councilman Aguirre congratulated Bill Reagan on his retirement from the Small Business Development Center.
- 7. Councilman Aguirre congratulated Kimberly Knight on being appointed as the Director of Libraries for the City of Virginia Beach, Virginia.
- 8. Councilman Chapman noted that there was increased activity along the Waterfront and that the Council may have to have future conversations about the vibrancy of the area for everyone.
- 9. Mayor Wilson noted that WMATA made an announcement earlier today regarding some significant impacts to the service in the community starting in September, impacting the yellow line. Mayor Wilson stated that Council would have more conversation with the provider and staff as they have had an opportunity to do some planning about accommodations.
