## Statement of Interest/Why You Should Be Appointed

I have been involved with avocational underwater and maritime archaeology for approximately fifteen years, primarily via the Institute of Maritime History (IMH). Since 2007, I have been an active volunteer Research Diver with IMH, currently led by Joshua Daniel, M.A. (who is also an Associate Director of the Institute of Nautical Archaeology) and David Howe, J.D. I have volunteered as a desk researcher and Research Diver on numerous assignments for the Maryland Historical Trust in the Potomac River and Chesapeake Bay, for the Naval Air Station Patuxent River, and for the Mount Vernon Ladies' Association (under the direction of Esther White). These various sites date from the US Revolutionary War through the middle of the 20th century. I was also selected in 2018 to be a member of a small dive team for the Pentagon's Defense POW/MIA Accounting Agency (DPAA), on a mission to locate and survey a sunken U.S. World War II bomber in a lake in northern Germany. I am a member of the Maritime Heritage Chapter of the Archaeological Society of Virginia, the Battle of the Atlantic Research and Expedition Group, and the Institute of Nautical Archaeology, and am working toward my Part 2 Certification with the Nautical Archaeology Society in the UK. My claim to fame is being featured as a research diver in a front page, full color article in The Enterprise newspaper in St. Mary's County, Maryland, just under a headline warning of a local rabid skunk. I moved to Alexandria in December 2019 in great part because of the city's maritime history, above and below the water. I would be honored to contribute in a small way to the important, historical work of the AAC. I do not take this commitment lightly because of the importance of the AAC's work locally, and because the AAC has led the way for many other such efforts across the U.S. since 1975. My most relevant interest and expertise is primarily in maritime / underwater archaeology, but if accepted as an AAC member I would look forward to learning more about the terrestrial work, and hopefully adding value to those efforts as well. Based on the several AAC meetings I have attended, I hold the AAC in high esteem, and am proud to live in a city with such an interesting and alive history, and such an engaged citizenry. My day job for the last fifteen years has been in a series of advocacy organizations focused primarily on the global water security challenge. I would like to see if my advocacy and communications skills (which admittedly are not in grassroots / community-based advocacy) could be useful to the efforts of the AAC as well. It would be a special honor to contribute to the work of a Commission with such history, and such future. There are a lot of archaeological discoveries still to be unearthed in Alexandria, a lot of stories to be shared with fellow Alexandrians, and a lot of opportunities for the Commission to engage further with the public.
