Statement of Interest/Why You Should Be Appointed

I have lived between DC and Northern Virginia for almost 12 years, starting in Braddock Road in 2010 as an intern on the Hill. The City of Alexandria is where most of my life currently revolves around, given the restaurants, the church I attend, the stores, and the local bookstore. Although I live in Belle Haven that's a few minutes away, the true center of the community ecosystem is the City of Alexandria. I will continue to live here for many years to come and actually thought I lived within the city limits given I'm still in Alexandria. Based on my professional and educational experience I could contribute greatly to BFAAC, in great part because I have already advised governments in large distress situations. I have worked on debt, fiscal, and operational restructuring through different lenses. One is from a policy standpoint in the U.S. House of Representatives, working to get legislation passed for Puerto Rico to get a mechanism for it to restructure its debt, and later through a consulting firm, working with a large government of over 100 agencies on restructuring their debt, operations and the utility company, totaling over \$70 billion in outstanding debt at the time. I've seen how Puerto Rico, where I grew up, changed over the years because of the deteriorating financial situation at the government level, and although the City of Alexandria is currently in a healthy financial position regarding its debt, I would like to contribute through this committee by providing input and assist in the City not changing its course of success. However, there are challenges the city faces with retail centers that are no longer operating how they used to and the city will continue to work on how to adequately pivot or repurpose those areas. As I'm currently a community development banker, I work with underserved communities in commercial loans, which have in many cases revitalized areas and improved the conditions in neighborhoods. I greatly appreciate the opportunity and consideration as I look forward to further discussing with your group how I could further contribute to

the Committee's goals.
