My background in organizing and legislative advocacy has included centering intersectional approaches to policy change and building strong relationships and coalitions with a wide range of issue stakeholders working at the intersections of gender and racial justice, as well as economic security for women. Before relocating to Alexandria in 2019, I served as a Mayoral appointee on the Philadelphia Women's Commission and was a leader of the Commission's work to integrate a Reproductive Justice framework into its local agenda-setting work and local and state-level advocacy portfolio. I helped spearhead local resolution strategies to call on the state legislature to provide equitable coverage for a full range of reproductive health services. I also worked with stakeholders in the city to improve conditions for incarcerated women in state prisons and to introduce a local and state-level legislative efforts to address the Maternal Mortality crisis in Philadelphia and across the state. This local-level public service experience complimented my state level legislative advocacy and coalition-building work to advance a Reproductive Justice Policy Agenda. Now that I am living in Alexandria, and working on policy issues uniquely impacting marginalized women in a wider range of states on behalf of a national organization, I am eager to build deeper relationships and continue my service and advocacy work at the local level to advance women's health and economic security.
