My career and volunteer experience uniquely equips me to serve on the board of Alexandria Renew Enterprises. I spent over 20 years of my professional career working on water policy issues at the federal level, as congressional staff and at the Department of the Interior and national environmental organizations. My work experience involved significant leadership roles, including as the director of a federal agency, as vice president of a national environmental organization, and as staff director of a congressional committee. In addition to this work experience, I have served as a volunteer on environmental issues and water policy in particular for the last twenty years in Arlington County and the City of Alexandria. I chaired Arlington's Environment and Energy Conservation Commission, served on Alexandria's Park and Recreation Commission, and now co-chair the Alexandria-Arlington Joint Task Force on Four Mile Run. With specific relevance to AlexRenew, I have served for the last 4 years on various stakeholder groups advising on AlexRenew's RiverRenew project -- first as a representative from the Park and Recreation Commission and more recently as a representative of the Carlyle/Eisenhower East community. I've also provided volunteer support for local river conservation work, now serving on the board of the Potomac Conservancy. My work on the RiverRenew project has given me a greater perspective on the responsibilities of AlexRenew, and I believe that my combined background in water policy, organizational management and local government advisory organizations gives me a broad range of skills that I could bring to the AlexRenew board. Statement of Interest/Why You Should Be Appointed

Thank you for considering my application for service on the Alexandria Renew Board of Directors. I have lived in Alexandria for almost 9 years, and throughout that time, I have been continually impressed by the professionalism and integrity of the agencies and utilities that work together to make our City a fantastic place to live. I would be honored to contribute to that shared spirit of excellent public service by applying my professional expertise to the AlexRenew Board. I am a nationally recognized expert in wastewater and stormwater policy with over a decade of experience advocating for cleaner waterways and better water infrastructure in communities across the country. At the Natural Resources Defense Council, I lobby for enhanced federal funding for wastewater and stormwater utilities, develop policies to ensure that water and sewer service is affordable for all people regardless of income, and advocate for the adoption of workable legal solutions to bring wastewater and stormwater systems into compliance with the Clean Water Act. Additionally, prior to my current focus on federal advocacy, I spent several years representing NRDC in a leadership role with the Choose Clean Water Coalition, an alliance of 200 environmental organizations advocating to clean up the Chesapeake Bay. As a result, I have a strong understanding of how Bay restoration policies – alongside local water quality goals – drive regulatory requirements for wastewater treatment plants and other dischargers. Like many Alexandrians, I'm excited about the transformational RiverRenew project that will reduce combined sewer overflows and accelerate the revitalization of the Potomac riverfront. I would love to contribute to that effort through service on the AlexRenew Board. Thanks to my experience in environmental advocacy, I understand the significance of this project both for our City's ecosystems and for the economic benefits a healthier Potomac River will generate. However, I'm also passionate about the less-publicized routine work of providing well-run and affordable sanitation services to our community. Operations and maintenance aren't as sensational as a massive tunnel boring machine, but those activities need robust support in order to keep our wastewater system running smoothly. If selected for this position, I would bring this enthusiasm for the nuts and bolts of utility oversight to the Board. I'd also be thrilled to serve as a messenger to the public who can communicate the great work that AlexRenew is doing. Perhaps most importantly, I would also contribute a focus on environmental and social justice that I believe is currently underrepresented on the Board. Many families across the City struggle to afford their wastewater bills, and I believe we can do more as a community to ensure that no one loses access to safe sanitation due to an inability to pay. I would appreciate the chance to help balance the Board's perspectives on environmental, social, and financial concerns and keep Alexandria the thriving, healthy community we all love.

I have worked as an attorney at the Natural Resources Defense Council since 2009. In the past five years, I have held the following titles: Staff Attorney (2014-2017), Senior Attorney (2017-2018), and currently Senior Attorney & Deputy Director of Federal Water Policy (2018-present). NRDC is a national nonprofit environmental organization. At NRDC, my duties center around federal advocacy for strong legal protections for waterways and enhanced water infrastructure funding. My goals are to ensure safe, well-functioning sanitation in all communities and affordable water and sewer bills that allow families to maintain reliable access to these essential public services. In recent years I have also engaged deeply in clean water advocacy at the regional level in the Chesapeake Bay watershed (including in Virginia and the District of Columbia). I am a legal and policy specialist in matters relating to Clean Water Act permitting, green infrastructure, stormwater pollution, combined sewer overflows (CSOs), federal water infrastructure financing, water affordability policy, and climate resilience. Over the years I have developed a strong familiarity with regulatory requirements (such as the Clean Water Act, Virginia Pollutant Discharge Elimination System permits, the Chesapeake Bay total maximum daily load, and CSO consent decrees and long-term control plans) as well as funding and financing programs (including the Clean Water State Revolving Fund and Low-Income Household Water Assistance Program) that are relevant to service on the Alexandria Renew Board of Directors. In my current role, I represent NRDC in coalitions and before legislative bodies, administrative agencies, and courts, while working in partnership with community leaders and small businesses. I testified before Congress last year about legislative proposals to promote sustainable wastewater and stormwater infrastructure, and I regularly work with local and national media outlets to bring attention to water infrastructure issues. I have published white papers and law review articles on stormwater policy, water infrastructure financing programs, and the Clean Water Act. Finally, the more administrative aspects of my work at NRDC have provided me with experience managing budgets, contracts, and consultants, which are important functions of AlexRenew Board members.
