I am the parent of three sons who attend Alexandria City Public Schools, my husband is also a product of these same schools. As a family, we have proudly used the services the City has to offer and continue to benefit from these services. Although I have only been a resident since 2002, I became a participant in the community in 1999 through work where I met my husband who has now lived here his entire 57 years. I have heard his experiences and have been able to note what has changed over the years and what has not. In 2021, I participated virtually in the Alexandria City Academy with the intention of taking some of what I learned to give back to Alexandria in a different way than I had previously done. We were encouraged to apply for Boards and Commissions. I think now would be a great time to fulfill my intention. I believe my experience will allow me to productively contribute to the Children, Youth and Families Collaborative Commission. I worked for a member of Congress for over 6 years but only indirectly supported my boss in what he could do for children and education at the federal level. I joined his campaign part time when I left my full time job to become a stay at home parent. I experienced for the first time how child care effects our entire community, with cost being personally relevant to our decision. While staying home with my children I used many playgrounds and programs around the City. We enrolled our children in the recreation department classes from sports, to swimming and art. The Soft Playroom in Chinquapin was a very big deal for us! The prices were affordable for our family and I had a flexible schedule to participate. I know many families in the City of Alexandria do not have this luxury but

deserve to also have these enriching benefits. My children attended part time preschool at Westminster Weekday Preschool where I served on the board for two years. It was a wonderful curriculum based on Conscious Discipline. Over the course of the years, I have taken the Conscious Discipline class through WWP both as a parent and as a teacher. As my children got older they attended Mount Vernon Community School. Although, we didn't use the City of Alexandria's Recreation Department after school program I was able to see the benefits it gave to our community. We continued to use recreation department programs expanding to Alexandria Soccer, Alexandria Little League and other off shoot programs for evening and weekend extracurricular activities. My husband volunteered as a coach while I focused my volunteering in the school through the PTA. I helped in the classrooms, resource room and library. As volunteer coordinator I arranged room parents and helped with the gardens. I volunteered for anything from fundraisers, to Blessings in a Backpack, to community building events like ice cream socials and pumpkin patches. Like Westminster Weekday, it was a wonderful community we were fortunate to be part of. During all this time, I worked part time on campaigns but came to the point where I felt I would enjoy working more with children. I joined the staff of St. Clement Episcopal Day School as the assistant in the Junior Kindergarten classroom where I remained for 5 years until the Covid-19 pandemic. Although I do not have a background in education, I had much to offer as a parent. St. Clement served mostly as a full day daycare, in our class we worked on getting students kindergarten ready with phonics, math play, and handwriting activities. One of the best programs we did with the kids was prepare brown bag lunches for Meade Memorial Church. I was fortunate enough to work with all ages from 2 to 5, learning so much from both the students and teachers. This time period allowed me to see better all the work teachers do for their schools with their own work life balances. I also got to see the challenges full time working parents faced. It was not a diverse program with little scholarship funding. Although, I saw it at MVCS, I further saw how the educational gap between students begins well before entering kindergarten. I wish all Alexandria students could benefit from the play and learning St. Clement offered. As my kids have aged into middle and high school, our needs have shifted but my sense of community has not changed. My kids have support at home with homework and financial support to participate in outside school sports and activities. We've dealt with the lack of after school programs for teens to keep them engaged, active and interested. I have a strong belief that if kids are active and moving, it can help keep them out of trouble, thriving both in and outside of school. Too often I see financial restraints not allowing participation for many and not allowing for development or enjoyment in recreational activities. There seems to be a drop off at middle school. I've also seen a drop off in parent voluntary involvement at this point. We now have two students in Alexandria City High School. Their experience has been very good, particularly as our country still struggles with the Covid-19 pandemic. They have definitely experience learning loss but I have faith they will get back on track with the school's support. On the extracurricular side, the high school is very large, and we are seeing the limitations of the availability of sports and arts for all who want to participate. We've noticed that if one didn't have the ability to pay for intensive training and activities at an early age there may not be a place for them in an interest of their choosing. We have been very fortunate that our children have always had wonderful teachers. We have one student with a 504, one in TAG and one in Honors/General Education. The counselors have always been so helpful in guiding our kids as best they can, even when our child is perhaps not a student most in need. Parenting is not always easy, and we are relatively involved parents. I can only imagine how difficult it is to navigate this a new American parent with language barriers. I do hope the Commission has strong representation in this regard. I would like to do as much as I can to give all parents equal footing since we are all in this together, particularly at the end in one large high school. I have volunteered with the Del Ray Citizens Association, and with the Grace Church Food Pantry and Sunday School program. Prior to the pandemic I volunteered for the Grace Church Godly Play program and will begin again this upcoming Sunday school year. It is not lost on me that I am very fortunate. I have all my family nearby for support, we own a home and we are not food insecure. My kids go into school each day knowing this and I know it is not the case for many of their peers. I would like to become a member of this committee to make that gap smaller and chip away at inequities. I want Alexandria's kids to look back on their city fondly, wanting to live here as adults giving back to the community. I would like to see programs flourish even more. It's beautiful how Alexandria has so many people from different backgrounds with different experiences. I would like to see us embrace all of it more and find ways to become closer. I think this starts with children and I would love to opportunity to support them as they grow.
