6	amended, to amend and reordain Section 12-1-4 (ELECTION OF SCHOOL BOARD
7	MEMBERS; DATE AND MANNER OF ELECTION), of Chapter 1 (SCHOOL DISTRICT
8	AND SCHOOL BOARD), Title 12 (EDUCATION, SOCIAL SERVICES AND WELFARE) of
9	The Code of the City of Alexandria, Virginia, 1981, as amended, and to amend and reordain
10	"The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting
11	Places," adopted by Section 2-2-13 (MAP OF ELECTION DISTRICTS AND VOTING
12	PLACES), of Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of
13	the City of Alexandria, Virginia, 1981, as amended.
14	
15	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
16	
17	Section 1. That Section 2-2-10 Subsection (o) of The Code of the City of Alexandria,
18 19	Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the
20	text shown in strikethrough and add the text shown in underline as follows:
21	(o) The Chinquapin Park Recreation Center Alexandria City High School Election
22	District shall be bounded and described by the census blocks shown on the map adopted
23	by section 2-2-13 of this code as comprising the said district.
24	The voting place within the Chinquapin Park Recreation Center Alexandria City High
25	School Election District shall be at the Chinquapin Park Recreation Center Alexandria City High
26	School, located at 3210 King Street. However, the temporary voting place for the district for the
27	November 8, 2016 election shall be T.C. Williams High School, located at 3330 King Street.
28	
29	Section 2. That Section 12-1-4 Subsection (c) of The Code of the City of Alexandria,
30	Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the
31	text shown in strikethrough and add the text shown in underline as follows:
32	
33	(c) The city shall be divided into three school board election districts, District A, District
34	B and District C. Three school board members shall be elected from and shall represent each
35	such district. The three districts shall be composed of the following precincts (or, as identified
36	in title 2 of this code, "election districts") located within the city, the boundaries of which are
37	described in section 2-2-10.
38	(i) District A shall be composed of the Lyles Crouch School, City Hall, Ladrey Senior
39	Building, Fire Department Headquarters, Lee Center, George Washington Middle School, Cora
40 41	Kelly – "Chick" Armstrong Center, Mt. Vernon Recreation Center, Durant Center, Charles Houston, and Potomac Yard precincts;
42	(ii) District B shall be composed of the Naomi L. Brooks_School, George Mason
43	School, Blessed Sacrament Church, Temple Beth El, Northern Virginia Community College Arts
44	Center, Charles Barrett Center, Douglas MacArthur School, Chinquapin Park Recreation Center

Alexandria City High School, Ferdinand T. Day School, AlexRenew, and James K. Polk School

precincts; and

1	(iii) District C shall be composed of the Patrick Henry Recreation Center, Samuel Tucker
2	School, Charles E. Beatley, Jr., Central Library, John Adams School, William Ramsay
3	Recreation Center, Cameron Station Community Center, Olympus Condo, and South Port
4	precincts.
5	
6	Section 3. That "The Official Map of the City of Alexandria, Virginia, Designating
7	Election Districts and Voting Places," adopted by Section 2-2-13 of The Code of the City of
8	Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained as
9	shown on Exhibit 1, attached hereto and incorporated fully by reference.
10	
11	Section 4. That this ordinance shall become effective upon the earlier of i) receipt by the
12	City Attorney's Office of a Certification of No Objection by the Office of the Attorney General
13	of Virginia, or ii) March 24, 2023, and the adjustments contained herein will be utilized for the
14	elections in 2023 and thereafter until or unless further modified and amended.
