

AFHS History

- 1992 Children's Fund established
- 1997 Community Partnership Fund established, replacing Council awarded Contributions List
- 2001 Youth Fund established for youth developmental programs grades 6-12
- 2002 Youth Fund expanded to ages 6-21, with transfer of funding for youth programs from CPF
- 2005 Administration of CPF transferred from OMB to former Dept of Human Services
- 2005 Alexandria Fund for Human Services adopted as umbrella name
- 2013 City Manager appoints Review Committee to assess the fund's grantmaking approach and issues process improvement recommendations
- 2014 City Council Review Committee recommendations to consolidate the CF, CPF and YF grant pools, implementation of an on-line application process, a multi-year grant cycle and established funding consistent with City Council endorsed strategic plans

AFHS Overview

- AFHS expands the human service delivery system through a competitive grant-making process, in recognition that the City alone cannot address all the critical needs of the community.
- AFHS funds non-profit partners in our community that are providing vital services to our residents.
- Currently in a second extended grant period, an appropriation of \$2,000,000 supports 40+ programs managed by 34 nonprofit partners.
- Current awards range from \$10,000-\$263,000+.
- Historically AFHS grants have been supplemented by grantees with \$4 \$5 million in additional funding from other sources.
- Review of grant submissions and funding recommendations have been made by committees comprised of a cross-section of members from the City human service-related boards and commissions.
- Annual award amounts are contingent upon a City Council appropriation, and articulated priorities.
- For the past 15 years the City Council's appropriation has ranged from \$1.9 to \$2.2 million, and the funding requests typically exceeds the available funds.

Reform Committee Objectives

Over the course of 5 in person sessions the Committee sought to:

- Review funding areas and priorities to determine if the AFHS competitive process is the appropriate vehicle for funding these areas and the related fiscal impact.
- ✓Review all relevant data to determine critical outcomes/impact areas and structure for future grant cycles.
- ✓ Explore mechanisms that will allow collaboration among and between community-based organizations that provide services to City residents.
- Develop a better understanding of racial and ethnic communities most impacted using prior AFHS data.
- ✓ Seek to explore ways to encourage innovation and a racial equity focus.

Survey of Current AFHS Grantees

Survey results from 68% of AFHS grantees:

- 96% reported that the application process was clear
- 74% of grantees found "Follow up after report submission" most helpful
- 89% found reporting process was "Comprehensive" and "Just Right"
- A combination of demographics such as age, gender, race/ethnicity or zip code are tracked by most respondents
- 74% leveraged additional funds as a result of the AFHS
- 63% reported the ability to expand services by collaborating with other agencies

Data Collection

Committee noted consensus on:

- Funded organizations should commit to collect and report data.
- Data collection should be relevant and reflect the work grantees are being funded to do.
- Data collection is a means to ensure focus areas of interests are being served with the Fund.
- Key elements for data collection may include; zip codes, population served, number of individuals served.

Organizational Capacity: Racial Equity

Committee Feedback

- Committee discussion centered on capacity building around Racial Equity and Diversity Equity Inclusion (DEI) as an important component for those organizations that are funded. Ultimately with the goal to make systemic changes in historically marginalized communities.
- Committee also noted that DEI elements can be woven into the fabric of the application process.

Committee Discussion

- Look to identify organizations that exemplify commitment to DEI as demonstrated by their board and staff composition, focus population, service areas, stakeholder and feedback related interventions.
- Look for organizations that are embedded in the communities they serve.
- ✓ Support capacity building with funded organizations and associate value/scoring with demonstrated commitment to advancing racial equity

Grant Proposal: Scoring Criterion

Committee Feedback:

- Ensure a transparent and clear scoring system. Make scoring criterion available to applicants.
- Provide concrete examples of what constitutes the various score range (0-100 and provide examples).
- Explicit points should be given for collaboration that strengthens community capacity and cost effectiveness and overall human service system.
- Proposed scoring criteria offered by a committee member:
 Focus population, program description (the unmet need),
 organizational governance and fiscal management,
 organizational reach and engagement of the focus population,
 efficiencies and cost effectiveness, intra-agency collaboration,
 and advancement of Racial Equity.
