2022 IN REVIEW

- The City secured \$31,316,236.10 in total federal grant funding**
- Secured \$3.25 million in earmarks** in the now-passed FY 2023 omnibus appropriations bill, including a \$1.5 million earmark sought by ALIVE!, Inc.
- Inclusion of language in the FY23 omnibus giving state and local officials more flexibility in COVID-19 relief spending.



2023 PRIORITIES & OPPORTUNITIES

- FY 2024 Appropriations Process A diversified portfolio of top tier targets
 - THUD, LLHS, Education, and CJS subcommittees for programmatic opportunities in transportation, affordable housing, mental health, higher education, and public safety
 - **Earmarks** from VA congressional delegation members
 - Sens. Kaine and Warner are accepting programmatic and earmark requests through March 10th, while Rep. Beyer will accept programmatic requests up to 2 weeks before the subcommittee deadline (TBD, along with earmark deadline)
- Key Annual Congressional Authorizations
 - Surface Transportation Reauthorization
 - Water Infrastructure Funding
 - Water Resources Development Act Reauthorization
- Federal grants A wide range of funding opportunities:
 - Flooding and storm resiliency, including BRIC funding
 - Police & fire department projects (ex., COPS, AFG)
 - Housing supply
 - Education
 - Infrastructure Bill opportunities, including transit
