The outdoor dining permit shall be valid only between <u>April-October</u> 1 and <u>March</u> <u>September</u> 340 of the following calendar year, subject to Section 6-805(O)(5), and shall be renewed on an annual basis. A permit fee, established pursuant to Section 11-104 of this ordinance, and based on the gross square feet of outdoor dining area, plus a minimum processing fee, shall be assessed annually.
39 40 41	Section 2. That the director of planning and zoning be, and hereby is, directed to record the foregoing text amendment.
41 42 43 44 45	Section 3. That Section 6-804(F), as amended pursuant to Section 1 of this ordinance, be, and the same hereby is, reordained as part of the City of Alexandria Zoning Ordinance.

1 Section 4. That this ordinance shall become effective on the date and at the time of 2 its final passage, and shall apply to all applications for land use, land development or subdivision 3 approval provided for under the City of Alexandria Zoning Ordinance which may be filed after 4 such date, and shall apply to all other facts and circumstances subject to the provisions of the 5 City of Alexandria Zoning Ordinance, except as may be provided in Article XII of the Zoning 6 Ordinance.
