After the video of George Floyd's killing by a Minneapolis police officer, it ricocheted around the web igniting perhaps one of the largest social movements this country had ever seen. Millions of people from all backgrounds flooded streets in protest, encompassing their increasing intolerance for police brutality into a three-word viral hashtag: #BLM. This change of events applied even more pressure to accelerate the need for community policing review boards on a national level. I was pleased to learn that the City of Alexandria instituted an Independent Community Policing Review Board, especially with the discourse negatively widening between the citizenry and law enforcement throughout the country. Time has demonstrated that these committees have become an essential component to restoring the needed trust. Being a long-term resident, community advocate and retired federal executive law enforcement official, I am well-positioned to leverage the facets of my life to enhance citizen oversight to assist in fostering a synergistic relationship between community and the city's police department. Ironically, during a two-year period, the duality of understanding law enforcement and community challenges were at the forefront of my daily decision making. I balanced the pressures of leading IRS-Criminal Investigation 3,000-person law enforcement agency while serving as the then-T.C. Williams High School PTSA President. By day, I oversaw some of the country's most sensitive financial crimes investigations while fulfilling congressional and regulatory obligations. This journey enhanced my political savviness while allowing further development of the acumen required to handle sensitive, confidential matters to ensure justice for all stakeholders. Additionally, my responsibilities included serving on IRS' misconduct review board which recommends employee termination for acts of willful violations of tax laws. By night, I negotiated with the most engaging and well-informed citizens regarding the challenges of a 4,000-student high school wrought with socio-economic and political impediments which thwarted the school's full potential. Furthermore, with an increasing diverse student body, I took the initiative to develop strategies to ensure inclusion among the students and parents. This also included at times, articulating these strategies and obstacles to the city council and school board. I approached these assignments whole heartly and if selected. I plan to embrace this appointment with the same level of fervor and vigor that the city deserves.
