BOARD ACTION:

BOARD ACTION: On a motion by Mr. Scott, and seconded by Mr. Lyons, the Board of Architectural Review voted to approve BAR #2023-00090. The motion carried on a vote of 6-0.

CONDITIONS OF APPROVAL:

- 1. The signs' illumination be no greater than 150 lumens and the color of the light should be warm and no greater than 3000K.
- 2. The applicant removes the four existing glass panel signs on the Strand Street elevation.
- 3. Anchors for the sign should be installed into the mortar joints on the masonry to avoid damage to the brick.
- 4. The sign must comply with the conditions provided by Zoning.

CONDITIONS OF APPROVAL:

1. That the anchors for the sign should be installed into the mortar joints of the masonry wall to avoid damage to the brick.

<u>BOARD ACTION</u>: On a motion by Mr. Scott, and seconded by Ms. Del Ninno, the Board of Architectural Review voted to approve BAR #2023-00107 and BAR #2023-00111 as amended. The motion carried on a vote of 6-0.

REASON

The Board felt that the infill area on the west elevation would look best if recessed, and that it would be best to work with staff to resolve any issues that may arise having to do with the roof and/or HVAC.

SPEAKERS

Harold Smith, project architect, gave a brief presentation and was available to answer questions.

DISCUSSION

Ms. Del Ninno asked about cooling systems, which Mr. Smith explained will be a VRF system,

noting that it will not be visible from a public right of way.

Mr. Scott asked if the lintel above the west elevation entry area to be filled in is wood. He asked if the new brick infill on the west elevation will be running or dimensional brick. It will be running. Mr. Scott suggested that the lintel be retained and the opening be recessed. Ms. Del Ninno agreed.

Mr. Adams requested a summary of the three associated buildings on the property and their ages. He noted that he likes the compatibility of the addition with the existing design.

Mr. Spencer likes the design and expressed concern about the lack of a definitive location of an HVAC unit and the possible need for roof screening and/or ductwork. He also noted that the roof height may require modifications due to insulation or other factors, and advised Mr. Smith to work with staff to resolve any of the afore-mentioned issues.

Ms. Zandian asked why there was no internal entry to the room, only an external entrance. Mr. Smith explained that it was mostly for space reasons but they also do not want to alter the historic structure too much. People don't seem to mind going in and out.

OTHER BUSINESS

Staff gave a presentation to the Board regarding a proposed amendment to the Administrative Signage Policy related to halo lit signs. The Board didn't act on the proposed amendment.

ADJOURNMENT

The Board of Architectural Review adjourned at 7:52 pm.
