Vice Mayor Jackson called the meeting to order and the City Clerk called the roll. All the members of City Council were present, with Mayor Wilson arriving following roll-call.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously, City Council convened in closed session at 5:34 p.m. to consult with legal counsel and staff pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the public body and specific legal matters requiring the provision of legal advice by legal counsel, specifically, the national Opioid litigation to which the City is a party, litigation regarding the City's environmental remediation project at Oronoco Street, and litigation regarding the City's BIPOC Small Business Grant program; pursuant to Sections 2.2-3711(A)(7) and (A)(8) of the Code of Virginia. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously, City Council reconvened in open session at 6:54 p.m. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously by roll-call vote, City Council adopted the resolution previously circulated approving of the City's participation in the proposed settlement of opioid related claims against TEVA, Allergan, Walmart, Walgreens, CVS, and their related corporate entities and directing legal counsel to execute the documents necessary to effectuate the City's participation in the settlements. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none. (RES. NO. 3135)

The resolution reads as follows:

RESOLUTION NO. 3135

A RESOLUTION OF THE ALEXANDRIA CITY COUNCIL APPROVING OF THE CITY'S PARTICIPATION IN THE PROPOSED SETTLEMENT OF OPIOID-RELATED CLAIMS AGAINST TEVA, ALLERGAN, WALMART, WALGREENS, CVS, AND THEIR RELATED CORPORATE ENTITIES, AND DIRECTING THE CITY ATTORNEY AND/OR THE CITY'S OUTSIDE COUNSEL TO EXECUTE THE DOCUMENTS NECESSARY TO EFFECTUATE THE CITY'S PARTICIPATION IN THE SETTLEMENTS

WHEREAS, the opioid epidemic that has cost thousands of human lives across the country also impacts Alexandria by adversely impacting the delivery of emergency medical, law enforcement, criminal justice, mental health and substance abuse services, and other services by Alexandria's various departments and agencies; and

WHEREAS, Alexandria has been required and will continue to be required to allocate substantial taxpayer dollars, resources, staff energy and time to address the damage the opioid epidemic has caused and continues to cause the citizens of Alexandria; and

WHEREAS, Alexandria has filed suit against Teva, Allergan, Walmart, Walgreens, CVS, and certain of their related corporate entities for their role in the distribution, manufacture, and sale of the pharmaceutical opioid products that have fueled the opioid epidemic that has harmed Alexandria; and

WHEREAS, the City's suit seeks recovery of the public funds previously expended and to be expended in the future to abate the consequences and harms of the opioid epidemic; and

WHEREAS, settlement proposals have been negotiated that will cause Teva, Allergan, Walmart, Walgreens, and CVS to pay billions of dollars nationwide to resolve opioid-related claims against them; and

WHEREAS, the City has approved and adopted the Virginia Opioid Abatement Fund and Settlement Allocation Memorandum of Understanding (the "Virginia MOU"), and affirms that these pending settlements with Teva, Allergan, Walmart, CVS, and Walgreens shall be considered "Settlements" that are subject to the Virginia MOU, and shall be administered and allocated in the same manner as the opioid settlements entered into previously with the Distributors and Janssen; and

WHEREAS, the City's outside opioid litigation counsel has recommended that the City participate in the settlements in order to recover its share of the funds that the settlement would provide; and

WHEREAS, the City Attorney has reviewed the available information about the proposed settlements and concurs with the recommendation of outside counsel;

NOW THEREFORE BE IT RESOLVED that the Alexandria City Council, approves of the City's participation in the proposed settlement of opioid-related claims against Teva, Allergan, Walmart, Walgreens, CVS, and their related corporate entities, and directs the City Attorney and/or the City's outside counsel to execute the documents necessary to effectuate the City's participation in the settlements, including the required release of claims against settling entities.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman

Chapman and carried unanimously, City Council authorized the City Attorney to enter into a consent judgment for the reasons and under the terms discussed in closed session to resolve the litigation captioned Tridentis, LLC v. City of Alexandria. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously by roll-call vote, City Council adopted the resolution regarding the closed executive session previously circulated to Council. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none. (RES. WHEREUPON, upon motion by Councilman Chapman, seconded by Councilman Aguirre and carried unanimously, the annual stockholder's meeting of the Alexandria

Transit Company was adjourned at 7:23 p.m. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

***Northern Virginia Transportation Commission (NVTC)(Councilman Aguirre and Councilmember Bagley)**

Councilmember Bagley reported that the Commission recognized the WMATA employee killed during a shooting one of its stations. Councilmember Bagley reported that there was discussion about the upcoming Commuter Choice applications for the upcoming year. Councilmember Bagley reported that there was discussion about the upcoming Zero Emissions Bus Study that will be forthcoming.

***Alexandria Campaign on Adolescent Pregnancy (ACAP) (Councilman Aguirre and Councilmember Bagley)**

Councilman Aguirre reported that ACAP received a presentation about STIs in the community, they received a policy update and the body discussed potentially adding another member to leadership team and restarting some of the subcommittees.

***Commission on Aging (Councilman Aguirre)**

Councilman Aguirre reported that Commission toured the DASH facility and received a presentation from DASH and their services. Councilman Aguirre reported that there was a presentation from ARHA on the Samuel Madden project and preparation for relocation for residents moving from Ladrey.

***Children Youth and Families Collaborative Commission (CYFCC)(Councilwoman Gaskins and Councilmember Bagley)**

Councilmember Bagley reported that Commission received a presentation on the ACPS budgeting process. Councilmember Bagley reported that the Commission reviewed goal groups and focused on mental health issues for youths.

***Northern Virginia Regional Commission (NVRC)(Councilwoman Gaskins and Councilman Chapman)**

Councilwoman Gaskins reported that NVRC will be hosting a litter-monitoring webinar on March 22, highlighting tracking litter in the Anacostia River Watershed. Councilwoman Gaskins reported that on March 15 there will be a trails webinar focusing on the 2022 Corridor Analysis of the Northern Virginia Section of the Potomac Heritage National Scenic Trail. Councilwoman Gaskins noted that there was a blog updated on how to fight climate change at home on the NVRC website. Councilman Chapman noted that there was new, updated economic data posted on the NVRC Dashboard to see how the regional is faring economically. Councilman Chapman reported that NVRC won a grant for expanding the network for stream gauges throughout the region.

***Alexandria Health Partners (Inova Alexandria Hospital Task Force) (Councilwoman Gaskins and Councilman Aguirre)**

Councilwoman Gaskins reported Inova updated the group on their Dream Big initiative targeting middle school and high school students interested in careers in the healthcare field, particularly with entry level positions. Councilwoman Gaskins noted that Inova will entering into a partnership with the City's Workforce Development Center to fill some much needed positions. Councilwoman Gaskins reported that there was an update on the Oakville Triangle site. Councilwoman Gaskins reported that there was an update from DCHS on the move to the West End. Councilwoman Gaskins reported that the State will be awarding \$500,000 for opioid prevention as it relates to youth.

***COG Board of Directors (Mayor Wilson)**

Mayor Wilson reported that COG has released the Regional Fair Housing Plan on the website to receive public comments and there will be three public meetings to receive comment from the community.
