Councilmember Bagley noted that there was discussion about the Commuter Choice program, particularly the projects for 395 submitted by Alexandria.

Councilwoman Gaskins reported that the Committee met to review the proposed scope of work for the project for renaming streets throughout the City. Councilwoman Gaskins reported that the Committee reviewed the steps in the process and community engagement for the process and how the public can be part of the process.

# \*Children, Youth and Families Collaborative Commission (Councilmember Bagley and Councilwoman Gaskins)

Councilmember Bagley reported that the Commission focused on the proposed budget and the need for more mental health resources. Councilmember Bagley also reported the Commission discussed the role of youth on the board and how to encourage their participation on City Boards and Commissions.

Vice Mayor Jackson gave an update on the construction at MacArthur Elementary school and noted that there will be virtual community meeting on March 28.

Mayor Wilson reported that he presented to the Board on the City's use of the equity emphasis areas and he discussed how it has been used across many departments including Planning and Zoning, Housing, and capital projects. Mayor Wilson thanked Hillary Orr, Transportation and Environmental Services, for helping with the presentation.

## \*Northern Virginia Transportation Authority (Mayor Wilson)

Mayor Wilson reported that Josh Baker from DASH gave a presentation about the City's fare free program along with OmniRide about their program. Mayor Wilson reported on the regional fund budget for a study on regional bus rapid transit, noting that there is about \$500 billion dollars for BRT systems funding five different projects, including two in the City of Alexandria.

26. Introduction. Consideration. Passage on First Reading of an Ordinance on the

Proposed Real and Personal Property Tax Rates and Proposed Effective Tax Rate Increase for Calendar Year 2023 (Fiscal Year 2024).

(A copy of the City Manager's memorandum dated March 7, 2023, is on file in the Office of the City Clerk and Clerk of Council, marked Item No. 26; 03/14/23, and is incorporated as part of this record by reference.

A copy of the informal memorandum explaining the ordinance is on file in the Office of the City Clerk and Clerk of Council, marked Item No. 26; 03/14/23, and is incorporated as part of this record by reference.

A copy of the ordinance referred to in the above item, of which each member of Council received a copy not less than 24 hours before said introduction, is on file in the Office of the City Clerk and Clerk of Council, marked Item No. 26; 03/14/23 and is incorporated as part of this record by reference.)

A motion was made by Councilman Chapman, seconded by Councilman Aguirre, to establish the tax rates to be advertised for residential and commercial real property and personal property.

The maximum rates in the ordinance reflect:

A base real estate tax rate on residential, commercial, and industrial property for calendar year 2023 of \$1.12.5 (1 cent and ½) per one hundred dollars of assessed valuation. The FY2024 proposed budget reflects a real estate tax rate of \$1.11. Also included in the FY 2024 Proposed Operating budget is an alternative option with a one cent increase.

- 1. Assumed in this proposed amount is the continued dedication of 1.0 cents for affordable housing;
- 2. Assumed in the proposed amount is the continued reservation of 2.2 cents of the real property tax rate for transportation projects;
- 3. A Special Services District tax is proposed to continue to be levied on all real property located in the Tier I Potomac Yard Metrorail Station Special Services District at the current rate of \$0.20 per one hundred dollars of valuation;

For all other taxes, the following rates are proposed:

- 4. A personal property tax rate on vehicles for calendar year 2023 of \$5.33 per one hundred dollars of assessed value. The FY 2024 proposed budget recommends a vehicle personal property tax rate of \$5.33 to fund the base budget; and
- 5. A tangible business personal property tax rate for calendar year 2023 of \$4.75 per one hundred dollars of assessed value and a machinery and tools tax rate of \$4.50 per hundred dollars of assessed value. The FY 2024 proposed budget recommends a tangible personal property tax rate of \$4.75 and a machinery and tools tax rate of \$4.50 to fund the base budget.

WHEREUPON, a substitute motion was made by Councilwoman Gaskins, seconded by

Vice Mayor Jackson and carried 5-2, to establish the maximum rated authorized by City Council to reflect a 1 cent increase for the tax rates to be advertised for residential and commercial real property and personal property. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilmember Bagley, Councilwoman Gaskins, and Councilman McPike; Opposed, Councilman Aguirre and Councilman Chapman. The substitute motion became the main motion.

**WHEREUPON**, upon motion Councilwoman Gaskins, seconded by Vice Mayor Jackson and carried 5-2, City Council passed the proposed ordinance on first reading after establishing the tax rates to be advertised for residential and commercial real property and personal property.

The maximum rates authorized by City Council in the ordinance reflect:

A base real estate tax rate on residential, commercial and industrial property for calendar year 2023 of \$1.12 per one hundred dollars of assessed valuation. The FY2024 proposed budget reflects a real estate tax rate of \$1.11. Also included in the FY 2024 Proposed Operating budget is an alternative option with a one cent increase.

- 1. Assumed in this proposed amount is the continued dedication of 1.0 cents for affordable housing;
- 2. Assumed in the proposed amount is the continued reservation of 2.2 cents of the real property tax rate for transportation projects;
- 3. A Special Services District tax is proposed to continue to be levied on all real property located in the Tier I Potomac Yard Metrorail Station Special Services District at the current rate of \$0.20 per one hundred dollars of valuation;

For all other taxes, the following rates are proposed:

- 5. Councilman McPike thanked everyone involved in the St. Patrick's Day Parade.
- 6. Councilman McPike thanked everyone who came to speak at the Budget Public Hearing.
- 7. Councilman McPike thanked City staff and Councilmember Bagley for assisting him while he is on travel this week, enabling him to participate remotely in Council meetings.
- 8. Councilmember Bagley reported that members attended the ALIVE! Impact Briefing earlier in the week highlighting their impact on the community and the needs of the community.
- 9. Councilmember Bagley reported that she had a meeting with the stakeholders in the redevelopment and revitalization of the King Street/Commonwealth Bridge site through community walk to survey the site and explore possible changes.
- 10. Councilmember Bagley commended everyone involved in the planning and execution of the service for Deputy Fire Chief Brian Hricik.
- 11. Vice Mayor Jackson noted that she and Mayor Wilson participated in Career Day at MacArthur Elementary School and the children enjoyed hearing about local government.
- 12. Vice Mayor Jackson recognized the All City Schools Artists who were recognized at the Torpedo Factory on Friday with a reception.
- 13. Vice Mayor Jackson stated that the City is hosting an expungement clinic in the West End at the Mark Center Hilton on March 25 from 10 am until 1 pm.
- 14. Councilman Aguirre noted that the City is offering tax preparation services for the community.
