Over the past decade I have become very familiar with the life challenges facing persons with disabilities, as I have a 14-year-old daughter and an uncle (now deceased) with Fragile X Syndrome. I experience these challenges with the context of also having a 17-year-old neurotypical daughter, so the differences in how every life experience plays out for each of my children are starkly contrasted for our family every day. Through advocating for my younger daughter and my uncle (who worked for the USPS in Alexandria for 40 years!), I have become passionate about finding ways to improve inclusion in our communities, starting with compassion and understanding; I have also learned the power of community and how it truly "takes a village" of families and caregivers of children and adults with disabilities to help one another navigate systems and resources in order to provide an acceptable quality of life for our family members. At Maury (now Brooks) elementary school, I founded the Special Ed Parent Network to provide a space for parents to come together to discuss and problem solve issues related to their children's IEPs and school experiences, to advocate for and support teachers in differentiated learning, and to plan events to increase student's, parent's, and staff's understanding of people with disabilities (especially invisible disabilities like ADHD and dyslexia). For example, one year during Special Education Awareness month (October), we developed a series of short bios of famous people with disabilities, which were read each morning on the announcements.
