All he wants is to make the house look better. Ms. del Nino said that probably the mortar wasn't clean properly when the renovation took place and that the new mortar looks wider than the original as well.

Mr. Scott asked Mr. Conkey to explain the limewash treatment. Mr. Conkey explained that limewash, also known as whitewash, is a process where lime is grounded and mixed with water to give a patina look. The limewash treatment is reversable. Stain is pigmentation, which is not reversable, however, it is better than painting since it allows the brick to breath, and it does not cover the brick texture.

Mr. Spencer stated that he prefers the stain treatment since this property was modernized and limewash would look awkward since the treatment is mostly used to give an old look to buildings. There was no further discussion.
