

## **STAFF RECOMMENDATION**

Staff recommends approval of the Certificate of Appropriateness as submitted.

#### GENERAL NOTES TO THE APPLICANT

- 1. APPEAL OF DECISION: In accordance with the Zoning Ordinance, if the Board of Architectural Review denies or approves an application in whole or in part, the applicant or opponent may appeal the Board's decision to City Council on or before 14 days after the decision of the Board.
- 2. COMPLIANCE WITH BAR POLICIES: All materials must comply with the BAR's adopted policies unless otherwise specifically approved.
- 3. BUILDING PERMITS: Most projects approved by the Board of Architectural Review require the issuance of one or more construction permits by Department of Code Administration (<u>including signs</u>). The applicant is responsible for obtaining all necessary construction permits after receiving Board of Architectural Review approval. Contact Code Administration, Permit Center, 4850 Mark Center Drive, Suite 2015, 703-746-4200 for further information.
- 4. ISSUANCE OF CERTIFICATES OF APPROPRIATENESS AND PERMITS TO DEMOLISH: Applicants must obtain a copy of the Certificate of Appropriateness or Permit to Demolish PRIOR to applying for a building permit. - 5. EXPIRATION OF APPROVALS NOTE: In accordance with Sections 10-106(B), 10-206(B) and 10-307 of the Zoning Ordinance, any Board of Architectural Review approval will expire 12 months from the date of issuance if the work is not commenced and diligently and substantially pursued by the end of that 12-month period.
- 6. HISTORIC PROPERTY TAX CREDITS: Applicants performing extensive, certified rehabilitations of historic properties may separately be eligible for state and/or federal tax credits. Consult with the <u>Virginia Department of Historic Resources (VDHR)</u> prior to initiating any work to determine whether the proposed project may qualify for such credits.



## I. <u>APPLICANT'S PROPOSAL</u>

The applicant requests a Certificate of Appropriateness to add a roof deck to the rear two-story ell, at 309 Duke Street.

## Site context




Figure 2: E elevation. The blue is tarp on the southernmost portion of the rear ell; the roof deck will be beyond this.

The alley to the east, adjacent to the property, and the alley to the north, behind the subject property, are both private. Another alley which runs north/south on the west side of 311 Duke is also private. Therefore, only a small portion of the proposed addition will be visible from a public right of way. See Figures 1 and 2.

## II. <u>HISTORY</u>

Based on historic maps, 309 Duke was constructed at some point between **1877 and 1885**. It does not appear on the 1877 G.M. Hopkins Atlas of Alexandria, VA and it does appear on the 1885 Sanborn Fire Insurance Map. This Sanborn Map depicts it as a two-story brick dwelling with a rear two-story brick ell and slate or metal roofing, but by the time of the publication of the 1902 Sanborn map, the house has a three-story main block, a two-story rear ell, and two small rear additions. The proposed deck will be constructed on the two-story rear ell.

In December of 2023, the east elevation of the rear ell completely collapsed and permit BLDR2023-01236 was issued for emergency shoring and select demolition to make the building safe.

## Previous BAR Approvals

- July 3, 2024, BAR2024-00218: Approval to replace a collapsed masonry wall with a wood frame wall with fiber cement siding and trim.
- April 7, 1994, BAR 94-32: Approval to demolish a porch façade and the construction of a new exterior wall.
- September 6, 1972, Permit #29418: Hammer down standing seams in existing tin roof. Apply new built up roof over existing. Surface with flood coat of hot asphalt. Apply black 240# shingles on rear porch roof; remove old tin roof. New copper gutters and downspouts. Staff notes that while this is not a BAR approval, it indicates important changes to the building. Staff found no record of BAR approval for this work.

## III. ANALYSIS

## Certificate of Appropriateness

The *Design Guidelines* state that "Roof decks should be constructed so that they do not interfere with the historic roofline of a building." In this case, the roof deck will not at all interfere with the roofline. Instead, the proposed deck respects the historic roof, as it will be a floating deck on pedestals located above, but not resting on, the existing roof. Therefore, there is no encapsulation or demolition involved in the project. The 36" high metal guardrails comply with USBC regulations and the *Design Guidelines*, and the Trex composite decking is an appropriate material.

Staff therefore recommends approval of the Certificate of Appropriateness, as submitted.

### **Zoning**

- C-1 The applicant shall comply with the City of Alexandria's Solid Waste Control, Title 5, Chapter 1, which sets forth the requirements for the recycling of materials (Sec. 5-1-99). (T&ES)
- C-2 The applicant shall comply with the City of Alexandria's Noise Control Code, Title 11, Chapter 5, which sets the maximum permissible noise level as measured at the property line. (T&ES)
- C-3 Roof, surface and sub-surface drains be connected to the public storm sewer system, if available, by continuous underground pipe. Where storm sewer is not available applicant must provide a design to mitigate impact of stormwater drainage onto adjacent properties and to the satisfaction of the Director of Transportation & Environmental Services. 


