Lighted Tennis Courts at T.C. Williams - Yes

I'm here this morning to ask the council to override the no-lights amendment put forth by the planning commission at last week's hearing. At that meeting, there were many who clearly described the pressing need for the TC Williams team to have tennis courts, but the user community at large were underrepresented. I therefore would offer my own point of view on the matter.

I've been an Alexandria resident for the past 15 years and have logged thousands of hours on the city's public tennis courts and quite a few hours on the courts of Fairfax and DC. I have two standing matches per week and typically squeeze in a couple sessions on top of that.

At last week's planning commission meeting, those opposing the inclusion of lights in this project characterized tennis in Alexandria as a dying pass-time. They argued that any enhancement bringing value to the non-TC community would not be worth the tax dollars. They had just the other night seen that nobody at all was playing at the Minnie Howard courts...during a cold snap...in December. I would like tell the folks here today that tennis in Alexandria is, in fact, alive and well.

Alexandria officially has 36 tennis courts spread over 16 locations, most sites having only one or two courts with only Chinquapin and Old Town having four. Of these 36 courts, 21 are lighted. I frequent those courts which are in my half of town....Montgomery Park (old town), Simpson Park, Mount Vernon Rec, and Ft Ward Park. Minnie Howard is not in this list because, as any of the local hacks will tell you, the balls do not bounce on them (but this is a separate issue), and I usually avoid Chinquapin as there is an hourly use fee. All of these courts see heavy use during the warmer months, April through October. During the daytime in the summer, my son, who is also on the TC team, and I play and train at Simpson Park just a few blocks from home. There, typically at least one of the two courts in use when we arrive and oftentimes both are taken and we have to divert to one of the nearby drivable sites. Sometimes we have to reroute twice to find an empty court.

Frequently, especially during school days, we play in the evenings. The closest, and largest, lighted facility in the city is old town with four courts. There we can always expect to wait 30 minutes to an hour to play and usually wind up playing doubles just so others won't have to wait. That's a significant overhead for students and absorb during the school year with high class loads. During the week, working people often can't begin their regular exercise until dusk, so it's not surprising that lighted facilities are so heavily used at those times. The situation will only get worse when all 1400 new housing units are completed at Potomac Yard which will rapidly exhaust the capacity of the two new courts being built to support them.

Tennis networks and communities flourish where a large number of courts exist in one spot because it's likely that, if you show up, there will actually be a court available, and because there is a good chance of getting a pickup game. Most of my current hitting partners were discovered at old town, Hains Point, and other larger facilities even though most of my hours are logged at locations where only two courts exist.

The six lighted courts at the TC site, would become the largest collection of courts in the city. That would relieve some of the pressure from those perpetually overbooked parks, and provide Alexandria residents and non-residents alike with a valuable public space where they can enjoy each other, get much needed exercise, and participate in one of the great lifetime sports.

Finally, I would like to make one final observation regarding this process. At last week's planning commission meeting ALL parties present were in strong support of TC getting tennis courts and ALL parties present agreed that the new lights would have no negative impacts.

The primary argument repeatedly offered against the inclusion of lights was that this would embolden some other folks, at some future date, to pursue approval for lighting at some other facility, at some other location on the TC campus, specifically, the football stadium.

Any plan should be judged on its own merits and not against some possible future plan which will no doubt have its own, very different, merits and issues.

On December 10th, the Seminary Hill Association, Inc., of which I am President, unanimously passed a resolution—and I quote—"In accord with Seminary Civic Association, Seminary Hill Association, Inc., supports the construction of school tennis courts on the T. C. Williams campus and supports the continuation of the prohibition of lighting on any athletic fields, such as tennis courts and the football stadium." End quote.

As many of you know, SHA is an umbrella organization that represents nine neighborhoods on Seminary Hill. Seminary Civic Association is one of these nine—known as Area 1 in SHA and you will hear from at least one of their members today. Unfortunately, the President of Seminary Civic—Francis Terrell—and a chair of the Fort Ward and Seminary African American Descendants Society— Adrienne Washington—cannot be here today because, just a few weeks ago, the City scheduled a meeting for them to review the "draft report" prepared by the City's consultant of their ancestral history.

As a former history teacher, I must note that Seminary Civic Association represents an historic community with families that settled in Area 1 of SHA and near Fort Ward during the Civil War. In the 1920s this community built the Seminary School on the T. C. Williams site. In the 1960s, the City of Alexandria moved the Hill community off their land to make way for Fort Ward Park and then in the 1970s some were moved again to make way for T. C. Williams High School.

The agreement to NOT light the school's playing fields dates back about 40 years because the football stadium is so close to residential properties. When the school was rebuilt in 2004, citizens suggested relocating the football stadium to King Street—where the tennis courts are now proposed—but the City did not wish to do so. Instead, the City offered to formalize the long-standing agreement prohibiting lights on the playing fields and thus to protect the quality of life in the single-family residential neighborhood adjacent to the school that had gone through so many upheavals since being annexed by the City of Alexandria in 1952.

Seminary Hill residents do not trust the ACPS or staff to work with them to resolve problems.

- In the 1970s, Alexandria's leaders labeled this neighborhood with a derogatory name to gain public approval for "urban renewal" to take the land on which T. C. was built.
- The City promised berms and screening promised but we are still waiting.
- The ACPS is rarely available to meet with the T. C. Williams Community Advisory Committee, which was created by the Planning Commission to resolve issues like these—and the School Board doesn't even know the Committee exists.
- The ACPS has never made promised improvements to the sound system, such as relocating the speakers so they face the school rather than away from the building and blaring at the neighbors.
- The ACPS never consulted the community about a location for the large metal scoreboard at the stadium and placed it at the edge of their properties for them to "enjoy" whenever they were in their back yards.
- Most recently City staff for over 5 months has never answered our questions about the planned lighting, and even today has no answers only a recommendation in the staff report that a detailed lighting plan be created.

Is it any wonder that we rely on this DSUP to protect us from a clueless neighbor that is disrespectful, unresponsive, and will destroy the quality of life in our homes?

Yes a deal is a deal.

This proposal before you to amend the DSUP and allow lights on the new tennis courts will betray an agreement with a community that has suffered enough. Please honor your deal and do NOT approve lighting on these courts.

In conclusion, Seminary Hill Association supports the students and the construction of their courts but NOT the lights that the students don't need, that the ACPS has not funded, and that would break your long-standing deal with our community.



Dear Mayor Euille and Members of City Council,

I am writing to urge you to DENY the request for lights at the proposed TC Williams tennis courts. I regret that I am not able to attend today's public hearing to testify in public on this issue.





For the past 18 months, the Alexandria City Public School (ACPS) staff has been partnering with the Alexandria City staff to develop the plans for new tennis courts at T.C. Williams. Tennis courts at T.C. Williams have been a topic of discussion by citizens, students and the Board for several years.

The Alexandria City School Board approved the tennis court plans on November 19, 2012 which included a feasibility study for lighting. In the following months, ACPS staff conducted the study and hosted community forums in the Seminary Hill area and with the TC Williams school community. On June 20, 2013, the School Board approved the updated plans that include the lighting.

The current proposed layout presents two banks of three fenced-in courts with access gates for security purposes. The site's lighting is currently included in the project design. When these courts are built, they will be the only courts in the city equipped to host tennis league play at a single location. The Alexandria City School Board's June 20' 2013 plan approval included building the conduits for lighting, even though the budget climate precludes funding lighting for the courts currently.

Installing lighting conduits at the time of construction, instead of in the future, prevents deconstructing the courts to set the lighting and having to restore the courts to playing condition. This not only provides cost efficiency, but also allows for the shortest downtime for the asset.

For large recreation projects, like the tennis courts and fields, the City of Alexandria must maximize its investments for the citizens as a whole, including our student athletes. While focus has been placed on the T.C. Williams Tennis Team using the courts, these courts will be available to the city residents who are tennis players up to 75% of the possible weekday hours during tennis season and *all of hours on the weekends*.

Without lights, the citizens would only be able to access the courts 53% of the possible hours during the weekdays and 20% less time on the weekends. Additionally, our tennis team would not finish matches that go into long tiebreakers during day light savings time.

At this time, we are asking the city to consider two things:

• Approve the original request for DSUP2013-0014. This recommendation was made by City staff and the ACPS staff. Please vote to approve the tennis court plans, with lighting, in order to serve the citizens of Alexandria City and the T.C. Williams high school tennis team.

The Alexandria City School Board does not discriminate on the basis of race, color, national origin, sex, disability, age, religion, sexual orientation, marital status, status as a parent, or pregnancy in its programs and activities. Please direct all inquiries regarding ACPS non-discrimination policies to the Chief Human Resources Officer, 2000 N. Beauregard St., Alexandria, VA 22311, 703-824-6657.

• Engage in future dialogue to changing the DSUP2002-0044 language. The Alexandria City School Board asks that you consider changing the language that states that no permanent stadium lighting shall be installed at the T.C. Williams stadium or on any other athletic field on school property. Student athletes no longer compete in the daylight hours alone.

We appreciate your commitment to advancing our great city and we thank you for the time commitment you make on behalf of our citizens. We hope that you will agree that planning for lights on public fields maximizes the benefit for our entire community.

Letter in support of lights at the T.C. Tennis Courts

I am writing to support the inclusion of lights in the plans to construct tennis courts next to the parking garage at T.C. Williams. This morning the focus is on lights at the tennis courts but let's not pretend it is really **just** about the tennis courts. The neighbors fear this will set a precedent for lights at the Parker-Grey Memorial Stadium. By the way, the font size of those words **PARKER GREY MEMORIAL STADIUM** on the side of the press box was actually a topic of discussion at one of the quarterly meet and confers with the neighbors.

Now, as we all know, there are no lights at the stadium but that has not stopped them from dictating other aspects of our programming at that facility. At another meeting, we were instructed to buy a set of two way radios, one would be kept in the home of a neighbor and one would be kept in the press box so they could call us during an event to let us know if we needed to turn down the volume.

At our neighboring schools, with stadiums right up against housing developments there are sound effects emanating from the press box to celebrate first downs, video boards highlighting player accomplishments and sponsors and most importantly large numbers of peaceful and enthusiastic fans cheering on their teams during the day and **EVEN** at night. At TC we get complaints if we hang a banner for Jack Taylor Toyota, for all he and folks like Donnie Simpson do for our school it is the very LEAST we can do and yet it is a problem here.

Tennis players beware, do not call **OUT** or **FAULT** too loudly or you may be subject to a noise complaint, not from the church right next to the courts but from a neighboring street on the other side of the campus. If that sounds like a joke I have to again refer you to a neighborhood meeting where the volume of the football coach's whistle and even their **VOICE** was seriously discussed.

Why is everything so contentious when it comes to the basic rights of a school that serves more than 3,000 of Alexandria's citizens? Lights at the tennis courts that borders a lighted, multi-story parking garage on one side, the lighted front entrance of the school on one end, a lighted and busy King street on the other side and lighted church parking lot on the other end? How is this even a serious issue unless their motivation is about something else entirely? Do you really think the "neighbors" who came out in opposition to lights at Hammond all lived on Pegram street? Check the record, at yet another one of these T.C. community meetings they made sure to let us know they spoke at the public hearing at Hammond.

I **fully** support every citizen's right to express their opinion but I do not support the ability of a few to determine how we run a public school that serves thousands of its citizens. **Please allow us to include lights with our new tennis courts.**





We, the undersigned residents of the neighborhoods adjacent to TC Williams High School, respectfully ask City Council to deny the proposed amendment, 2013-0014, to the DSUP to allow lighting on tennis courts on the TC Williams campus. We negotiated in good faith with the Alexandria school system in 2004 about issues of noise and lighting resulting from their desire to rebuild the high school on its very tight site in a residential area. The result of these discussions was Site Condition #85 that states, "no permanent lighting shall be installed at the School stadium or any other athletic fields, including the proposed new practice field." The proposed tennis courts sit on the exact location of that "new practice field" and, as such, are very specifically included in the lighting prohibition. The issue to us, therefore, is not about foot-candles or design changes for these lights. The issue is quite simply a matter of trust and respecting the reasons why this prohibition was codified when the new high school was built. Nothing has changed since that construction took place, which almost doubled the size of the school building and intensified use of the fields that ring the outer edges of the campus next to nearby neighborhoods. The proposed tennis courts sit on a field subject to the lighting prohibition and school officials were quite aware of this fact as they began planning for these courts, though some current School Board members now seem to question the existence of this written condition to the DSUP.

The TC Williams Community Advisory Committee (which was also established as part of the conditions to the DSUP in 2004) had two meetings with TC staff in 2012 when the proposal for 6 tennis courts was discussed. At both of these meetings, in response to questions about possible lighting of the courts, committee members were unequivocally told by the Athletic Director and the tennis coach that TC Williams did not plan to place lights on these tennis courts as they were NOT necessary for tennis team practices, matches, and tournaments. School officials stated they were aware of the prohibition against lights and would respect that. The Committee had no objections to the unlit tennis courts and expressed a preference for the King Street location.

It was, therefore, a shock to learn at the June 27, 2013 and subsequent September 23, 2013 Design Information Sessions for the Community that lights had been added to this project, despite the fact that school officials had made it clear to us that the tennis program did not need lights. At both of these meetings, residents asked to see the exact language being proposed and questioned why the school system was now seeking to undo the written agreement. We were told that the amendment language and staff report were not available and therefore no discussions could take place relating to those issues. Staff was only there to discuss the design elements of the project, not to discuss the SUP issues. Despite the objections to lights expressed at these meetings, there was no further communication from school or Planning staff to our neighborhoods about the intention to amend the SUP. So we were left to wait until November 22nd when the staff report was finally released to learn what the exact amendment language was and why this change was made against the wishes our neighborhoods. At the Planning Commission meeting on December 3rd, we learned from Mr. Finn, ACPS Director of Educational Facilities, that

conversations with the Department of Recreation, Parks, and Cultural Activities brought about this change because the Rec Department wanted to light these courts for public uses, despite the very clear written prohibition against lights on the TC Williams campus. Since the Rec Department was not the original DSUP applicant, they could not apply for this change, so they convinced the school system to change the proposal to include lights and seek to amend Condition #85.

If the Rec Department and the City want to provide 6 lit courts for the tennis team and the public, why was no consideration given to placing these courts within the Chinquapin Park boundaries where lighting is permitted instead of placing them in an area that violates the DSUP? The staff report indicates that the 4 lit courts in Chinquapin may be removed in order to build an Aquatics Center in that location. If the planning for Chinquapin Park is this far along, why didn't the Rec Department and the school system find a place for these courts in that new park design and go ahead with plans to construct those courts now in a location that is not subject to this lighting prohibition? In addition, the school is losing a practice field on its campus in order to construct these courts when other land in the park might have been used. It seems to us that no consideration was given to this agreement being in place or any desire to protect it by either the schools of the Rec Department. Since we had no conversations with either Planning or the school about this, we were never able to suggest alternatives for their consideration.

We question whether any studies have been done to demonstrate the need for additional lighted tennis courts, as existing nearby courts appear to be unused much of the time. If there is such a demonstrated need, we would suggest that the Department of Recreation, Parks, and Cultural Activities select an alternative location on the land it owns throughout the city that is not governed by a DSUP prohibition. In an era of tight budgets, it doesn't seem prudent for the school system to advocate spending several hundred thousands of dollars for lights that its team doesn't actually need to be successful.

We are aware that since the Planning Commission vote to deny the amendment for lights, efforts are being made to convince Council that these lights are now needed for school use. References have been about safety issues while students wait to be picked up from matches or try to finish long matches in waning light. We would like to respectfully remind Council that now these tennis courts will be located on the TC Williams campus. There will be no time-consuming travel to distant public courts so that matches that require 6 courts can be held. Students will walk out of the school and onto their own 6 courts. They will no longer lose educational time to be transported to off site courts for practices or home matches. Matches will not be split between two sites, as was necessary in the past. As the tennis coach and the Athletic Director stated to us, the tennis team does NOT require lights and to assert that now is simply not accurate. We note that only one other high school that TC Williams competes with has any lit tennis courts, so other school systems have not seen this as an obstacle to team practices and matches. The team will gain playing

time now with the construction of these on-campus courts and will be picked up after matches on their own well-lit school campus.

We believe the desire to modify Condition #85 in this one instance opens the door to others who will seek to light other areas of the TC Williams campus that will have significant and extremely adverse impacts on our homes and quality of life. The fair and reasonable agreement reached in 2004 recognized the need for permanent protection for our neighborhoods. There is simply no valid reason to break this agreement and make this substantive change to the DSUP. We therefore ask the City Council to uphold the decision made by the Planning Commission on December 3rd to uphold Condition #85 and deny the application for an amendment to allow lights on tennis courts at TC Williams. We fully support the construction of the 6 new unlit courts for the tennis team at TC Williams, which will be available for public use at times when the tennis team does not need them.

Dear Mayor Euille and City Council Members:

I am writing to you on behalf of the Park and Recreation Commission to express our support for the DSUP sought by the Alexandria City Public Schools (ACPS) to construct six lighted tennis courts on ACPS property between the existing parking structure and King Street.

Staff from Planning and Zoning briefed the Park & Recreation Commission several times over the course of the project's development. In addition several of our members participated in public meetings on the tennis courts held by ACPS. We feel the project modifications incorporated in the final design presented adequately addresses concerns heard at these meetings from nearby property owners. These adjustments primarily address potential noise issues and light effects. The Park & Recreation Commission strongly supports the inclusion of lights with this project and feel it would be akin to constructing the Chinquapin pool a bit too short if they were not approved and constructed with this project. We will regret it when it is discovered the lack of lighting impacts the TC tennis program as well as broader community uses.

The concerns about noise and lights which inevitably accompanies recreational activities will always be voiced for new projects planned in the City. We must remember, however, that field and court lighting has come a very long way and that the new generation of lights here and in other recreational locations are designed to meet LEED green certification and "dark sky" standards. There is no longer light spillover into neighboring properties. For this project the height of the lights has been adjusted, landforms and landscaping have been designed to mitigate potential noise from competition.

This project needs the lights if the TC Williams team is to operate in a top tier tennis facility -- the goal of the ACPS Board and the parents of tennis team members. If lights are not included it will compromise practice and meets both early in the spring season and late in the fall. Examples of the impacts of no lights were given at the public meetings by parents who indicated they have been at meets when the competition was "called" short because of darkness.

In addition, any investment of money or scarce land that we, the citizens of Alexandria, make in recreational facilities whether primarily for ACPS use or City recreational uses, must try to assure that the investment addresses both needs. We do not have enough land or money to do otherwise. In considering this DSUP we need to look toward accommodating both current and future needs -- a future where we are rapidly adding more residents but not more large pieces of land that can be dedicated to active recreational uses. In summary, the Park & Recreation Commission fully supports this project to construct six competition tennis courts at TC Williams, *with the inclusion of lights*. We urge you to pass this DSUP.
