10	WHEREAS, Section 15.2-1500 of the Virginia Code provides, in part, that every locality		
11	shall provide for all the governmental functions of the locality, including, without limitation, the		
12	organization of all departments, offices, boards, commissions and agencies of government, and		
13 14	the organizational structure thereof, which are necessary to carry out the functions of government; and

16	WHEREAS, Section 2.2-4501 of the Virginia Code provides that all municipal		
17	corporations and other political subdivisions may invest any and all moneys belonging to them or		
18	within their control, other than sinking funds, in certain authorized investments; and		
19 20	WHEREAS, Section 15.2-1300 of the Virginia Code provides that any power, privilege		
20	or authority exercised or capable of exercise by any political subdivision of the Commonwealth		
22	of Virginia may be exercised and enjoyed jointly with any other political subdivision of the		
23	Commonwealth having a similar power, privilege or authority pursuant to agreements with one		
24	another for joint action pursuant to the provisions of that section; and		
25 26	WHEREAS, any two or more political subdivisions may enter into agreements with one		
20	another for joint action pursuant to the provisions of Section 15.2-1300 of the Virginia Code		
28	provided that the participating political subdivisions shall approve such agreement before the		
29	agreement may enter into force; and

31 32	WHEREAS, the City of Chesapeake, Virginia and the City of Roanoke, Virginia have determined to jointly establish and participate in the VACo/VML Virginia Investment Pool (the		
33	"Trust Fund") for each such city; and

35	WHEREAS, it appearing to the City Council that it is otherwise in the best interests of		
36	the City of Alexandria to become a participating locality in the Trust Fund; and		
37 38	WHEREAS, Laura Triggs, the duly appointed Chief Financial Officer/Director of		
39	Finance of the City of Alexandria, has the authority and responsibility under Virginia law to		
40	determine the manner in which City funds under her control will be invested;

42	NOW, THEREFORE THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
