4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
5	adopting and incorporating therein the amendment heretofore approved by city council to

7	2013-0003 and no other amendments, and to repeal all provisions of the said master plan as
8	may be inconsistent with such amendment.

10	WHEREAS, the City Council of the City of Alexandria finds and determines that:

12	1. In Master Plan Amendment No. 2013-0003, the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on November 7, 2013 of an amendment to
15 16	the Northeast Small Area Plan chapter of the Master Plan of the City of Alexandria to revise the height map to from a maximum 50 feet to a maximum of 65 feet for the property known as 800
17	and 820 Slaters Lane, which recommendation was approved by the City Council at public
18	hearing on December 14, 2013;

20	2. The said amendment has heretofore been approved by the planning commission
21	and city council after full opportunity for comment and public hearing.

30	attachment titled Proposed Height Map and labeled as Attachment #1, attached hereto and
31	incorporated fully herein by reference.

33	Section 2. That the director of planning and zoning be, and hereby is, directed to
34	record the foregoing master plan amendment as part of the Master Plan of the City of
35	Alexandria, Virginia.
