4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
5	adopting and incorporating therein the amendment heretofore approved by city council to
6	the Northeast Small Area Plan chapter of such master plan as Master Plan Amendment No.
7	2013-0003 and no other amendments, and to repeal all provisions of the said master plan as
8	may be inconsistent with such amendment.

12	1. In Master Plan Amendment No. 2013-0003, the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on November 7, 2013 of an amendment to
15	the Northeast Small Area Plan chapter of the Master Plan of the City of Alexandria to revise the
16	height map to from a maximum 50 feet to a maximum of 65 feet for the property known as 800
17	and 820 Slaters Lane, which recommendation was approved by the City Council at public
18	hearing on December 14, 2013;
19	
20	2. The said amendment has heretofore been approved by the planning commission
21	and city council after full opportunity for comment and public hearing.
22	
23	3. All requirements of law precedent to the adoption of this ordinance have been
24	complied with; now, therefore,
25	
26	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
27	
28	Section 1. That the Northeast Small Area Plan chapter of the Master Plan of the City
29	of Alexandria, be, and the same hereby is, amended by amending the height map as shown in the
30 21	attachment titled Proposed Height Map and labeled as Attachment #1, attached hereto and
31 32	incorporated fully herein by reference.
33	Section 2. That the director of planning and zoning be, and hereby is, directed to
34	record the foregoing master plan amendment as part of the Master Plan of the City of
35	Alexandria, Virginia.
36	
37	Section 3. That all provisions of the Northeast Small Area Plan Chapter of the
38	Master Plan of the City of Alexandria, Virginia, as may be inconsistent with the provisions of
39	this ordinance be, and same hereby are, repealed.
40	
41	Section 4. That the Master Plan of the City of Alexandria, as amended by this
42	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,
43	Virginia.

1	Section 5. That the city clerk shall transmit a duly certified copy of this ordinance to
2	the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the
3	Circuit Court shall file same among the court records.

5	Section 6. That this ordinance shall become effective upon the date and at the time
6	of its final passage.
