The most valuable skills that we need on the Board are:

Understanding of public finance, budgeting and rate setting. The most important responsibility of the Board is to set the quarterly wastewater processing rate. To do this requires a working-level understanding of capital financing, fiscal projections, and government accounting. The ideal candidate would possess a few years of experience with accounting and budgeting, fiscal reporting and financial modeling.

Familiarity with city and county relations. Alexandria Renew must work in partnership with the City of Alexandria and Fairfax Counties. Its authority and finances are intertwined with these jurisdictions. The ideal candidate would understand the planning and compliance processes of these entities and have a sensitivity (and interest) in how they operate.
