Hello. I have reached out to Leslie Zupan, but was told by someone else that she is no longer the president of the Olde Towne West Civic Association, are you the new president? With the Jefferson Houston school construction, our Buchanan Street Park will be moved, and with this move, I have contacted the Naming Committee to rename the park after Leatrice Byrd who lived next to and watched over the park for more than 40 years. A year ago Mrs. Byrd was killed in a tragic accident as she was being transported from dialysis. I have requested that the park be named in her honor. Myself and her children submitted our request and when we met with the Naming Committee they requested that we get endorsements from the neighborhood civic associations. I have also sent information to Trey Hanbury, the president of the Old Town Neighborhood Association, which is the association I am a member of. Del Pepper, Mayor Euille, and the others want to be sure there will be no backlash from the community in naming the park after Mrs. Byrd, this is why they requested that we do this outreach. We had more than 40 people submit written notice asking that this be honored.
