4	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by		
5	adopting and incorporating therein the amendment heretofore approved by city council to		
6	the Old Town North chapter of such master plan as Master Plan Amendment No. 2014-0001		
7	and no other amendments, and to repeal all provisions of the said master plan as may be		
8	inconsistent with such amendment.

10	WHEREAS, the City Council of the City of Alexandria finds and determines that:

12	1. In Master Plan Amendment No. 2014-0001, the Planning Commission, having		
13	found that the public necessity, convenience, general welfare and good zoning practice so		
14	require, recommended approval to the City Council on February 4, 2014 of an amendment to the		
15	Old Town North Chapter of the Master Plan of the City of Alexandria to amend the land use and		
16	zoning maps for the property at 509 North St. Asaph from RM/Townhouse to CRMU/X		
17	Commercial, Residential, Mixed Use (Old Town North) which recommendation was approved		
18	by the City Council at public hearing on February 22, 2014;

20	2. The said amendment has heretofore been approved by the planning commission		
21	and city council after full opportunity for comment and public hearing.

23	3. All requirements of law precedent to the adoption of this ordinance have been		
24	complied with; now, therefore,

26	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

28	Section 1. That the Old Town North Chapter of the Master Plan of the City of		
29	Alexandria, be, and the same hereby is, amended by amending maps 10, 11, 17 and 18 as shown		
30	in the attached graphic of the maps titled Master Plan Amendment Updated Maps attached		
31	hereto and incorporated fully herein by reference		
32			
33	Section 2. That the director of planning and zoning be, and hereby is, directed to		
34	record the foregoing master plan amendment as part of the Master Plan of the City of		
35	Alexandria, Virginia.		
36			
37	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,		
38	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.		
39			
40	Section 4. That the Master Plan of the City of Alexandria, as amended by this		
41	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,		
42	Virginia.		
43			
44	Section 5. That the city clerk shall transmit a duly certified copy of this ordinance to		
45	the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the		
46	Circuit Court shall file same among the court records.
