- Request Description: As you may know, this afternoon King Street residents were given letters from Rich Baier in City Transportation telling us a decision has been made to install bike lanes, despite the recommendation just several weeks ago from the Traffic & Parking Board to delay such action. Not only was this done on a Friday afternoon before a holiday, so staff are unavailable to speak and answer questions, but the letter was given to the bike groups and media before it ever reached the residents most impacted. In fact, many of us first learned of it from the Old Town Patch.

Time and time again residents have asked to meet with Rich and his staff, and particularly walk along King Street with them. Not once did they respond. However, they met with interest groups a number of times, including groups that were largely made of non-Alexandria residents. In addition, the letter release by Mr. Baier was full of inaccuracies, including the assertion that the traffic study conducted by the bike group was the City's 'formal analysis'. It certainly was not and resident counts are much different, backed by photos, videos and data which we are happy to provide. Similarly, while Mr. Baier points to a number of city decisions to prove his point, there are a number of them, including within the City's own CPBM plan, that are contradictory. This should not be a pick and choose approach. Instead of listening to our safety concerns and making pedestrian safety first, including the fact there is no crosswalk for nearly half a mile between Upland and Russell, this decision is poor and unilaterally made. Based on measurements of both current lanes and standard city bus and fire truck widths, bike lanes would not permit proper lane widths under USDOT guidelines.

Myself and our neighbors would like to ask a few simply things from you, outside of listening to Alexandria residents instead of outside groups. Please urge Mr. Baier to not only reconsider, but to actually sit down and visit with residents. Second, this issue pertains to a major arterial in our City and it should not be approved by nonelected staff, rather it deserves serious consideration by you, our elected officials. Please support King Street residents, as did the Parking Board and the Taylor Run Citizens Assocition, and ensure this decision by staff is reconsidered. Better yet, sit down with those of us living on King Street and see our concerns first hand.



I'm writing in favor of the King St. Bike Lanes. One would think this would be obvious, for numerous reasons, and most of those reasons were mentioned at the November 25th Traffic and Parking Board Hearing. I did not get to speak at the hearing but was present, along with the rest of the room, that was, by and large, in favor of the bike lanes.

I can only reiterate what most others in favor have already mentioned. Designated bike lanes, or even shared lanes as in the revised proposal, are proven to be a safer means of travel for the constantly increasing number of cyclists in Alexandria and the surrounding areas. On a daily basis, we hear from our customers about their concerns of safety when utilizing their bicycles as a means of transportation in and around Alexandria, especially on the roads in areas where sidewalks have high pedestrian traffic or where there are no sidewalks. We mention to them how Alexandria has been very proactive in recent years with installing bike lanes, designated parking, etc and that it's only going to keep moving forward. It seems as though a small amount of folks, with false claims, could keep this from potentially happening.

In my opinion, the concerns of a few, educated, obviously well off, citizens along that stretch of King St., are claiming "Safety Concerns" as their reasoning for opposing the bike lanes on King Street. The bike lanes would be implemented to ensure safety for cyclists as well as create a buffer between the cars and the sidewalks. It would also narrow the driving lanes, which has been shown to decrease speeding. All of these factors would create a safer environment for all those using King Street.

I can't help but see the argument of the citizens of King Street and the Taylor Run community as purely a cover up for the possibility of them losing their prized parking spaces, which I might add, don't seem to get used! The vast majority of those homes have driveways, obviously, which is why there is never more than 1-3 cars parked along that stretch of King St. (I use it every single day, at approximately 10pm-which is when most would be home). They simply do not get used. It shouldn't even be an issue, but it is to them, because they don't want to give up what I would consider, a luxury, as the rest of the residents of Alexandria aren't guaranteed street parking.

The revised plan presented still maintains 10 spots, while also making transportation safer for all who use King St., not just the cyclists. Simply put, the plan works, for everyone. Except for those that are afraid of positive change, and positive movement forward during a time when it's needed most.

Cycling is growing, and with the increase of vehicle traffic constantly in the DC area, cyclists must have safe routes. The original plan, and the revised plan, offer this, and it works for everyone else involved as well.

I can only hope that your decision is to ultimately approve either of the plans. And, the beauty of it all, is if you do, and for some reason, we realize that six months down the road, it needs to be re-worked, then we do it. We're talking a very minimal investment at this point to make a huge improvement for all. It should not surprise me that a small community of residents is objecting to city policy in the King Street Traffic Calming Project. However the decision to proceed with this project is made clear by just looking at the facts. Basically the issue boils down to the city implementing policy versus residents losing parking. The city has shown that every resident losing parking has at least two off-street parking places. This project also addresses an important safety issue. The city has presented a plan that increases safety for pedestrians and cyclists and will slow traffic. While the opponents claim that adding bike lanes will create an environment that is less safe, they provide no facts to support this claim. The city has at least five surveys and studies which show that adding bike lanes provide a safer environment (shown below). The city has experts and professionals who studied this reasonable proposal, the residents have none. The opponents have sent many letters with lots of claims of which most are unfounded.

The city's plan addresses traffic calming, pedestrian safety and cyclist safety. The opponents plan focuses on saving parking spaces provided by the city on city streets. City commissions, local organizations and an overwhelming majority of those who submitted letters and attended the Traffic and Parking Board meeting agree that the safety benefits outweigh the concerns of the opponents.

The city should implement the Complete Streets Policy and proceed with this project which also complies with the Transportation Master Plan and the Bicycle and Pedestrian Mobility Plan. The Transportation Plan encompasses many changes to encourage more biking and walking and less use of single occupancy vehicles. The city is planning for the future and needs to move forward through implementation.

I urge the City Council to approve the creation of a bike lane on King St from Janneys lane to West View Terrace - or at least create sharrows through that stretch.

This project is important to improve the safety of this part of King Street and more broadly to provide connectivity of a safe route to the King Street metro and Old Town. Traffic moves in this area too fast for the pedestrians or bicycles to feel safe; and sometimes too fast for a driver to anticipate and react safely to the presence of either. Just this week as I biked down King from Janney lane midday when traffic was relatively light, a car came up behind me, and because there was just enough opposing traffic to prevent him from going out and around me the car had to follow me most of the way down to Callahan getting ever closer with cars just behind him weaving left and right impatiently. Watching this play out in my rear view bike mirror was daunting, but there was little I could do since even slowing or stopping to retreat to the sidewalk on the downhill with a car close behind, would have been more dangerous.

The implementation of a bike lane or sharrows will act to calm traffic and cause walkers and bikers to feel safer. We know this from examples in our city and Arlington where bike lanes have been added. This is not an experiment, it is an implementation of a policy that has calmed traffic in similar situations.

I chose to live in Alexandria over other nearby cities in part because it provides well for transit, walking and biking. The result has been gratifying. After decades of owning and driving two cars my wife and I, though we are both out every day, now own but one car and drive about a third as much as we used to. I love the opportunity of being free of a vehicle as I so often can in Alexandria. But it works because I can bike and walk either right to my destination or to a transit stop. More people will do that if we make it safer.

My family knows that I bike on King Street. You can give them some peace (of mind) by nudging him to move forward with this project, for safety's sake. Some argue that there are increased risks from narrowing the lanes. Facts show the opposite: A landmark study in 2007 examined safety in ten-, eleven-, and twelve-foot lanes in urban areas with a speed limit below 45 MPH (Potts, et al. "Relationship of Lane Width to Safety for Urban and Suburban Arterials"). No decrease in safety was found when lane width was reduced. A earlier study ("Relationship of Lane Width and Speed", by the Parsons Group, September 2003) cited nearby examples of narrow lanes with no operational issues. "Several studies have reported the use of lanes 10 feet wide (or slightly narrower) with no perceived operational difficulties to buses and trucks." Makes sense. Think about the narrow streets we have driven on, many in Alexandria; we tend to slow down, and that tends to keep us all safe, arguably, safer.

City staff has numerous references to support that narrowing lanes will slow traffic and that adding bike lanes will improve safety for cyclists; additionally, residents in the King Street area (not "outsiders") have asked for bikes lanes to provide a buffer for pedestrians and to eliminate conflicts with cyclists who otherwise might use the sidewalks. The expected result is that more people with walk and ride along this section of King Street because it will be safer to do so, and that makes it safer yet! Why? Because, "The likelihood that a given person walking or bicycling will be struck by a motorist varies inversely with the amount of walking or bicycling" [Safety in numbers: more walkers and bicyclists, safer walking and bicycling, Peter Lyndon Jacobsen, Injury Prevention 2003, Volume 9 Issue 3, pages 205-209]

Members of the City's Transportation Commission, many of whom have relevant expertise, unanimously agreed that the safety benefits outweigh other concerns and that the King Street project should proceed without further delay. Most people agreed with that on November 25th, when 40 of 58 speakers spoke in support of the project. Bottom line: narrowing lanes reduces traffic speeds and will not cause operational or safety issues, bike lanes improve safety, and more people walking and riding improve safety. Appointed officials with relevant experience as well as many residents agree. My family and I would like to enjoy this holiday season and many more. You can help with that by encouraging Rich Baier to approve the King Street project, for safety's sake. Thanks for all that you do for the City of Alexandria and have a Happy Holiday!

As a former member of the Washington Area Bicyclists Association (WABA), I was asked to write the city to express my support for bike lanes on King St. between Russell and Janneys. While I generally support biking initiatives within Alexandria, I DISAGREE with them in this case for the following reasons:

1. Bike lanes are a declaration by the city that bike use is encouraged on that road. This is the wrong message to send for the area in question. Even with bike lanes, King St. will remain a narrow, hilly road. While there are a small number of commuters who have no good alternatives, these are experienced cyclists who are used to difficult conditions. This is not a place to send tourists or recreational bikers.

2. Removing parking completely would harm residents. Imagine a group of guests visiting this area, not having room in the driveway to park, having to park on a side street on the other side of King St., then crossing the busy road where there are no crosswalks. As far as I know, there is no other location in the city where we force residents into this kind of dangerous situation. Let's not start now.

3. Adding the bike lanes would not make a significant impact on biker safety or convenience. Going downhill, cyclists can travel at the speed limit and mix with traffic until they reach the light at Russell. Going uphill, the parking spaces are mostly not in use and that space is perfectly suitable for biking. When there is a vehicle parked, the biker must either use the sidewalk (also usually empty since very few people walk this stretch of road) or briefly merge with traffic. While this is a slight inconvenience, it is no more difficult than the inevitable left turn they make at the beginning or end of their trip. Since we are talking experienced bikers here, this really is not an issue.

I ask the council to do the following:

1. Ignore the requests by the biking lobby to put bike lanes on every stretch of road in the city regardless of its impact, positive or negative.

2. Consider altering the parking rules on King St. to further reduce the probability of vehicles being parked there long term. For example, not allowing residents to park on the street full time would further reduce the likelihood of vehicles being encountered by bikers while biking up the steep hill without completely eliminating the ability of guests to park there when needed.

3. Look for alternatives that would keep bikers away from this stretch of road. I understand some improvements for Taylor Run are in the works. This is a good start. However, in the long term I believe that Duke St. should be investigated for improvements. If a cycletrack were constructed there, the biking lobby would forget all about King St.

I think we need to emphasize the diversity of our community residence and that we all want to enjoy our community and each other equally. Thank you for your time, Sincerely, Patty Collins



Although I only ride on King Street about once a week, it seems to me that there is a real need for some kind of bicycle accommodation on the uphill side--a bike lane for climbing up is necessary if this is to be a utilized route. Riding on the sidewalk is not an option here, it is too narrow and dangerous for both bicycles and pedestrians. I am less convinced that a bike lane is necessary on the downhill side since there are parallel streets and it is easier for bicycles to keep up speed. Parking is certainly an issue for the residents and I sympathize with them, but it seems that the optimal use of public areas is a legitimate issue for city council to consider if its policy is to encourage bicycle and pedestrian use.
