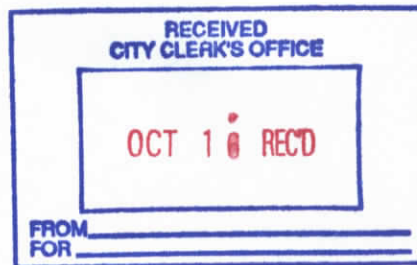

Dear Ms. Henderson,

In accordance with Section 9.13 of the Charter of the City of Alexandria, and of Section 11-808 of the Zoning Ordinance of the City of Alexandria, we are submitting the attached petition in opposition to three proposed actions currently scheduled to be brought before the Mayor and Council on Saturday, October 18, 2014. The applicants are requesting approval of a Master Plan Amendment, #2014-0007, a map amendment (rezoning) #2014-0005 and a Special Use Permit #2014-0079 to operate a hotel and restaurant, for a parking reduction and shared parking at 329 North Washington Street. The applicant is JanowLLC/LaBergerie.

Attached are forty-seven (47) pages containing signatures of the owners of one hundred and thirty (130) properties (over 200 residents) within 300 feet of the boundary of the land affected by the proposed changes. This represents a percentage in excess of the 20% required by Section 11-808. All of the 130 property owners are opposed to all of the proposed changes.
