14	found that the public necessity, convenience, general welfare and good zoning practice so		
15	require, recommended approval to the City Council on February 3, 2015 of an amendment to the		
16	Old Town North Chapter of the Master Plan of the City of Alexandria to modify the land use		
17	designation for 513 and 515 North Washington Street from RM/Residential Medium to		
18	OC/Office Commercial, which recommendation was approved by the City Council at public		
19	hearing on February 21, 2015;

21	2. The said amendment has heretofore been approved by the planning commission		
22	and city council after full opportunity for comment and public hearing.
