

I am writing to you concerning my application to become a member of the Alexandria Commission for the Arts. I wanted to personally introduce myself and express my strong interest in serving on the Commission, based on my interest in serving our community as well as my love for the arts. I would also like to offer to provide any additional information and answer any questions you may have.
