11	WHEREAS, the City Council of the City of Alexandria finds and determines that:

29	Section 1. That the Old Town North Chapter of the Master Plan of the City of
30	Alexandria, be, and the same hereby is, amended by amending the land use designation for 513
31	North Washington and 515 North Washington Street on Map #11 from RM/Residential Medium
32	to OC/Office Commercial.

34	Section 2. That the director of planning and zoning be, and hereby is, directed to
35	record the foregoing master plan amendment as part of the Master Plan of the City of
36	Alexandria, Virginia.

38	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
39	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

41	Section 4. That the Master Plan of the City of Alexandria, as amended by this
42	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,
43	Virginia.
