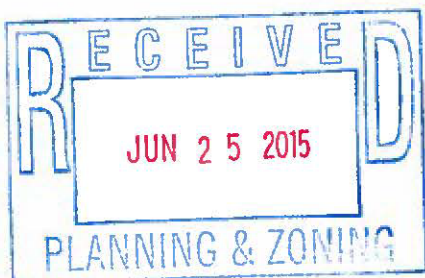

Kitchen Renovation. Run a gas line FROM STREET TO HOME. Place new gas line in front of home. GAS METER shall NOT EXCEED 18" ABOVE GROUND. Run Gas line into home for new Gas cooktop appliance. Hole needed for gas line penetration into home shall not exceed 1 1/2".

Vent new Hood Appliance to front exterior of home for new Hood vent appliance in kitchen. Hole needed for Hood vent penetration OUT OF HOME shall not exceed 6".

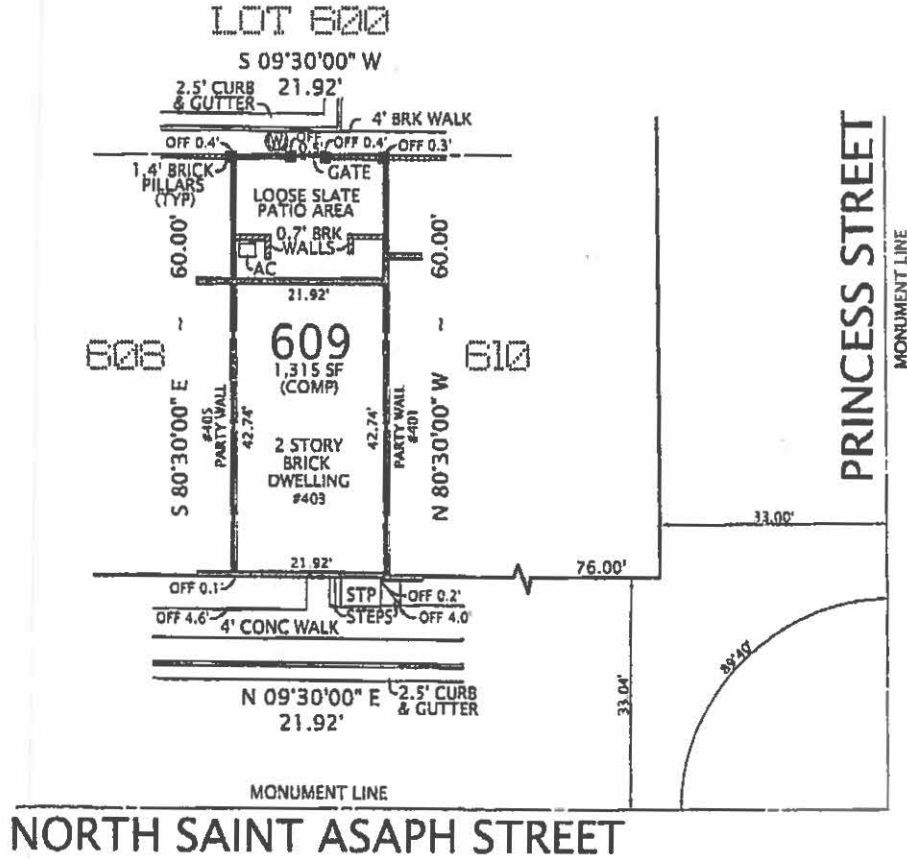
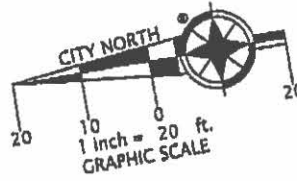

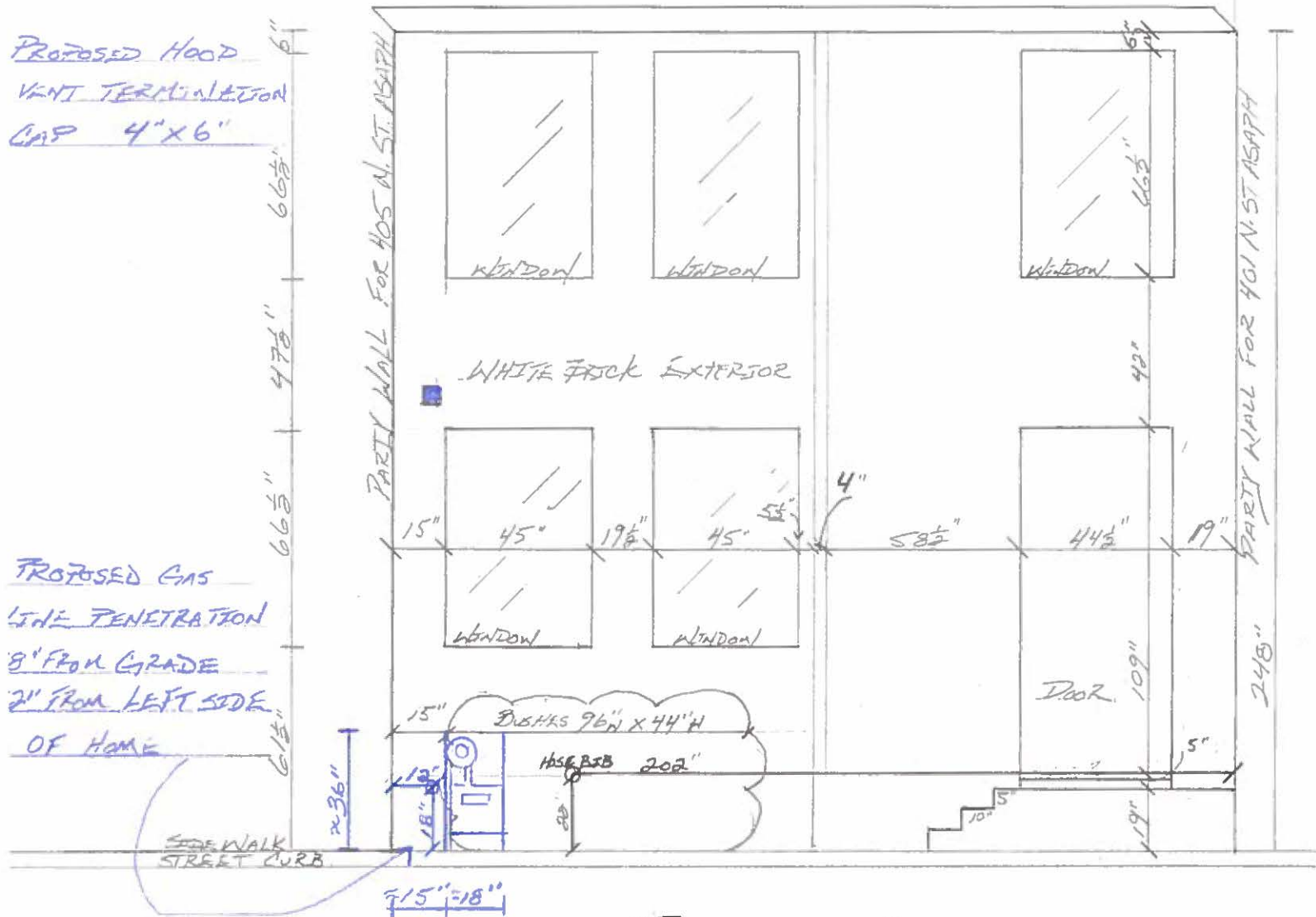
