



Dear Mayor Silberberg, Vice Mayor Justin Wilson and members of the City Council,

I would like to recommend that you appoint Patricia Hennig of Alexandria to the Northern Virginia Juvenile Detention Commission. Consideration of the candidates for this vacancy is on the docket for the Council's March 8, 2016, meeting.

Ms. Hennig is the best qualified person in Alexandria for this position on the Commission because of her proven abilities, professional experience and knowledge of the particular financial areas which the Commission needs to address at this time.

Ms. Hennig is presently Vice President in charge of finances and operations at the Council of Competitiveness in Washington, DC. She has prepared applications for federal and state grants that were presented by the Council, and managed and distributed funds in complex situations with the grants. I have been impressed by her hard work and attention to detail during her many years on the Alexandria School Board. In that capacity, she asked tough financial questions and demanded honesty and transparency, on behalf of the proposed school budgets, from the staff and from her fellow Board members. She worked hard to help create viable, long-term and realistic budgets for the Alexandria school system.

At the public meeting of the Northern Virginia Juvenile Detention Commission on Feb. 9, 2016, we were informed that the Commission had miscalculated the monies of capital reserves in the FY2017 fiscal budget and the error was \$700,000. The Commission has been operating for approximately one year without a Memorandum of Understanding between Alexandria City, Arlington County, Falls Church City and the Commission our budget, consisting of contributions from these jurisdictions.

While there are many qualified candidates in Alexandria for this Commission vacancy, I do not believe any of them have the unique financial experience of Ms. Hennig, including her monetary expertise. To the best of my knowledge, I do not believe that the information on the \$700,000 financial error has been widely disseminated and this serious oversight should be a factor as the Council considers the financial track records and expertise of all the candidates for this very important post.

As an 8-year member of this Commission, I am deeply concerned about these pending financial matters that have some to my attention in the last two years. I have recommended to other Commission members on different occasions that we should have a Certified Public Accountant

or an expert financial advisor consult with us. But I have not been successful in this endeavor. If appointed to this Commission vacancy, Ms. Hennig would be able to provide the crucial financial expertise that this Commission sorely needs.

Please know that I make this recommendation to the Council as a 40-year career attorney in Alexandria and other Northern Virginia jurisdictions. During that time, I have represented many juveniles in this facility, and before and after they were sent to this facility. I was the attorney appointment by Judge Stephen Rideout in 1995 and was subsequently appointed by Judge Nolan Dawkins and then Judge Constance Frogale to the Model Court Commission and its successor organization, the Best Practices Committee in Alexandria.

I have received awards from the Division of the Social Services and the Virginia Supreme Court for the Legal Continuing Education Program. I was also appointed to and named chair of the Parent Child Partnership, which came up with five mandates changing the Alexandria Social Services protocols after the death of the young child, Caitlin Frazier. I was also chair of the Northern Virginia Juvenile Detention Commission for four years. During my chairmanship of the Commission, we had excellent staff people at the Center to run the programs for youth, and we were also well represented by the retired Court Services Directors of Arlington and Alexandria City. I know we have good programs. I also know that our primary limitation in giving the best services in the best facility, with the best staff, came from a lack of money, and not a lack of dedication or knowledge by those involved.

I ask the Council members to vote on March 8 to Patricia Henning to represent Alexandria on this Commission. Also, I want to thank the Council members, past and present, for appointing me for the last eight years to be a member of this Commission. Working together, I am proud of all that we have accomplished at the Detention Center.
