



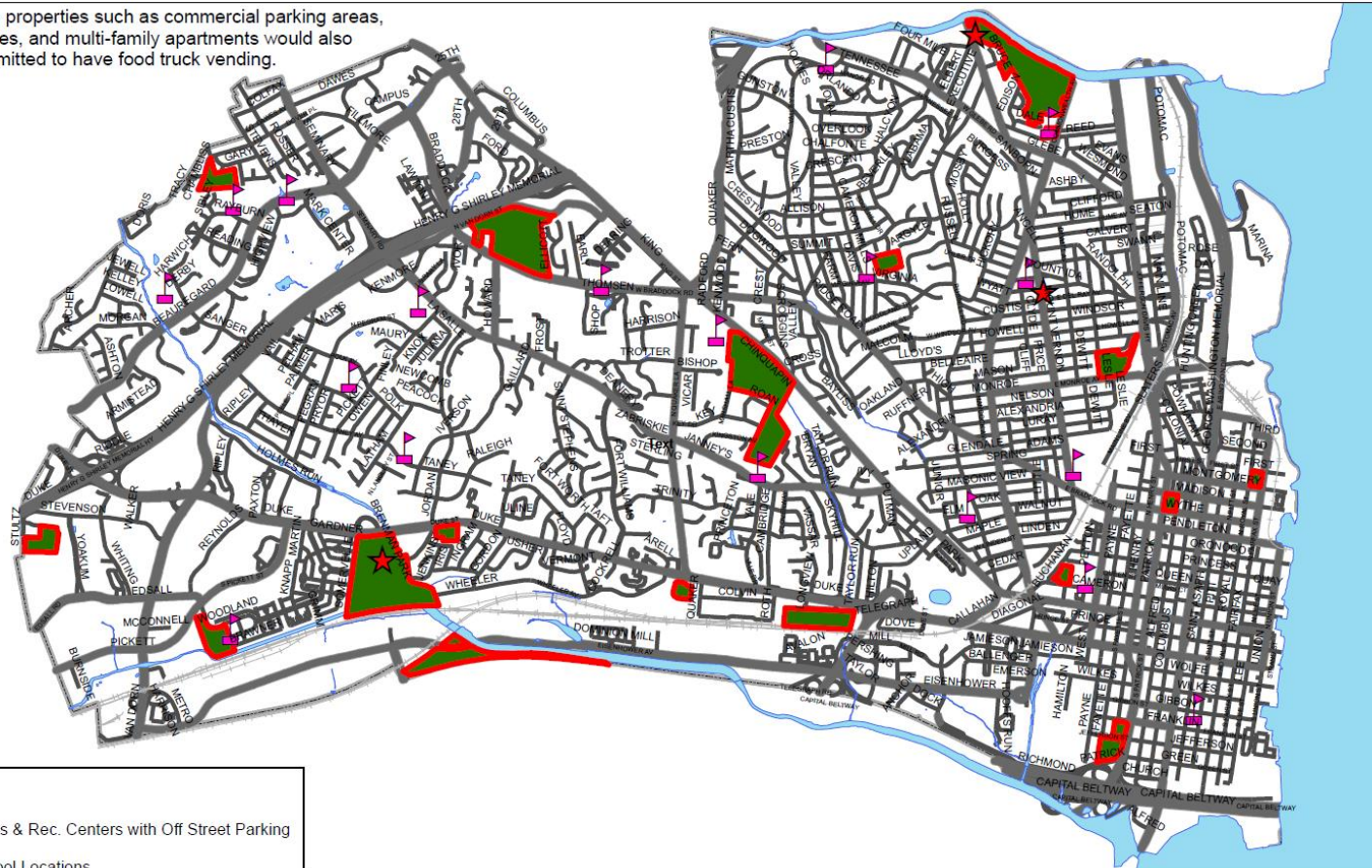
Food Truck On-Street Locations Proposal

Off-Street Locations

Parks and Recreation Centers with Parking, Farmer's Markets, and School Locations

Private properties such as commercial parking areas, churches, and multi-family apartments would also be permitted to have food truck vending.

Criteria for Consideration

City Code 9-15-15: The City Council may establish one or more designated vending locations within parking spaces on the public right of way where a food truck vendor may operate.

A. Factors for Consideration of Location: City Council shall consider the following factors in determining whether a location should be used for vending:

- a. Concentration of people within a quarter (1/4) mile of the location;
- b. Adequacy of parking in the surrounding area;
- c. Adequacy of space on the street for circulation and safety; and
- d. Amount of congestion.

B. Minimum Requirements of Location: At a minimum, the designated vending locations shall:

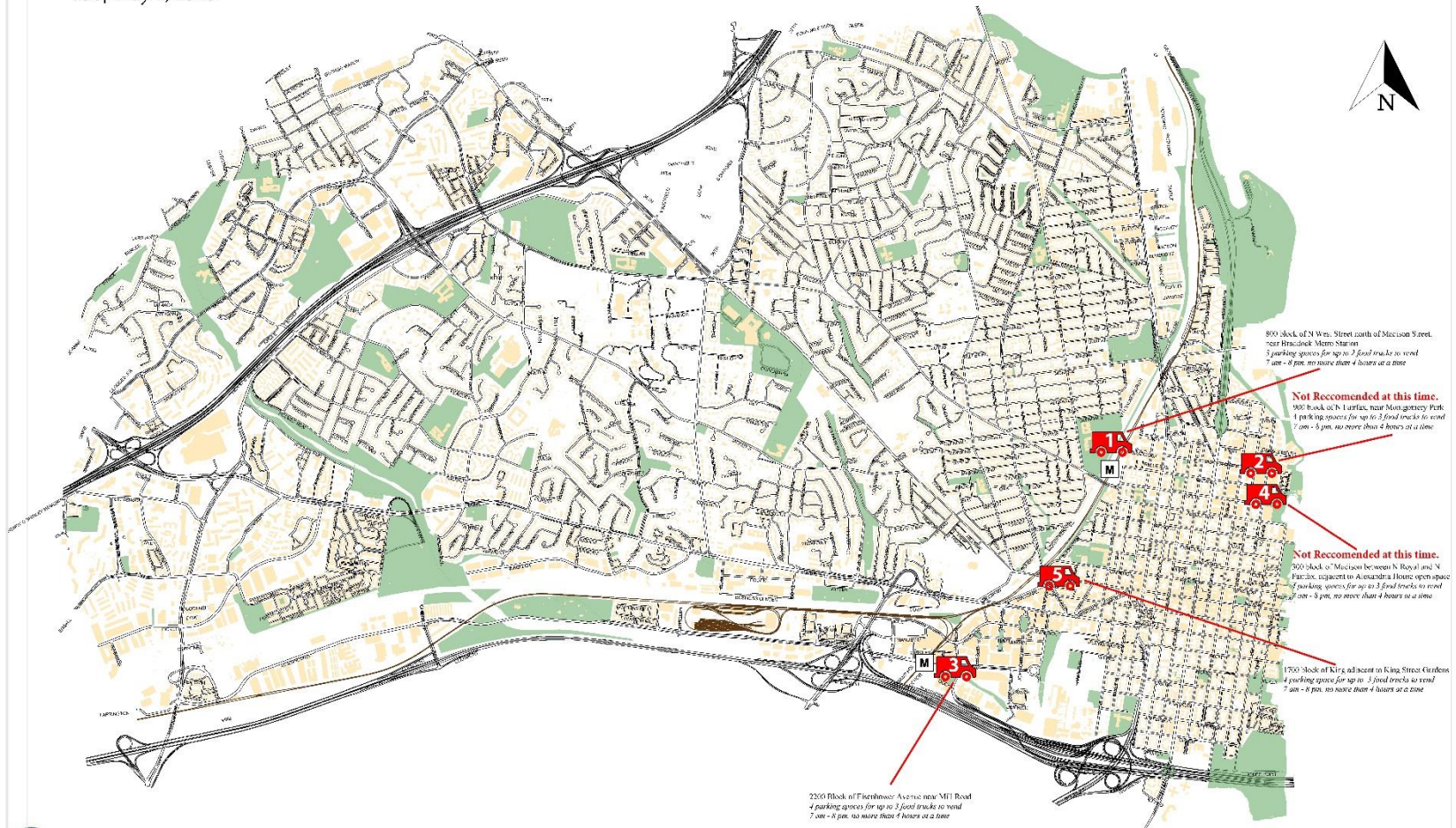
- a. be on streets that have at least sixty six (66) feet of right-of-way;
- b. include no more than four (4) parking spaces in a row;
- c. not be located in front or within twenty (20) feet from a commercial outdoor dining area measured along the curb line;
- d. not be within ten (10) feet of an intersection, crosswalk, driveway, bus stop, taxi stand, or handicapped parking space;
- e. not be situated in any part of any designated loading zone or fire lane; and
- f. allow for adequate clearance for pedestrian traffic as determined by the director of T&ES based on the context of the specific site.

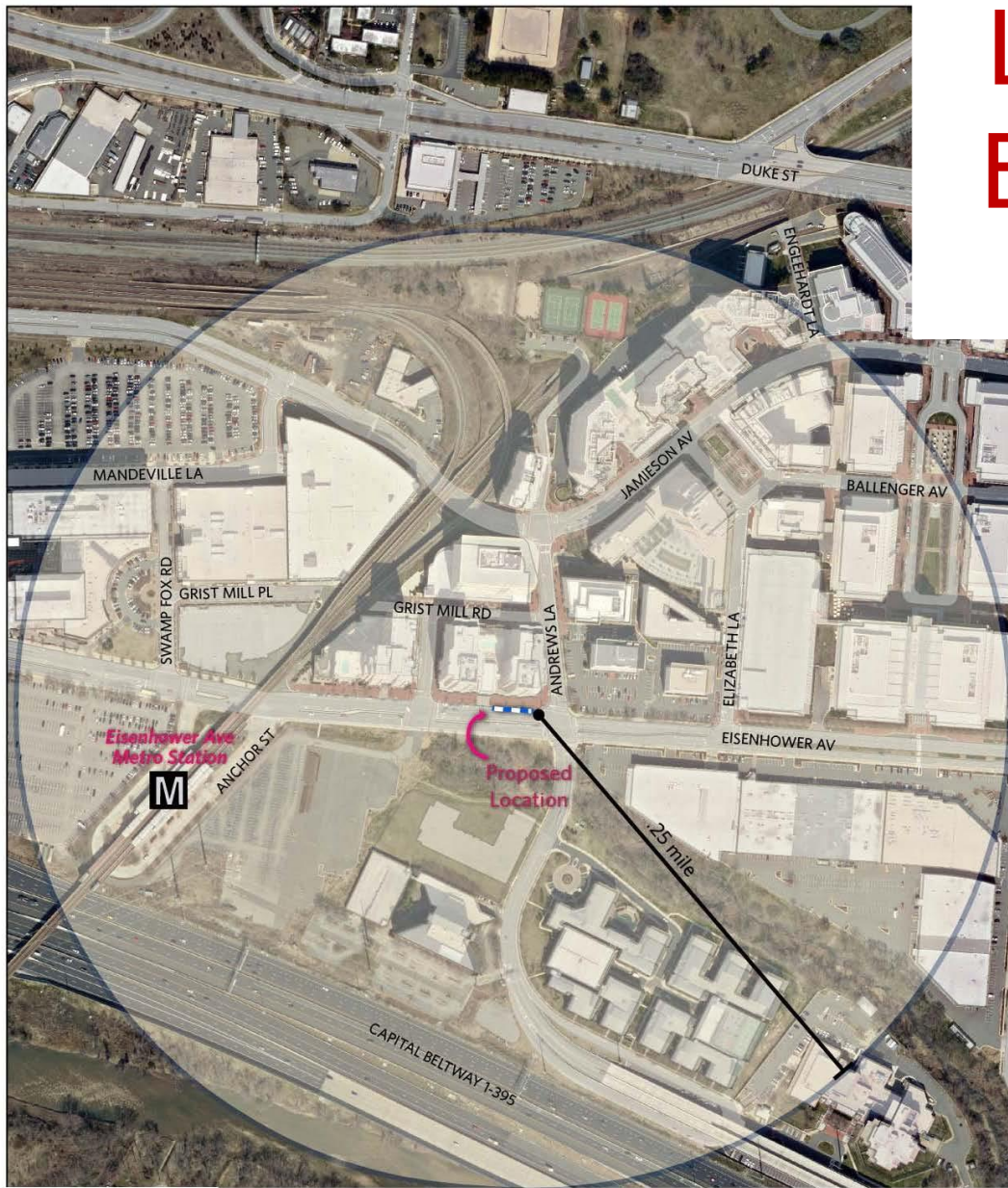

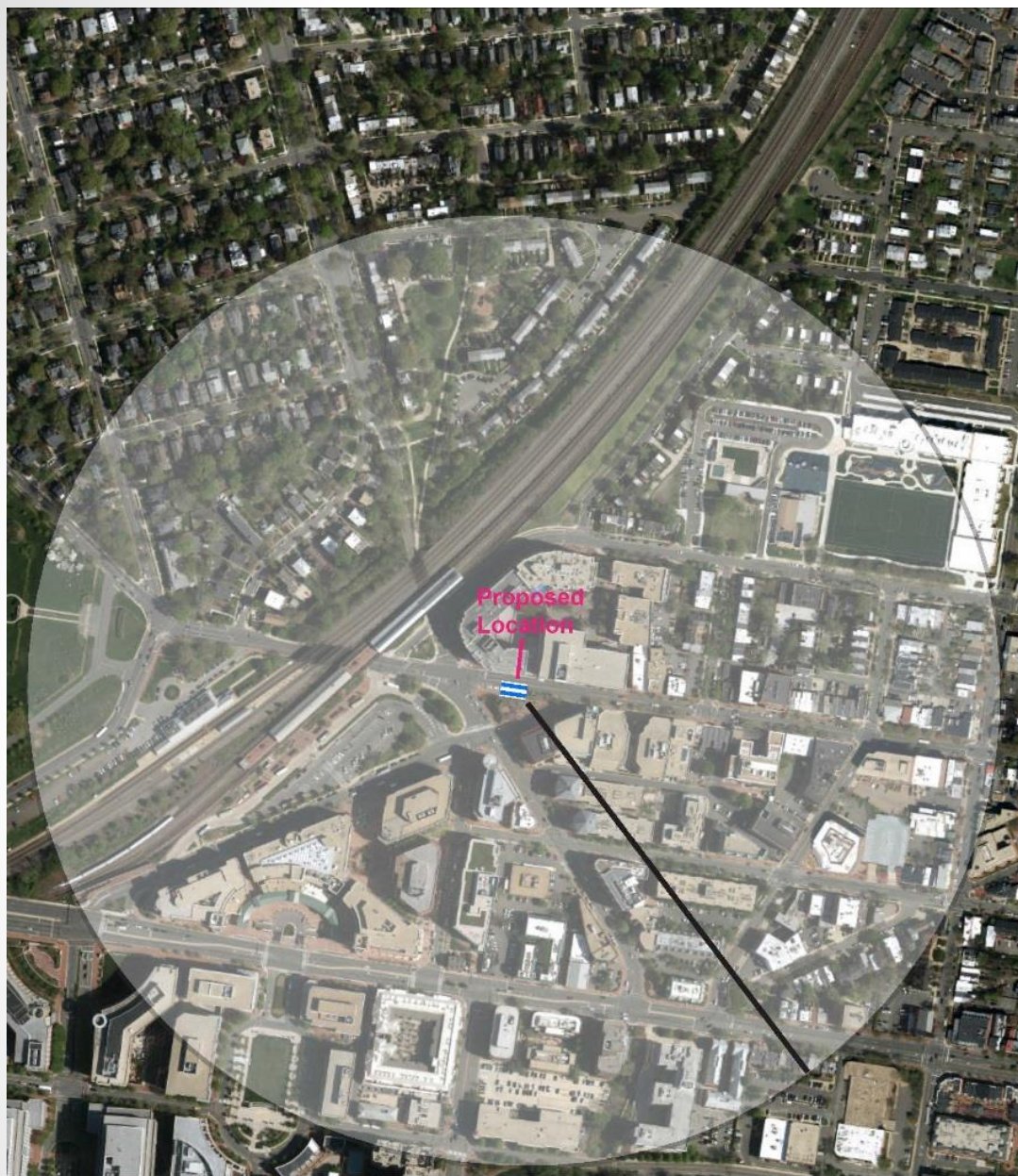

Figure 1: WITH the 504 submissions from the same source

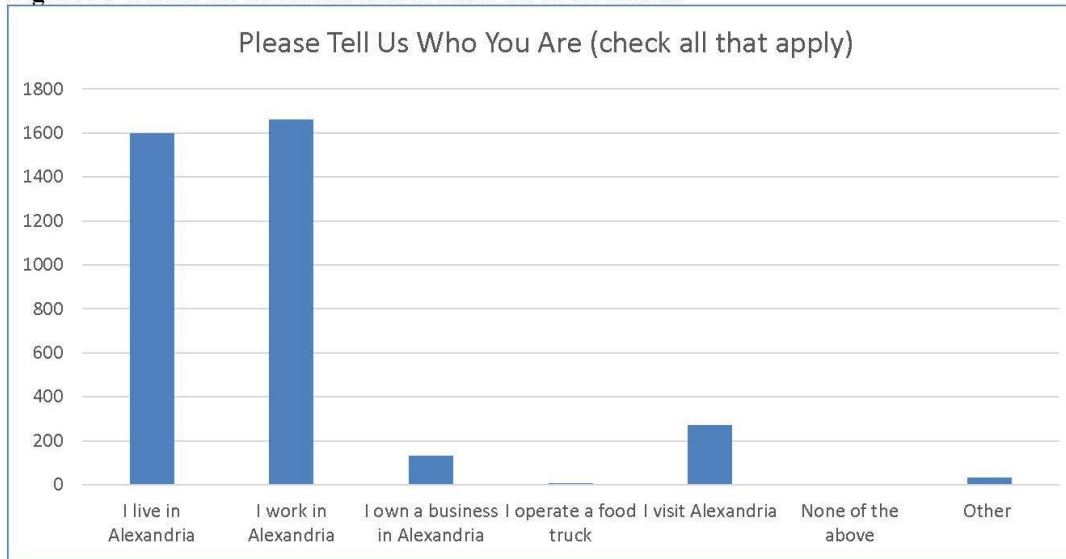
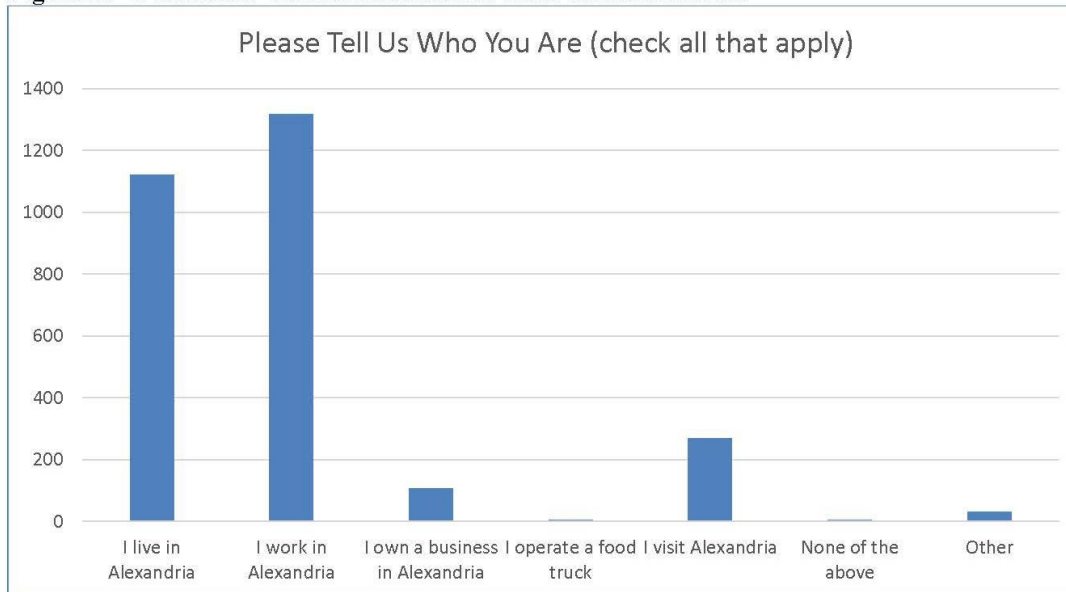
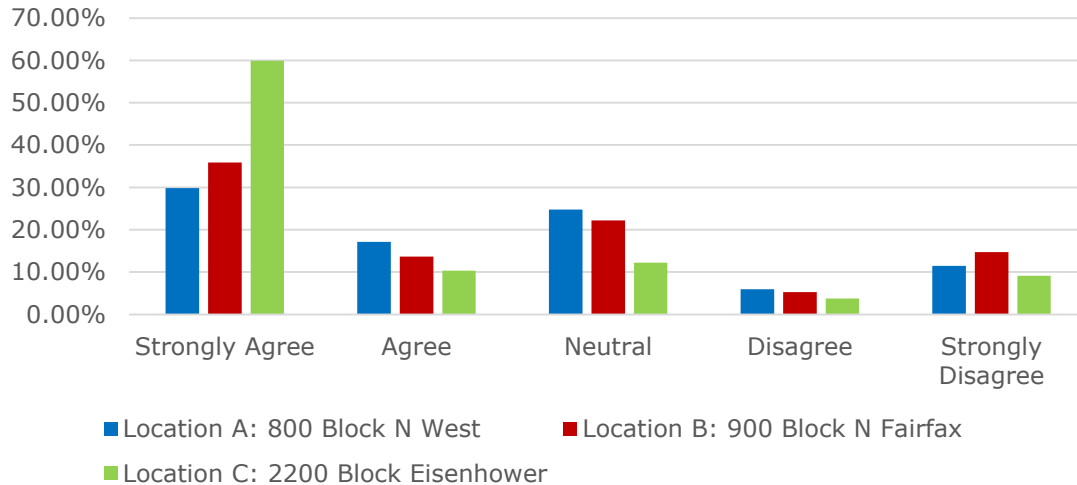


Figure 1: WITHOUT the 504 submissions from the same source

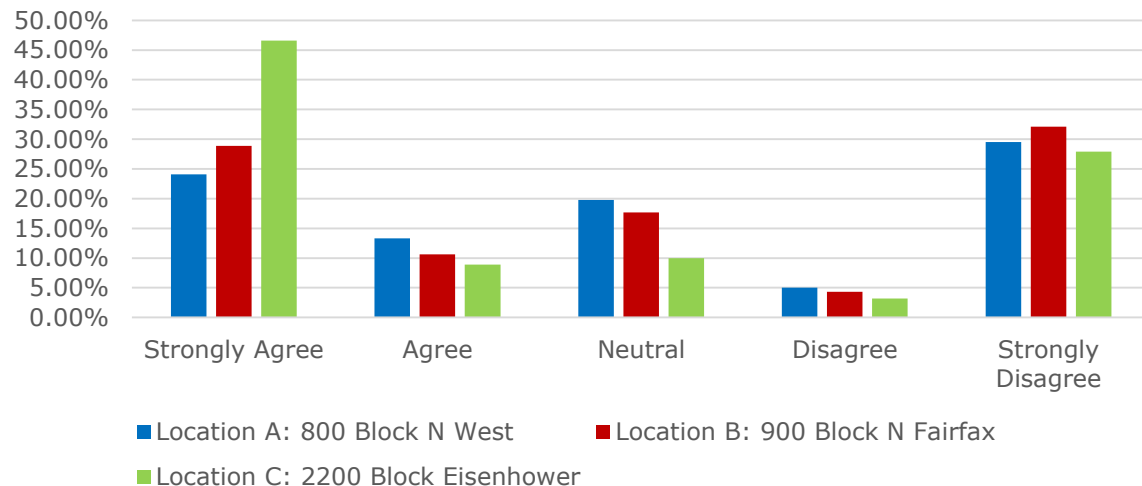


Poll Results for Three Proposed Locations

Recommendation

- Traffic and Parking Board:
 - Approve Food Truck Vending at the North West Street Location, Eisenhower Avenue Location and the King Street Garden Location;
 - Report back to Traffic and Parking Board in 6 months regarding the number of trucks using each space, the duration that the food trucks are using the spaces, and the utilization of each space;
 - Use the Old Town North Small Area Planning process to consider acceptable locations in Old Town North.

- Staff:
 - Given the testimony and concerns regarding parking and congestion raised at the Traffic and Parking Board hearing, staff is in agreement with the Traffic and Parking Board recommendation.
