2	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
4	adopting and incorporating therein the amendment approved by city council on March 12, 2016
5	to the Braddock East Small Area Plan chapter of such master plan as Master Plan Amendment
6	No. 2015-0003 to amend the land use and development framework tables pertaining to the
7	Ramsey Homes property and no other amendments, and to repeal all provisions of the said
8	master plan as may be inconsistent with such amendment.
9	
10	WHEREAS, the City Council of the City of Alexandria finds and determines that:
11	
12	1. In Master Plan Amendment No. 2015-0003 the Planning Commission, having
13	found that the public necessity, convenience, general welfare and good zoning practice so
14	require, recommended approval to the City Council on February 4, 2016 of an amendment to the
15	Braddock East Chapter of the Master Plan of the City of Alexandria to amend the land use and
16	development framework tables pertaining to the Ramsey Homes property which
17	recommendation was approved by the City Council at public hearing on March 12, 2016;
18	
19	2. The said amendment has heretofore been approved by the planning commission
20	and city council after full opportunity for comment and public hearing.
21	
22	3. All requirements of law precedent to the adoption of this ordinance have been
23	complied with; now, therefore,
24	THE CITY COUNCIL OF ALEYANDDIA HEDERY ORDAING.
25 26	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
27	Section 1. That the Braddock East Chapter of the Master Plan of the City of
28	Alexandria, be, and the same hereby is, amended by amending Table 3 on Page 37 and Table 5
29	on Page 47 as shown on the document labeled Attachment 1 attached hereto and incorporated
30	fully herein by reference.

32	Section 2. That the director of planning and zoning be, and hereby is, directed to
33	record the foregoing master plan amendment as part of the Master Plan of the City of
34	Alexandria, Virginia.
35	
36	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
37	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.
38	
39	Section 4. That the Master Plan of the City of Alexandria, as amended by this
40	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,
41	Virginia.

43	Section 5. That the city clerk shall transmit a duly certified copy of this ordinance to
44	the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the
45	Circuit Court shall file same among the court records.
