7	No. 2015-0009 and no other amendments, and to repeal all provisions of the said master plan as

10	WHEREAS, the City Council of the City of Alexandria finds and determines that:

12	1. In Master Plan Amendment No. 2015-0009 the Planning Commission, having		
13	found that the public necessity, convenience, general welfare and good zoning practice so		
14	require, recommended approval to the City Council on March 1, 2016 of an amendment to the		
15	Old Town North Small Area Plan Chapter of the Master Plan of the City of Alexandria to amend		
16	the land use map and the height map for the parcels located at 530 First Street and 901 North St.		
17	Asaph Street, which recommendation was approved by the City Council at public hearing on		
18	March 12, 2016;

20	2. The said amendment has heretofore been approved by the planning commission		
21	and city council after full opportunity for comment and public hearing.		
22			
23	3. All requirements of law precedent to the adoption of this ordinance have been		
24	complied with; now, therefore,		
25			
26	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:		
27			
28	Section 1. That the Old Town North Small Area Plan Chapter of the Master Plan of		
29	the City of Alexandria, be, and the same hereby is, amended by amending Map 11 and Map 15		
30	as shown on the document labeled as Attachment 1 attached hereto and incorporated fully herein		
31	by reference, as a new chapter of the Master Plan of the City of Alexandria, Virginia.		
32			
33	Section 2. That the director of planning and zoning be, and hereby is, directed to		
34	record the foregoing master plan amendment as part of the Master Plan of the City of		
35	Alexandria, Virginia.		
36			
37	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,		
38	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

40	Section 4. That the Master Plan of the City of Alexandria, as amended by this		
41	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,		
42	Virginia.
