It is my opinion that although the ordinance may be facially content neutral, it is currently applied and enforced in a discriminatory manner, where realtors and other commercial entities apparently are rarely if ever fined for posting unlawful signs. Meanwhile, individual residents -- who lack the means and resources enjoyed by realtors and other commercial entities -- cannot even RISK incurring fines under the ordinance, and are therefore deterred from posting their political and religious messages and "self censor" for fear that the ordinance might be enforced against them.

I will not speculate as to why the ordinance seemingly has been applied in such a manner. But since the city apparently isn't able or willing to enforce the current ordinance consistently and fairly, the city must simply allow ALL signs to be posted.





I understand that there is a universal law, but this a) was not the intended purpose and b) has a very direct impact of the property value of CS residents. When houses sit on the market because lack of visible advertisement and direction, we all loose. Cameron Station is a very unique neighborhood, not designed easily to identify side and back streets without signage. Not all buyers are computer savvy to check every Sunday for multiple listings. We are a community that is best appreciated with drive by and curb appeal. We already lost a buyer because they came on Sunday and saw no signs for open houses and drove away. I wonder how much revenue will the city loose for lack of real estate transactions. I would welcome a response to this question.

I am writing to express my concern at the implications that the City's "no-sign" ordinance has had on my community, Cameron Station. My understanding is that this ordinance was never intended to be enforced within Cameron Station, but that a single, lone complainant has flooded both our local community board and the City of Alexandria with complaints about signs, and has even decided to take the law into his own hands by removing posted signs. To my knowledge, this individual is the only person in the entire City of Alexandria who has a problem with the posting of non-political signs in common areas of our community.

Many institutions within our community rely on the ability to post signs to advertise their wonderful events. Most prominently, the West End Farmer's Market, which brings vitality, business, and enjoyment to our community each spring and summer, would be decimated if it were not allowed to post signs advertising the dates on which it takes place. Similarly, local realtors have noted that attendance at open houses has been abysmal since this community vigilante started removing signs and threatening those who post them with legal action. This affects every single member of our community, as it will no doubt have a negative impact on the value of our homes.

I urge you to take immediate action to redress this situation, and create legal safe haven for those who wish to post innocuous signs in the common areas of Cameron Station. The local vigilante, also a prominent government enforcement attorney, may lack common sense, but he does not lack intelligence, and he is draining the resources of our community through his anti-sign campaign, including through multiple emails per day to the local board registering complaints about signs. Without formal, legal redress, there does not seem to be any amicable resolution in sight.

I have attached a picture of a sign that this confused, albeit clearly motivated individual left on a realtor sign advertising an upcoming open house for a home that had just gone on the market.

Request Description: Although signs in the right of way were not permitted before the recent passage of the sign
ordinance there was very little/no enforcement. The recent changes have created a major issue in Cameron
Station. Our real estate open house traffic and sales have dropped to close to zero. The homes currently under
contract were on the market in early March. We currently have 17 houses on the market with an additional 20
expected to hit in May. If the current conditions hold our values will fall as people drop prices to compensate for
lack of traffic.

In addition, we are no longer able to advertise community events.

Unlike most parts of the city we have very little private space. And unlike most parts of the city we have one person; Greg Hillson, who is filing complaints daily with City Staff and the HOA in Cameron Station. The HOA passed a resolution last night allowing signage on common area space; however most common area space is not visible from a car or Cameron Station Blvd. In the past, realtors have relied on directional signs to alert people to open houses. Use GPS from an ad; but, many of our streets do not show up on some versions of GPS because they are private streets. We need immediate help from you to resolve this issue.

In the next phase of the sign ordinance there is a directive to not allow any A frame signs. Our condo buildings are facing city streets and the only place to advertise that there is an open house in those buildings is by a small A frame on the sidewalk. You can be certain that if this passes Mr. Hillson will begin complaining on June 1.

I never realized that one rule and one vigilante could totally tear a community apart but this is what is happening. 50 people showed up at the HOA board meeting last night to complain and ask for help. Alex Dambach was kind enough to try to give people answers but that was not enough. We need action immediately. Is there a way for Cameron Station to lease the median space on Cameron Station Blvd from the City? We already maintain all of the City property in our neighborhood.

Any solutions are appreciated.

As a 13 year homeowner and an active realtor in the neighborhood (selling 20+ homes a year in the neighborhood) I have gotten extremely concerned that lack of signage will have an adverse affect on the sale of homes and potentially harm values in the long run. Cameron Station is a unique neighborhood as you are aware. On any given Sunday there are 5-15 open houses. The norm has been home seekers will come on a Sunday and go from one open to the next. Generally they didn't intend to visit multiple homes, but once they arrive and are able to follow the directionals, many end up visiting multiple homes when they were just attending one. This allows for a greater opportunity and visibility for other homes in the neighborhood to garner traffic and hopefully secure a sale. Without signage, some less visible homes will get passed over and may miss out on a potential sale.

It seems that one particular individual (Greg Hillson) has an extremely strong view that isn't consistent with the greater community in regards to signage. I do also understand there are current rules in place that doesn't allow for signage on right of ways. That said, the short period of time when signs are up on a Sunday 12-5pm and the fact that the speed limit is 25 mph and that Cameron Station Blvd isn't a highway or throughway of sort, I could only assume that some directional signage shouldn't have an effect on drivers visibility or ability to safely drive the road.


