

3 4 5 6 7 8 9	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by adopting and incorporating therein the amendment approved by city council on June 16, 2016 to the Potomac Yard/Potomac Greens Small Area Plan chapter of such master plan as Master Plan Amendment No. 2016-0001 and no other amendments, and to repeal all provisions of the said master plan as may be inconsistent with such amendment.
10 11	WHEREAS, the City Council of the City of Alexandria finds and determines that:

In Master Plan Amendment No. 2016-0001 the Planning Commission, having found that the public necessity, convenience, general welfare and good zoning practice so require, recommended approval to the City Council on June 7, 2016 of an amendment to the Potomac Yard/Potomac Greens Chapter of the Master Plan of the City of Alexandria to amend the Land Use Map (Map 18) to amend the land use designation for the Metrorail Station from CDD #10 to Utility, which recommendation was approved by the City Council at public hearing on June 16, 2016;

3	record the foregoing master plan amendment as part of the Master Plan of the City of Alexandria, Virginia.
